AMENDMENTS TO SENATE BILL 228 (First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 2, strike "**Dementia Care Coordinator and**"; in line 4, strike "establishing" and substitute "<u>requiring</u>"; in the same line, strike "position of Dementia Care Coordinator in the"; and in line 17, strike "Coordinator and".

AMENDMENT NO. 2

On page 2, in line 5, strike "COORDINATOR AND"; in line 7, strike "THERE IS A **DEMENTIA CARE COORDINATOR IN THE**" and substitute "<u>THE</u>"; strike beginning with the period in line 7 down through "COORDINATOR" in line 8; in line 9, strike "(C)" and substitute "<u>(B)</u>"; in line 11, after "SUBTITLE;" insert "<u>AND</u>"; strike beginning with the semicolon in line 13 down through "WEBSITE" in line 20; in line 21, strike "(C)" and substitute "<u>(B)</u>"; in the same line, strike "**DEMENTIA CARE COORDINATOR AND** THE"; and after line 27, insert:

"(C) (1) ON OR BEFORE OCTOBER 1, 2024, AND EACH OCTOBER 1 THEREAFTER, THE DEPARTMENT SHALL SUBMIT A REPORT TO THE GOVERNOR AND, IN ACCORDANCE WITH § 2–1257 OF THE STATE GOVERNMENT ARTICLE, THE PRESIDENT OF THE SENATE, THE SPEAKER OF THE HOUSE, THE SENATE FINANCE COMMITTEE, AND THE HOUSE HEALTH AND GOVERNMENT OPERATIONS COMMITTEE ON THE SERVICES PROVIDED UNDER THIS SUBTITLE.

(2) <u>The report required under this subsection shall</u> <u>include:</u>

(I) THE NUMBER OF DIRECT CONTACTS EACH DEMENTIA

On page 3, in lines 5 and 6, strike "WITH DEMENTIA" and substitute "<u>CONCERNED WITH THEIR COGNITION</u>"; in lines 7 and 8, strike "WITH DEMENTIA IN" and substitute "<u>WHO DEMONSTRATE SYMPTOMS OF DEMENTIA THAT</u> <u>INTERFERE WITH ACTIVITIES OF DAILY LIVING,</u>"; in line 8, after "EXERCISE" insert a comma; strike beginning with "WITH" in line 9 down through "GROUPS" in line 11 and substitute "<u>WHO DEMONSTRATE SYMPTOMS OF DEMENTIA THAT INTERFERE</u> <u>WITH ACTIVITIES OF DAILY LIVING</u>"; strike beginning with "CONSIDERING" in line 12 down through "(5)" in line 15; in line 18, after "CHANGES" insert "<u>THAT MAY BE</u>"; in lines 19 and 23, strike "(6)" and "(7)", respectively, and substitute "<u>TO FACILITATE</u>"; and in lines 21 and 22, in each instance, strike "WITH DEMENTIA" and substitute "<u>WHO</u> SB0228/733922/01 Amendments to SB 228 Page 3 of 3
