Bill: House Bill 283 – Maryland Medical Assistance Program – Gender–Affirming

Treatment (Trans Health Equity Act)

Dear Chair Pena-Melnyk, Vice Chair Kelly, and Members of the Committee:

The Maryland Psychological Association (MPA), which represents over 1,000 doctoral-level psychologists from throughout the state, is writing in **SUPPORT** of House Bill 283 – the Maryland Medical Assistance Program to provide gender-affirming treatment in a

nondiscriminatory manner.

Supporting gender affirming care in a nondiscriminatory manner is, simply put, lifesaving. The attempted suicide rate for transgendered individuals is at an astounding 41% with higher rates for those who have been victims of discrimination. Individuals pursuing gender affirming care should be entitled to care that is assessed and treated according to nondiscriminatory criteria that are consistent with current clinical/medical standards and prohibiting the issuance of an adverse benefit determination related to gender-affirming treatment unless a certain experienced health care provider has reviewed and confirmed the appropriateness of the determination. For these reasons, the Maryland Psychological Association asks for a **FAVORABLE** report on House Bill 283.
