Our daughter was a student at Salisbury University beginning fall semester 2020 and left the university due to the school's ridiculous COVID mandates in December 2021. At Salisbury, every unvaccinated student had to show up twice a week for a scheduled COVID test. You could not change the test time or the day of the week for any reason. If you missed a scheduled test, you were locked out of your dormitory, the dining hall, all buildings, and your internet access was shut off. But only for the UNVACCINATED. So our out of state student living 3 hours from home, if she missed a test because of any reason at all (overslept, out of town, on break, at work, had a car accident, etc), would have no place to eat or sleep UNTIL THE FOLLOWING TEST DATE 4 DAYS LATER because she was late to a 10 second covid test. You could not get 'retested' if you missed your scheduled test. You were simply locked out of campus until your next scheduled testing date. The vaccinated could go and do whatever they wanted – even if symptomatic.

There was a 'glitch' in Salisbury's computer system on the first day of school and even though we followed all the 'rules' for enrollment and our daughter was cleared to move in on a Thursday and attend classes the following Monday (first day of school) , the school labeled her as "untested" (because her COVID tests started on Tuesday) and she was locked out of school for her first day of class. This included the dining area, her dormitory, and class. The school subsequently said, "oops sorry" – we made a mistake. However, now her professor knew she wasn't vaccinated and SU instructed their professors to treat the unvaccinated differently. HIPPA violation right there.

SU "PROMISED" they did not tell any faculty the vaccination status of any student, but instead they had students color coded in their university system which did, in fact, tell pertinent PRIVATE medical information to every faculty member. So if a student was 'green' in the class roster, they were cleared to come to campus (i.e. vaccinated). A student that was 'grey' in his roster had to pass a covid test every week until they were changed to 'green' (i.e. they were unvaccinated).

Our daughter was sent home following a positive COVID test on Tuesday, Sept 14, 2021. She had a BIO lab that met once a week on a Monday morning at 9am for 3 hours. She let the professor know about her test result and isolation because she would miss one class/lab until she was cleared to return to campus. She asked to zoom to discuss what she would be missing and how to continue to stay ahead until she was cleared to return to class. The professor completely ignored one scheduled zoom session (never attended), never answered her emails about rescheduling, but she finally spoke with him 3 days later. At that time, the professor told her he could not recommend a tutor because all his tutors are in person and since she is not on campus, that would not help her. He told her the university gave him the right to fail her outright for missing his class due to getting sick and not being vaccinated. When our daughter told this professor she had an exemption for getting the vaccine he said he didn't want to know any additional details about what type of exemption she had but if she had not told him that, he said he would have the authority **per instruction from Salisbury** to fail her in that class any time he felt like it.

Salisbury University encouraged parents to write in to their weekly "town hall" online meetings where they would address any questions, but any question/communication/discussion geared towards the policies in place directed at the unfair treatment of the unvaccinated was never addressed or answered.

Emails were never returned. Calls were never returned. Town hall questions were not allowed to be asked. Salisbury refused to recognize that the vaccinated got sick just as easily as the unvaccinated and that they could spread COVID around campus – AND to hold those persons to any accountability whatsoever. In their opinion, every person that got sick was unvaccinated and the resultant sickness was because there was an unvaccinated person walking around campus. Salisbury provided free covid tests for the vaccinated to test themselves any time they wanted – just show your student ID and vaccination status and here's your test. However, these tests were not free and available to the unvaccinated– only the vaccinated. Further, there was no follow up by campus health to have the results of a vaccinated person who took a covid test recorded anywhere. Only the unvaccinated test results were recorded. The university 'suggested' vaccinated students report their own positive test results if they tested and found a positive test result, but there was no mandatory requirement to do so if you were vaccinated. Conversely, unvaccinated students testing positive received a phone call 15 minutes later and told them they had 30 minutes to clear out of campus and leave school grounds. Your school access would be shut off in 30 minutes since you tested positive. As a result, vaccinated students ran around all fall after testing positive and not reporting the results BECAUSE SALISBURY'S PROFESSORS WOULD NOT ACCOMMODATE STUDENTS WHO WERE OUT SICK FOR ANY REASON. The sick and vaccinated did not want to tell campus health they were sick because the actions of the university. When someone DID test positive, the school's procedure was that they would be isolated for a ridiculous amount of time (14-21 days) and their grades would falter with no help from faculty because faculty was advised not to help the unvaccinated or allow any make up work. Positive VACCINATED infected students continued going to class and spread COVID BUT Salisbury blamed the unvaccinated for all cases of COVID on campus.

The nail in the coffin for our family was the school's handling of testing for Thanksgiving Break. My daughter was done with all classes before Thanksgiving on the Thursday BEFORE Thanksgiving, so 11/18. She could have come home on 11/18 for an extended break as she had no assignments, labs or classes scheduled until 11/29. 11 days home with family! I called Campus Health to inquire if there was anything she could do with her scheduled Tuesday COVID testing on 11/23, the Tuesday before Thanksgiving. Every unvaccinated student had to show up twice a week for a scheduled test. You could not change the test time or day of the week for any reason. If you missed a scheduled test, you were locked out of your dormitory, the dining hall, all buildings, and your internet access was shut off. But only for the UNVACCINATED. Campus Health said she could test the Monday classes resumed at 8:15 in the morning, but they could not guarantee her test results would be uploaded in time to make her class at 9:15 (that only met once a week)– so she stayed on campus 5 extra days just to stick a swab up her nose for 10 seconds on 11/23. This is ridiculous. We live in Pennsylvania – 3 hours away. Our only option was to come home, then turn around and drive 6 hours on one day just to prove to the school she was negative – EVEN THOUGH SHE HAD COVID 2 MONTHS AGO (natural immunity) and would not be on campus for another 6 days!! (her other regular testing day was Thursday, Thanksgiving day) Our daughter could not risk missing that Monday class because SU already screwed her the first day of class and locked her out of campus, even though she followed all testing rules. That professor told my daughter he didn't have to accommodate her when she was home sick with Covid and HE DID NOT. She got zeroes for every assignment and test scheduled during the time she was sent home to quarantine with no chance to make up the work. So no, this is not a class she could just 'blow off' Monday morning because she didn't get her test results back in time. Again – she did nothing wrong. She followed all the rules, and SU screwed her again. That professor DID fail her, by the way, and when she transferred to

her new school in Florida and re-took the same class she got a 97%. She is not stupid – she had a professor that had it in for her and failed her on purpose.

SU indicated it would provide free KN-95 masks to the vaccinated only. When I called and asked why they said that's not true, but when shown the information on their own website that specifically stated this they claimed it was a typo and they would change that and give masks to the unvaccinated too if needed.

Each of us has unique medical histories, risk factors, and beliefs and each of us should have the chance to make the best decision for ourselves as to what we inject into our bodies. Because both the vaccinated and unvaccinated can get and transmit Covid, vaccine mandates are not only unjustified, but also promote active discrimination. I would never send another child or friend to a Maryland university as long as the vaccine mandate continues. We have happily continued our daughter's education in Florida with no issue. In fact, they enjoyed receiving the \$100K we were willing to pay Salisbury before they became unreasonable and discriminatory.
