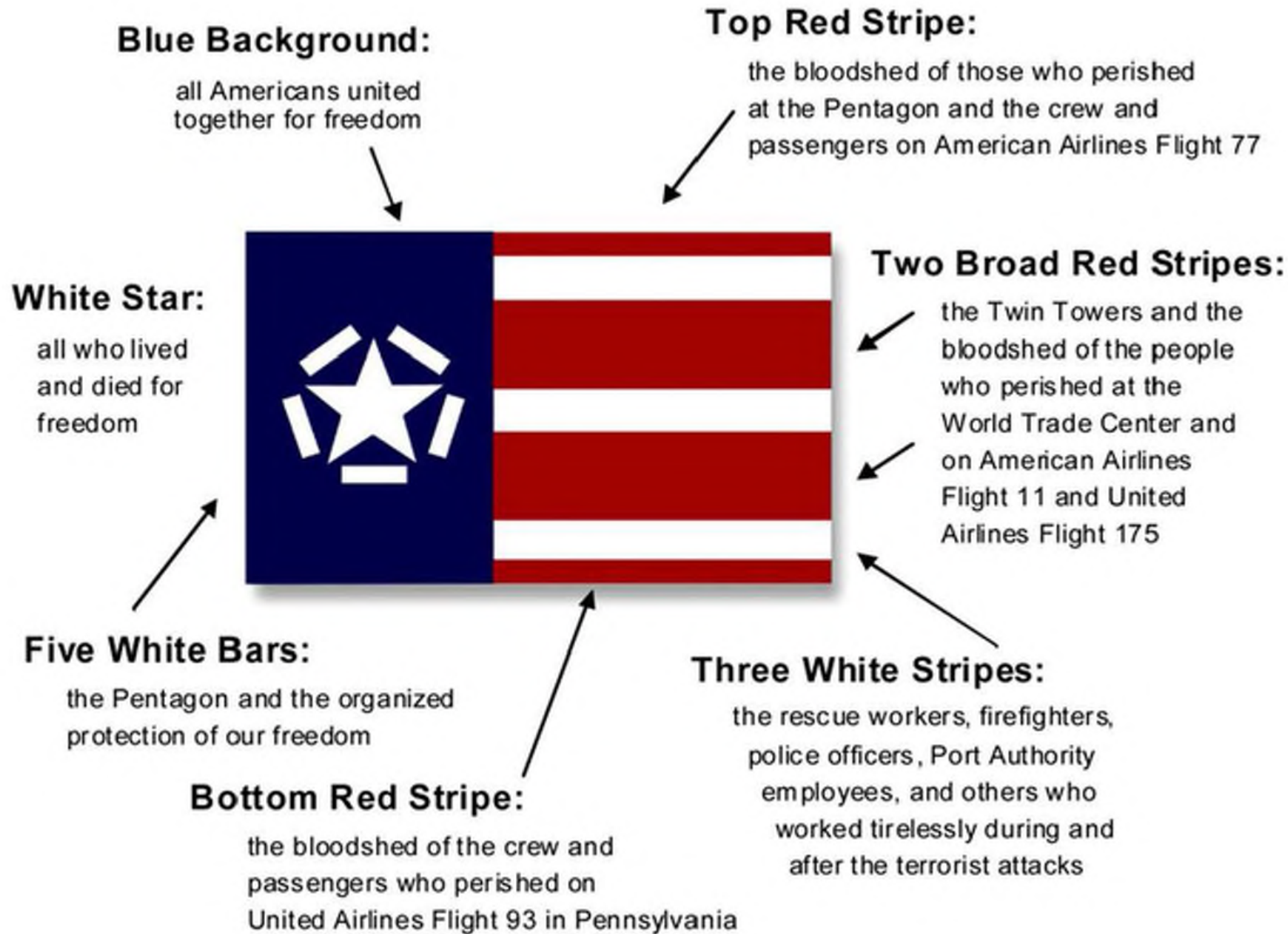


# MEANING OF THE FREEDOM FLAG

## **FREEDOM FLAG LEGISLATION – 2023 Case Support for Maryland**

1. 2,977 lives lost (including 70+ with ties to Maryland), a day we promised to “Never Forget.”
2. Incredible heroism by first responders 343 FDNY, 69 police/rescue, and the passengers/crew of United Flight 93.
3. Deadliest day on American soil since the Civil War (more lives lost than at Pearl Harbor).
4. Deadliest terrorist attack in world history.
5. International implications: citizens from over 90 nations perished on 9/11.
6. Attack on our freedoms and institutions ... painful reminder that "Freedom is not Free."
7. The death toll of first responders who have died of 9/11 related illness now exceeds the 9/11 death toll (3,000+ ... source: <https://theconversation.com/20-years-on-9-11-responders-are-still-sick-and-dying-166033> ).
8. Since 9/11, over 7,000 servicemen and women have paid the ultimate sacrifice protecting our freedoms around the world.
9. It's been over 21 years since the day that changed the course of American (and world) history.
10. Nearly 100 million Americans – including approximately 1.5 million Marylanders – have been born since 9/11 or were too young to remember the events (approaching 25% of our population).
11. Today's K-12 students and the majority of college-aged students were all born after 9/11.
12. Over 20 years later, teaching about 9/11 is only required in 14 states:

13. The Freedom Flag is our Nation's only codified flag/symbol of remembrance for 9/11:
  - Virginia (2018): *VAC §1-510*
  - Oklahoma (2022): *O.S. Title 25 §93.3*
  - Delaware (2022): *29 Del. Code §331*
14. The Freedom Flag is a demonstrated and enduring symbol of remembrance, flown/displayed in all 50 states, and proven educational tool for the next generation.

19. **Charles S. Falkenberg**, 45, of University Park – Travelling to Australia with wife and two children on American Flight 77
20. **Dana Falkenberg**, 3 of University Park – Travelling to Australia with parents and sister on American Flight 77
21. **Leslie Whittington Falkenberg**, 45, of University Park – Travelling to Australia with husband and two children on American Flight 77, to work briefly at the Australian National University
22. **Zoe Falkenberg**, 8 of University Park - Travelling to Australia with parents and sister on American Flight 77
23. **Jamie Lynn Fallon**, 23, of Towson – Storekeeper 3rd Class, US Navy stationed at the Pentagon
24. \* **Robert John Fangman**, 33, native of Baltimore – Flight attendant, filling in for a colleague on United 175, who made a one minute 15 second phone call at 8:52 a.m. (ET) to the United Airlines office in San Francisco reporting the hijacking, and that both pilots had been killed and another flight attendant had been stabbed before his call went dead.
25. **Amelia V. Fields**, 46, native of Princess Anne, MD – Civilian secretary for the US Army who would have celebrated her birthday that evening, was at work at the Pentagon
26. **Gerald Fisher**, 57 of Potomac – Consultant for Booz, Allen & Hamilton at the Pentagon that day to brief the Army's Deputy Chief of Staff for Personnel on an improved system for survivor benefits for military employees.
27. **Sandra N. Foster**, 41 of Clinton – Civilian employee of the Defense Intelligence Agency at the Pentagon
28. **Captain Lawrence D. Getzfred**, 57 of Silver Spring – assigned to the Naval Command Center at the Pentagon
29. **Cortez Ghee**, 54, of Reisterstown – Civilian employee, Budget Analyst for the US Army at the Pentagon
30. **Colonel Ronald F. Golinski**, US Army (Retired), 60, of Columbia – Civilian employee in the US Army's Office of the Deputy Chief of Staff for Personnel at the Pentagon
31. **Edwin Graf III**, 48, with family ties in the Baltimore area – Vice President, Cantor Fitzgerald, WTC North Tower
32. **Ian J. Gray**, 55, originally from England who later resided in the Baltimore/Columbia area was a passenger on American Flight 77
33. **Michele Heidenberger**, 52 of Chevy Chase – Senior Flight Attendant on American Flight 77
34. **Sheila Hein**, 51 of University Park – Civilian Army management analyst at the Pentagon

38. **Brenda K. Kegler**, 49, of Capitol Heights – Civilian employee, Budget Analyst for the US Army at the Pentagon
39. **Vincent A Laieta**, 31, of Ocean City – Vice President of Operations, Aon Corporation, Tower 2, WTC
40. **Paul Laszczynski**, 49, native of Baltimore –Police Officer, Port Authority of New York killed while attempting rescue of trapped victim in the WTC North Tower somewhere above the 20<sup>th</sup> floor”. He had received a commendation for his prior rescue carrying a disabled individual down 70 flights of stairs during the WTC attack in 1993.
