Written Testimony for HB 699: Covid-19 Vaccination By Choice, Vote "Favorable with Amendments"

Dear Health and Government Operations Committee Chair, Vice Chair and all other esteemed Committee Members.

I would like to implore each and every one of you to vote "Favorable with Amendments" on this bill please.

This legislation is an essential step toward freedom to return to pre-Covid life and to put an end to potential harm and irreparable damages done by the Covid-19 vaccine,

I would like all of you to consider these points:

- The Covid vaccines did not stop spread of the virus or transmission of the virus, as promised, and there was never any reason for a mandate. Receiving the vaccine has nothing to do with the community.
- Natural infection, which has been the scientific standard, was completely ignored. It is now an established fact. Those who contract the virus have just as much immunity, if not more, than those people who have received the vaccines but not contracted the virus. And how many people do you all know that received the vaccines and STILL contracted the virus anyway? Most of the people that I know that have received the vaccines have actually gotten Covid, some of those people having had Covid 2-3 times.
- The vaccine makers were NOT liable for any harm, injuries or deaths from the vaccine or any of the vaccine's adverse side effects. How can you mandate a brand new product until there is long-term safety and efficacy data?
- College students were never a high risk group for adverse outcomes of Covid infection. The only thing college students are known for in regard to the Covid vaccine is that the males are in that target range of age 15-30 for contracting either myocarditis or pericarditis, a heart condition that may or may not be permanent.

While some colleges have recently rolled back their Covid passport requirement, it is crucial to include the student body of all USM schools in this legislation.
