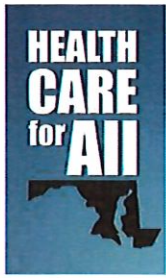




**TESTIMONY IN SUPPORT OF HOUSE BILL 279**

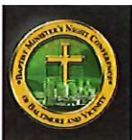
