#### WRITTEN TESTIMONY

### Senate Bill 84 – Places of Public Accommodation and Public Buildings - Gender-Inclusive Signage

### Judicial Proceedings Committee - January 31, 2023 SUPPORT

**Background:** SB84 would require that all signage for single-occupancy restrooms in places of public accommodation use gender inclusive symbols that do not use pictorial representations and contain only descriptive language, such as "restroom" or "bathroom."

**Written Comments**: Single occupancy restrooms are helpful and convenient for those with special needs; elders who need assistance; or individuals who simply might otherwise have to wait in line because bathrooms are gendered.

SB84 would not require restrooms to be altered in any way, but rather simply lays out how signage must look so that everyone can feel comfortable when using a single-occupancy restroom.

The Baltimore Jewish Council represents The Associated Jewish Community Federation of Baltimore and all its agencies, including Jewish Community Services (JCS), Comprehensive Housing Assistance Inc. (CHAI), and CHANA. Each of these organizations provide services to Maryland's rapidly growing aging populations. Likely one of the places a caregiver is needed most, these individuals can often feel excluded when accompanying those who they are assisting to a restroom. As we witness the aging demographic grow, it is imperative that we enact policies that support *all* Marylanders.

Five states have already taken the step to make single-occupancy bathrooms more inclusive, as well as Baltimore City, Howard, and Montgomery Counties in Maryland. With this in mind, the Baltimore Jewish Council urges a favorable report of SB84.

## SB 84 Testimony – Open to All Act January 31, 2023 Senate Judicial Proceedings Committee

Good afternoon Chair Smith, Vice Chair Waldstreicher, and members of the Committee.

My name is Allan Richardson and I am here today in support of SB 84, The Open to All Act. I was fortunate to testify before this Committee last year and am honored to be back before you.

I have resided in Maryland for over 70 years, and during that time my wife, Sally, and I greatly enjoyed going out to dinner and attending both folk and classical music performances in venues throughout Maryland. Unfortunately, in recent years Sally battled both dementia and severe loss of mobility. In spite of this she continued to find great comfort in these outings. They gave us the chance to retain an important part of our former life. But there were problems.

At first, it was difficult for Sally, who had become easily confused, to manage trips into the ladies room alone. I became uncomfortable allowing her to enter restrooms by herself because she would forget where she was. Then later, when she became wheelchair bound, she was completely unable to manage without assistance. Although there were sometimes restrooms accessible to those with disabilities, she could not use these alone. Often I had to decide whether to bring Sally into the men's restroom or to hire our daytime female caretaker for the evening to assist her. This added a layer of stress (and expense) to our evening that my wife and I did not need.

These are not easy things to discuss. But The Open to All Act would alleviate many of these problems by providing free access to all for single use bathrooms. That would help us to manage by ourselves many of the problems we experienced. We all want to be out enjoying events in Maryland and it goes without saying that none of us want to worry about how to access a restroom, regardless of our sex or state of disability.

In conclusion, I thank you for taking the time to consider this bill and ask for a favorable report.

My name is Dan Simons; I'm a co-owner of seven restaurants, a distillery, and a catering company. One of my restaurants, called Founding Farmers, is located in Montgomery County, Maryland. My other restaurants are in DC, Virginia, and Pennsylvania.

Thank you for the opportunity to provide written testimony to Senate Bill 84 (<u>SB0084</u>). I am grateful to Senator Cheryl Kagan for filing this important civil rights bill. I am writing to offer my support to this bill.

I am a businessperson and a restaurateur. I have more than 30 years of experience in the restaurant industry, and I have been an owner for the past 17 years. While I understand the impact unnecessary regulations can have on a business, I also believe we as business owners, and a society, can do a much better job providing adequate, safe, and fair accommodations for every guest and client that walks through our doors. It is also baseless to oppose all regulations – I can give testimony as a business owner that there are plenty of regulations that are ineffective and burdensome, and plenty that are sensible. Any regulation should be judged on the merits of its intent and the outcomes it creates.

In our restaurants, we have worked to ensure that every human is welcome to use whatever bathroom they identify with. We have signage on our restaurant doors that says: "Women: In Mind, Body, or Spirit." Our bathrooms have multiple stalls in them. We also have a one stall bathroom at our Founding Farmers DC location with a sign that says "All of Us." We have received only positive feedback over the years... in person, in writing, and often over social media channels. In the case of this proposed legislation, Senator Kagan is suggesting that single bathrooms – like airplane bathrooms – should be able to accommodate EVERYONE, regardless of how they identify. This is a no-brainer. This is the simplest of simple first steps. There is no logical reason to say this kind of accessibility would cause harm or have any downside. I see only upside with being more open, and more inviting – I know a little something about how hospitality, kindness, and understanding are the currency. So whether you want to prioritize the heart or the dollars, this bill is easy to support.

As business owners, we can do better to help foster a more tolerant and hospitable world. *We have to do better.*

### TESTIMONY OF ED ZAKRESKI, MANAGING DIRECTOR IN SUPPORT OF SB 84/HB 40 "OPEN TO ALL ACT"

In 2019, Round House reopened our renovated theatre. When we designed the signage for the renovation, we made the values-based decision to label our single-occupancy restroom as a Family Restroom, with a further explanation that our restrooms are available to everyone, regardless of their gender expression or identity.

Since that time, we have had multiple patrons express their gratitude for this signage and availability and have not had a single complaint.

Just about every business covered by this bill is in a business dependent on customers. That means that our revenues – our success – is dependent on creating an environment that is welcoming, safe, and accepting for our patrons. The more people we make happy, the better it is for our bottom line.

And there are so many people who hesitate when facing gendered signage on single stall restrooms: parents with young children, people who identify as trans or non-binary, caregivers of a different gender than the person they're caring for. This is about the easiest, lest expensive action that can be taken to provide a more welcoming environment to a large number of people. It's not just the right thing to do ethically, it's simply good business. All for the cost of a couple signs.

Moreover, as the proud father of a transgender son – whose statement is included below – I can personally attest to the anxiety, and sometimes fear, that many trans people encounter when forced to use gendered restrooms. There are websites to help trans people navigate their personal safety when travelling to different states and identifying business that are safe locations. Passing this bill will provide much reassurance to a community that faces significant discrimination and marginalization.

I strongly encourage you to vote in support of the Open To All Act.

### Statement from my son, Cameron Zakreski:

"Since coming out as trans in 2019, the first time I have truly felt safe walking into a men's room without the protection of my father or brother was when I saw a sign which actively welcomed me to use the correct bathroom for me. Because not only did I know I was allowed in that restroom, but everyone else had also seen the sign saying I was allowed in this bathroom. There's a sense of security that comes with being reassured that you'll be safe and protected if anything happens. I still avoid public restrooms when possible, but in venues where there's a sign welcoming trans individuals to please use the bathroom they want, that fear of public restrooms goes away because I know that someone there has my back if something happens. That's why inclusive signage is important. I shouldn't have to fear using the restroom and neither should anyone else."

### SB 84 Testimony – Open to All Act January 31<sup>st</sup>, 2023 Senate Judiciary Proceedings Committee

Good afternoon Chair Smith, Vice Chair Waldstreicher, Esteemed Colleagues. Thank you for the opportunity to present today on my legislation – the Open to All Act.

A single occupancy bathroom is one that is fully enclosed, contains only one toilet, and has a door that locks. We've likely all used one - whether it's on an airplane, in our committee rooms, or in our own homes. Many single occupancy bathrooms are already unisex or gender neutral.

All people deserve privacy and peace of mind when using a public bathroom. Gender neutral bathrooms provide a safe and welcoming space for all individuals in our community including those with disabilities and caregivers, nursing mothers, seniors, and parents of young children. Individual bathrooms that are open to all allow caregivers easy access to those they support, including senior citizens and individuals with disabilities, protect all of our community members from harassment, and allow parents the freedom to nurse and care for the bathroom needs of their small children.

Genders-specific bathrooms create unnecessary challenges:

- Senior citizens, Alzheimer patients and the disabled often have personal attendants of a different gender and need bathrooms that are accessible and accommodating.
- Many child care programs take field trips to enhance the educational experience of their young learners. Bathroom usage is difficult as most programs have mixed-gender groups of children, but nearly all providers are female. Young boys are reluctant and apprehensive about using the "Women's Room" but to ensure proper supervision are forced to do so.
- Fathers should not have to change diapers on the floor and most likely would not be comfortable using a restroom labeled as "women."
- Parents and guardians with children of a different gender often encounter scrutiny when accessing gender-specific restrooms.

In Maryland, communities across the state have already adopted this change. Salisbury and Howard County – where the council voted unanimously in favor – recently passed laws that remove gender identification signs from single-occupancy bathrooms. In 2019, Baltimore City became the first jurisdiction in the state to require this change.

California, Illinois, Nevada, New Jersey, New York, Rhode Island, and Vermont, along with cities like Washington, D.C., Philadelphia, Austin, New York, Portland, and Seattle, have all passed laws requiring single occupancy restrooms to be open to all – regardless of gender.

Additionally, the International Plumbing Code added a requirement for gender-neutral signage on all single-occupancy restrooms to be "identified for use by either sex" back in 2018.

SB 84 would require all public single-occupancy restrooms to have signs that don't reference gender at all. The signs would simply have the word restroom or bathroom and a picture of a toilet. New signs are available for purchase online for as little as \$15.

As you can see from the testimony submitted and the witnesses with us today, this bill is supported by businesses, the disability community, and the senior community across Maryland. Since 2020, we've worked closely with the Maryland Retailers Association as well as the Restaurant Association of Maryland to ensure this legislation was satisfactory. Neither organization has any opposition to the bill.

With this simple change, we can make our community open to all Maryland. I would ask for a favorable report on SB 84.

### **Testimony of the Human Trafficking Prevention Project**

Senate Bill 84 would require single-occupancy restrooms across the state to be designated with gender-neutral signage. The Human Trafficking Prevention Project at the University of Baltimore School of Law supports this bill because it will benefit nonbinary, transgender, and gender-nonconforming Marylanders, for whom using the restroom can be a particularly stressful experience. This small change will greatly reduce the stigma these individuals face, which, in turn, reduces their risk of being trafficked.

Efforts at raising public awareness about the crime of human trafficking commonly ignores the impact that gender identity and gender presentation has on a person's vulnerability to trafficking. The reality is that nonbinary, transgender, and gender non-conforming persons are disproportionately vulnerable to being trafficked because of the discrimination and isolation that they so often face, which commonly translates into the hallmarks of heightened trafficking risk including sexual assault, financial instability, homelessness, and drug addiction. One of the most common forms of discrimination that nonbinary, transgender, and gender non-conforming people face is that which comes with being forced to use a restroom that carrying a gender marker that does not match the person's lived gender experience, or, alternatively, attempting to use one that does.

Many nonbinary, transgender, and gender-nonconforming people have limited access to bathrooms because of the harassment, violence, and threat of arrest they face in both men's and women's bathrooms. Experiences like these typically drive affected individuals further into isolation, which is why so many nonbinary, transgender, and gender non-conforming people exist on the margins of society where they face a far greater risk of exploitation. The availability of gender-neutral single-stall bathrooms ought to be commonplace here in Maryland, because being able to use the bathroom without the threat of violence or harassment is a human right, not a privilege.

Since 2019, Baltimore City has had a similar ordinance, which has required single-occupancy restrooms to be labeled with gender neutral signage. After more than three years of implementation, there have been no unforeseen consequences, no rush of frivolous lawsuits against places of public accommodation, and no wave of sex-related crimes. This has also been the case in the multiple other jurisdictions that have implemented similar laws, including the District of Columbia, New York City, or Philadelphia, all of which have been in place since 2016. Indeed, DC's Municipal Rule 4-802 has been in place since 2006, without issue.

In recent years, Maryland has begun to show its support for *preventing* human trafficking by addressing the societal challenges that make Marylanders more vulnerable to being trafficked. SB 84 would further this goal by reducing the stigma that nonbinary, transgender, and gender non-conforming persons face every time they have to use a public restroom, which would, in turn, affirm the humanity of these individuals, making them less vulnerable to the harms that so commonly precede a trafficking experience. Additionally, in a time of unprecedented and unsubstantiated attacks on the rights of transgender people, it is crucial that Maryland stand up and say conclusively that hate has no place in our state. For these reasons, the Human Trafficking Prevention Project supports Senate Bill 84, and respectfully urges a favorable report.

We are writing in **SUPPORT of SB0084** - Inclusive Public Restrooms.

This bill would require that single-occupancy public restrooms be marked with inclusive signage, which would help to provide a safe and accessible public restroom experience throughout Maryland. We believe in creating welcoming and affirming spaces for everyone, including in public accommodations for transgender and gender-expansive individuals.

Sex-segregated bathrooms can be dangerous places for people who identify outside of traditional gender roles — including those who do not even identify as LGBTQ+. Additionally, gender-inclusive signage will create <u>both a pictorial representation and descriptive language</u> (such as "restroom", "bathroom", or "toilet"), which will be helpful to many individuals with disabilities.

The Mayor and Council of Rockville are thankful to Chairman Feldman, Vice Chair Senator Kagan, Chair Smith, Vice Chair Waldstreicher, members of the Senate Education, Energy, and the Environment Committee, and members of the Senate Judicial Proceedings Committee for the opportunity to share the City's comments on SB 84. We are thankful to Senator Kagan for sponsoring this important legislation.

The Mayor and Council strongly support SB 84 and its goal to make the use of single-occupancy public restrooms in public buildings and places of public accommodation more inclusive by requiring gender-neutral signage. The City of Rockville has a long history of converting single-use bathrooms to be all gender. The legislation also aligns with the Mayor and Council's vision to provide a welcoming and socially-equitable community for all. SB 84 would also benefit residents by facilitating access for parents and family members caring for a child that is a different gender.

Rockville's support and advocacy for its tapestry of race, religion, creed, ethnicity, physical and mental abilities, sexual orientation, and culture will always be a central pillar of the City's commitment to its community. We support SB 0084 and believe that the labeling of public restrooms with gender-inclusive signing simply reflects what is currently required by the 2021 International Plumbing code.

The International Code Council updates building codes every three years and the International Plumbing Code (IPC) is one component of the building codes. We believe the relevant section related to this bill is:

Section 403.1.2 Single-user toilet facility

The 2018 IPC states ... "shall be identified for use by either sex"

The 2021 IPC states ... "Shall be identified as being available for use by all persons regardless of their sex"

While we cannot speak to the enforcement of this requirement, we believe the language of SB 0084 to be consistent with the current building codes and consistent with the universal respect all persons deserve.

AIA Maryland cares deeply about the quality of Maryland's built environment and we encourage steps to maintain the quality of health, safety and welfare of our residents, visitors and buildings throughout the state. We all use public, single-occupancy bathrooms on a regular basis-- in planes, hospitals, restaurants, and more. Making these restrooms gender-specific restricts access and can create discomfort.

Women face longer wait times for bathrooms than men (an average of 6+ minutes), who are delayed by approximately just 11 seconds. Labeling restrooms with signage for any gender can cut wait times for women to less than 1.5 minutes.

Trans- and non-binary people can be at risk when using gender-specific facilities. In a national survey, 60% of transgender people avoid public restrooms due to apprehension about being confronted. This is a real fear-- 12% have been verbally harassed; 9% were denied access; 1% were physically attacked; and 1% were sexually assaulted.

Gender-Neutral bathrooms are family-friendly, enabling parents to assist their children. They are also more accessible and comfortable for people with disabilities.

SB84 simply requires a gender-neutral sign, which can be purchased for less than \$20.

The penalty is modest for non-compliance:

- The first offense is a warning;
- After 30 days, if the facility still does not comply, a \$100 fine may be assessed; and
- If another 30 days passes without this change, the organization can be fined \$250 for the third and subsequent violation.

<u>SB84</u> requires a simple, inexpensive fix to make **ALL** feel welcome!

### **Distinguished Senators**

Members of the Senate. My name is Vince Culotta, managing partner of Cured / 18<sup>th</sup> & 21<sup>st</sup>, a restaurant in Columbia, Maryland's Merriweather district. I have been a restaurant operator for two decades, and fortunate enough to own my own business for nearly five years.

During my time in the hospitality industry, one steadfast fact has emerged: businesses that are welcoming to their guests and customers, often, are 80% of the way to success. We work very hard to be welcoming, in fact, one of our core values is that "we treat everyone like family." This is not simply lip service at my company, as I spend nearly two hours during orientation chatting with all new employees about the "why" behind our business.

When we were opening our restaurant nearly five years ago one item that came up was what type of bathrooms we were going to have for our guests. We could have opted for a more traditional set up with one large room for women, a second one for men, and a third as a family restroom. Due to space constraints, we opted for what I now believe is the best solution for everyone: single occupancy restrooms that are devoid of gender specificity. While I realize this option is not for everyone, I honestly believe that if we want to be as welcoming as we can, a solution like this is one of the simplest choices out there.

Single occupancy, gender neutral restrooms not only eliminate confusion for our guests, they help minimize waits during times of high usage, and they foster an environment where everyone feels welcome. We have also seen great support from our elderly and disabled guests for our single occupancy restrooms as well as parents and caregivers of different gendered children.

The response by our community has been overwhelmingly positive. During our almost five years of operation, I have had numerous individuals laud our choice of single occupancy restrooms, while not one person has expressed a negative opinion. I, for one, am delighted that we can offer something so simple that helps everyone feel welcome in our place of business.

I know that the committee is concerned for any undue stress this may cause for a business. For business that currently employ single occupancy restrooms, with the exception of replacing a few signs, I can think of no undue burden this would place on anyone. I hope the committee will strongly consider moving this bill back to the House floor for a vote.

My name is Zeke Cohen, proud sponsor of Baltimore City Bill 19-0385, which requires single-user restrooms in our city to be gender inclusive. Our office fully supports SB84 "Gender Neutral Bathrooms" bill, requiring gender neutral signage for single-occupancy, public restrooms throughout the state of Maryland.

Senator Kagan's bill centers inclusivity and aims to ensure access to public accommodation for all residents, which should be a top priority of the State of Maryland. The passing of this bill should normalize access to publicly-accessible, single-occupancy restroom across the state of Maryland—regardless of gender identity.

Indeed, since Baltimore City passed Bill 19-0385 in July 2019, there has been a smooth transition to implementation. The overwhelming number of businesses and residents have welcomed the inclusive move, without significant concern or pushback.

Bills like SB84 make restrooms available to communities as a whole. Gender-inclusive, single occupancy restrooms benefit many people, including women (who often face long waits at the restroom), nursing mothers, parents with children of a different gender, and people who depend on caretakers or assistants.

Discrimination on the basis of gender identity has been illegal in Maryland since 2014. The Fairness of All Marylanders Act (FAMA) prohibits gender-based discrimination in public accommodations. While FAMA includes single-occupancy restrooms, that legislation did not require changes to restroom signage. Senator Kagan's bill will bring single-occupancy restroom signage in line with anti-discrimination measures that are already in place in the State.

For these reasons, I respectfully request the support of Senate Bill 84.

Dear Chairman Smith and Members of the Judicial Proceedings Committee, Chairman Feldman and the Members of the Education, Environment and Energy Committee, Chairman Peña-Melnyk and the Health and Government Operations Committee, and Chairman Wilson and the Economic Matters Committee.

I am in support of the equity goals of HB40/SB84 and, want to propose an amendment to help the bill more easily comply with current building/plumbing codes.

My concern is that local code officials may begin to interpret a 'requirement' for additional restroom facilities because the fixture counts required in the adopted 2018 International Plumbing Code would no longer be met as fixtures are switched from gender-defined to gender neutral facilities. The state adopted model building codes [IBC, IPC, etc.] have very specific requirements for a minimum number of gender-defined and separated facilities, and if facilities are no longer specifically designated, some code officials may interpret a need for more facilities to meet the minimum requirements. Essentially, for the purpose of building codes, it would be helpful to all building owners if gender inclusive restrooms can count for the minimum counts of either/both genders, to avoid triggering a perceived requirement for additional unnecessary restroom facilities. This would override specific provisions of the adopted International Plumbing Code, namely gender based fixture counts in "403.1 Minimum Number of Fixtures", and specific requirements in section "403.2 Separate Facilities" for separate facilities.

or other public official shall require additional gendered/gender-inclusive restroom facilities to be built, to meet Minimum Fixture Calculations or for any other reason, due to the redesignation of facilities; further all new or existing restroom fixtures and facilities marked with gender-inclusive signage shall be allowed to be allocated toward the Minimum Number of Required Plumbing Fixtures for either the male or female genders under the adopted International Plumbing Code, as determined by the needs of the building owner.

The language within the current adopted building codes is unfortunately vague and unclear regarding the assignment of gender-neutral restrooms, necessitating the request for this amendment. You may find that you further need to override the requirements for Separate Facilities under section 403.2 of the International Plumbing Code, in order to not require additional facilities to meet required Plumbing Code minimums. Again, I am in support of the intent behind this bill, and with the amendment above, or something similar, would strongly support its passage in Maryland. However, in its current form it could be detrimental to all commercial and civic building owners, increasing the risk for the imposition of unnecessary costs to all non-residential construction.

#### Senate Bill 0084 - Places of Public Accommodation and Public Buildings – Gender-Inclusive Signage Support with Amendment

Dear Chairpersons Smith, Vice Chair Waldsteicher and Members of the Senate Judicial Proceedings Committee:

The Maryland Commission on Civil Rights ("MCCR"; "The Commission") is the State agency responsible for the enforcement of laws prohibiting discrimination in employment, housing, public accommodations, health services and state contracts based upon race, color, religion, sex, age, national origin, marital status, familial status, sexual orientation, gender identity, genetic information, and physical and mental disability.

Senate Bill 84 requires that single-occupancy bathrooms have signage posted that does not use pictorial representation, and only uses descriptive language, such as the words "restroom" or "bathroom". Counties and municipalities are charged with enforcing the bill's provisions for places of public accommodation within their respective jurisdictions, and the bill authorizes the counties and municipalities to set and collect fines (with caps) to cover the costs associated with enforcing this bill.

While the Maryland Commission on Civil Rights is supportive of initiatives to enhance inclusivity across the State, MCCR is again concerned about the bill's mandate on counties and municipalities being placed in Title 20 of the State Government Article ("SGA Title 20"). Currently, MCCR has sole authority to enforce the State's anti-discrimination laws enshrined in SGA Title 20. There exists no qualifier within SGA Title 20 granting units of local government the authority to enforce any provision of SGA Title 20. By inserting a provision to be enforced by local governments within SGA Title 20, MCCR is concerned that the provision may be overlooked by those entities charged with enforcement.

Therefore, MCCR respectfully suggests that this bill's provisions stated at page 4, lines 29-30; page 5, lines 1-30 and page 6, lines 1-10 would be better placed in the **Local Government Article**.

This would ensure that the bill's provisions are clearly accessible to counties and municipalities in a section of the Maryland Code that is reserved for mandates placed on their respective units of government.

For these reasons, the Maryland Commission on Civil Rights supports a favorable vote of SB 84 with amendments. Thank you for your time and consideration of the information contained in this letter. The Maryland Commission on Civil Rights looks forward to the continued opportunity to work with you to improve and promote civil rights in Maryland.


