Reason for Position:

The Maryland Municipal League supports Senate Bill 409, which seeks to add the municipal perspective to the police disciplinary framework. Specifically, the bill authorizes municipal governments to establish a police accountability board (PAB) and administrative charging committee (ACC) to handle complaints against officers of that municipality.

As mandated by the law that went into effect July 1, 2022, each county is setting up their PAB and ACC to handle complaints against officers that operate in their county, including municipal officers. However, the roll out of the PABs and ACCs has been rocky and in many instances municipal input has either been ignored or not solicited at all. This is a problem for all 157 municipalities, and especially for the 89 with police departments.

Specifically, here are the problems this bill addresses:

- 1) The potential for case backlog is real, with only one PAB and ACC in each county to handle complaints against all officers. Prince George's County has 25 municipal police departments in addition to the county police department.
- 2) Municipal values and voices are lost in this process and are being ignored by the counties. The lack of meaningful municipal input is tangibly impacting the makeup of the PABs and ACCs.
- 3) Municipal police departments operate independently from their county counterparts, yet the existing framework mandates county oversight over this municipal service in an awkward arrangement rarely seen in the State. In at least five instances across the State, a municipal police agency has more officers than their county department, yet it is the county that has full control over the PAB/ACC process.

4) Not all municipalities will exercise this new authority, but those that do will work under the same safeguards already in place for the counties.

The authority granted to municipalities in this bill will allow for municipal governments, should they choose to exercise this authority, the ability to create a PAB and ACC in a fashion that reflects their community and its values, while also spreading the case load among more entities, thereby shortening response times. There are significant costs associated with establishing and administering these entities and municipal governments must weigh those costs with the benefits to determine if it is appropriate to create their own PABs and ACCs.

The provisions in SB 409 alleviate the concerns listed above while providing flexibility for municipal governments. For these reasons the League respectfully requests that this committee provide Senate Bill 409 with a favorable report.

I am submitting this testimony in strong support of SB0409 on behalf of the Maryland Legislative Coalition. The Maryland Legislative Coalition is an association of activists - individuals and grassroots groups in every district in the state. We are unpaid citizen lobbyists and our Coalition supports well over 30,000 members.

Our members are very supportive of police officers, but believe just as strongly that there should be accountability to the public. In every successful community, there is a working trust between the community and the police. In Maryland, as in many other states, there have been too many instances where it is clear that the police are being their own enforcers and generally not ensuring that they are transparent with the community, nor are they able to discipline one of their own who hurts a community member.

Enter the Police Accountability Board, which has become the only way that some transparency and accountability can be accomplished. This bill would require each municipality to have a Police Accountability Board. Our members believe that this is a wise course of action. It would give the community a more formal mechanism for handling complaints of police misconduct and would also allow for reporting of the number of complaints and their disposition, which is information the community needs. Finally, it would allow for some positive ideas and policy recommendations to be made available to the police force.

Our only concern is that, although the Police Accountability Board would not include active, serving officers, we believe it should also not include any retired or former officers. It should be purely civilian.

We strongly support this bill and recommend a **FAVORABLE WITH AMENDMENTS** report in committee.

I am a member of the Police Accountability Board of Howard County, writing to you in my individual capacity. I write to express my support of Senate Bill 409, with an important amendment. I would note:

- 1. My concern (and the consequential need for an amendment to Senate Bill 409) arises with respect to the following: the new provisions for Municipal Corporations contain a significant and detrimental change, one which would result in a significant de-scoping of a PAB's authority and responsibilities for municipalities. Namely:
 - (a) Existing language in 3-102 (a) (1), covering counties:
 - hold quarterly meetings with heads of law enforcement agencies <u>and otherwise</u> <u>work</u> with law enforcement agencies and the county government to improve matters of policing; [emphasis added]
 - (b) Proposed language in 3-102 (c)(1) (I) covering Municipal Corporations:
 - HOLD QUARTERLY MEETINGS WITH HEADS OF GOVERNMENT AGENCIES IN THE MUNICIPAL CORPORATION AND HEADS OF LAW ENFORCEMENT AGENCIES WITH JURISDICTION IN THE MUNICIPAL CORPORATION TO IMPROVE MATTERS OF POLICING IN THE MUNICIPAL CORPORATION;
- 2. The omission in the Bill of the language "and otherwise work....." takes away the broad and general authorization (currently provided for counties in the existing legislation) for PABs to [otherwise] work with LEAs etc. to improve matters of policing. Now the only PAB authorization is to meet quarterly with LEAs etc. to do so.
- 3. It is unclear why the General Assembly would wish to provide significantly less authority to PABs in municipalities than currently exists for counties. I recommend the following amendment to the original Bill 409's text (which would fully replicate the provisions currently applying to counties):

HOLD QUARTERLY MEETINGS WITH HEADS OF GOVERNMENT AGENCIES IN THE MUNICIPAL CORPORATION AND HEADS OF LAW ENFORCEMENT AGENCIES WITH JURISDICTION IN THE MUNICIPAL CORPORATION AND OTHERWISE WORK WITH THOSE GOVERNMENT AGENCIES AND LAW ENFORCEMENT AGENCIES TO IMPROVE MATTERS OF POLICING IN THE MUNICIPAL CORPORATION;

The Episcopal Church, in its 2018 General Convention resolution on police violence and racism, stated, "that while we honor and raise up the work of dedicated police officers who put their lives on the line to serve and protect, we also acknowledge the numerous inexcusable deaths and intimidation of people of color at the hands of law enforcement personnel in communities all over the United States" Episcopalians are further urged to "join community and grassroots leaders in advocating ... substantive and mandatory change in police departments and policing and to allocate resources for community-based models of safety, support and prevention." In that spirit, the Episcopal Diocese of Maryland and its member parishes strongly urge a favorable report on this act.

Since the death of Freddie Gray in Baltimore in 2015 the Maryland General Assembly has moved steadily to empower communities to hold police officers to account. A component of the police reform suite of legislation that passed in 2021 requires each County to have a Police accountability Board and establish an Administrative Charging Committee. Chairman Smith and members of the committee,

My name is Robert Melvin, and I am the senior manager of state government affairs for the Northeast region with the R Street Institute. The R Street Institute is a nonprofit, nonpartisan public policy research organization. Our mission is to engage in policy research and outreach to promote free markets and limited, effective government in many areas, including criminal justice reform and civil liberty issues. This is why we find SB 409 noteworthy.

This bill would expand on House Bill 670, adopted in 2021, that established Police Accountability Boards (PAB) in each county in Maryland; however, a key distinction is that Senate Bill 409 would instead authorize each municipality in Maryland to institute PABs within their jurisdictions.¹

Ensuring law enforcement is responsive to the general public is not a contemporary idea, rather it is one that has been in existence since at least the 1920s.² Initially review boards were established in New York City, Philadelphia and Washington, D.C.³ Since that time there has been significant growth in the number of oversight boards for law enforcement with it rising from three to over 200 such panels.⁴

This coincides with burgeoning support for establishing civilian oversight boards, with the Pew Research Center finding that 75 percent of respondents support the creation of such boards.⁵

There has even been a recognition by law enforcement groups, such as the International Association of Chiefs of Police, which issued a report related to practices in modern policing. The report had several recommendations including that law enforcement agencies "establish a culture of transparency and accountability," and "create formal community advisory committees that reflect the demographics of the community or neighborhood that is being served." We believe that SB 409 would comport nicely with these suggestions.

Most jurisdictions have review boards, like those proposed in SB 409, so this common oversight mechanism is not novel; it has been tried and tested in many other states and localities. This approach provides many benefits for Maryland citizens and a responsive law enforcement community. The public tends to view these review commissions as more representative of the community, and they provide an opportunity for an outsider's perspective to be brought forward in the compliant investigations process which can help identify and remediate shortcomings.

The focus on ensuring these PABs have diversity on them will also incentivize law enforcement to ensure there is no bias or appearance of bias in their investigations, thereby increasing legitimacy, trust and confidence in the process. Moreover, there is an increased probability that police trainings and community relations can be improved.

Finally, this bill provides municipalities with the ability to form these PABs, allowing them to decide individually if these would be helpful in their own communities. Ultimately, this proposal will help provide more sunlight on law enforcement agencies, which can help them become more responsive and gain public respect.

The Maryland Association of Counties (MACo) **SUPPORTS** SB 409. This bill would authorize municipal governments to establish their own police accountability boards (PAB) and administrative charging committees (ACC) to provide civilian oversight for investigations of police misconduct.

Counties were required to establish, staff, and manage a PAB and an ACC in every jurisdiction as mandated by law. MACo believes municipalities should be authorized with comparable powers within their own jurisdictions. This legislation could partially relieve counties of their very broad responsibility to provide civilian oversight for misconduct allegations involving all law enforcement bodies in their jurisdiction. For scale, without this legislation, Prince George's PAB and ACC would be managing this process for all twenty-seven law enforcement agencies operating within its jurisdiction.

Municipalities overseeing the investigations of their own law enforcement agencies will ensure the work is specific to the needs of their community and that the cases are reviewed in a timely manner. This momentum can serve to reinforce the public trust in the process by avoiding frustrating backlogs and bottle necks on matters where residents insist on speed and attentiveness. Allowing municipalities the autonomy to establish these entities will streamline implementation and fulfill the overall intent of community participation.

The integrity of the civilian oversight process is paramount to fulfilling the goals of law enforcement accountability. The mandated implementation is a task that has been absolutely and devotedly undertaken by all county governments. The allowance of municipalities to establish their own process as well preserves a trust in local authorities that the system demands, while sharing the administrative responsibilities with the appropriate parties. The City of Gaithersburg writes to support SB409 - Police Accountability Boards and Administrative Charging Committees – Municipal Corporations.

SB409 would authorize a municipal corporation in the State to establish its own police accountability board and administrative charging committees, a power not afforded to municipalities through the Maryland Police Accountability Act of 2021. As you know, under this law, the authority to establish PAB's and ACC's was limited to counties. While we consider the establishment of PAB's and ACC's to be laudatory positive steps towards affirming public trust in law enforcement by holding those who violate that trust accountable, we believe that it was a mistake to deny municipal agencies with the capability and capacity to institute their own boards and commissions. SB409 would rectify this omission.

The City of Gaithersburg and other municipalities would benefit from this revision for the following reasons:

- There is no current requirement for municipal representation on these countycreated entities. Specific review of municipal trends, practices, and recommendations should be made and considered by municipal officials;
- Keeping the boards and committee "local" means a heightened familiarity with that Police Department's regulations and policies;
- O These boards and committees must be established with the very same standards as those established at the County level;
- O There is a backlog of disciplinary cases in Montgomery County, so requiring Gaithersburg Police Department cases to be processed through a County Board and Committee is likely to lead to substantial delays in disciplinary actions; and

POSITION: SUPPORT WITH AMENDMENTS

The Maryland Chiefs of Police Association (MCPA) and the Maryland Sheriffs' Association (MSA) **SUPPORT SB 409 WITH AMENDMENTS.** This bill would authorize municipalities to establish police accountability boards and administrative charging committees.

The Maryland Police Accountability Act of 2021 (CH 59, Acts of 2021), which establishes a statewide accountability and discipline process, requires each county to establish both Police Accountability Boards (PAB) and Administrative Charging Committees (ACC). Since its enactment, concerns have been raised by municipalities because they have no statutory role in the establishment or responsibilities of the PAB or ACC.

MCPA and MSA do not have concerns with municipalities establishing their own PABs and ACCs. However, MCPA and MSA want to be sure the lines of agency review and discipline are clear with respect to the county and municipal PABs and ACCs. As an example, a county police officer may be involved in an incident that may occur within a municipal jurisdiction. If a complaint is filed and adjudicated, it should be handled by the county PAB and ACC, not a municipal PAB and ACC. MCPA and MSA are seeking amendments to clarify that officers are subject to the PAB and ACC of the jurisdiction to which the officer is employed, not the PAB and ACC in the jurisdiction in which the incident and/or complaint occurred.

For these reasons, MCPA and MSA SUPPORT SB 409 WITH AMENDMENTS and offer to work with the Committee to develop the appropriate amendments needed.

The Office of the Attorney General respectfully requests a favorable report with amendments on Senate Bill 409. Senate Bill 409, as introduced, creates potential confusion depending on the local legislation. Amendments are needed to make it clear that municipal Police Accountability Boards "PABs" and Administrative Charging Commissions "ACCs" only have jurisdiction over the law enforcement agencies that fall under the authority of the municipality. The problem with the bill text is that it says, "law enforcement agencies with jurisdiction in the municipal corporation." Arguably, some of the universities and certainly the Maryland State Police have jurisdiction within municipal corporations, but the intent is not that those universities or barracks would fall under the municipality's PAB or ACC. Instead, they should and do fall under the statewide ACC.

Currently, the Baltimore City Police Accountability Board lists Morgan State University as an agency over which the city PAB and ACC have jurisdiction. That might signal to other cities that universities within the city fall under their PAB/ACC jurisdiction. Notably, however, Morgan State is not part of the University System of Maryland. Those that are a part of the University System of Maryland and already believe they are subject to the statewide ACC, would push back at any suggestion to the contrary.
