

Testimony for the House Judiciary Committee February 28, 2023

HB 585 Public Safety - Use of Force Incident Reports

FAVORABLE

The ACLU of Maryland urges a favorable report on HB 585, which would establish more transparency and accountability from police officers and law enforcement agencies in reporting use of force.

The State of Maryland is one of several states to require officers to intervene when instances of excessive force arise.¹ In previous sessions, the General Assembly has passed meaningful legislation outlining the scope of when police may use force on an individual.² However, despite this, the state lacks any requirements on reporting instances of using force by a police officer while on duty or generally by law enforcement agencies. The underreporting, or the lack thereof, on the use of force, undermines the effectiveness of police accountability efforts as there is no way of meaningfully collecting and examining data that could be used to prevent unlawful uses of force.

Generally, perceptions of police legitimacy have been linked to varying levels of cooperation and adherence to the law by police.³

HB 585 would require police officers to report uses of force engaged while on duty and require law enforcement agencies to publish those instances for the general public.

Mutual trust between police and the communities they serve is fundamental to both effective policing and public safety. Communities must be able to in trust in the safety and service law enforcement provides just as much as Police must rely on the cooperation and assistance of community members. Such trust is impossible without transparency and accountability. When the mandate of transparencey is not made available to the public that trust can be broken down.
