I had some foster homes I was sent to by D.SS, I almost went back to my no having window, no heat, small tiny shed, be caux I was mixrable. Thank God I had someone (Kelley Ray) who didn't let go of me during this entire proceess. I coult get into the detoils, However I want to point the picture for your. I magine this, you have this lady in a 40's at the time, sees, this kids at a local gym, in desparate need of help. this is a foreign Kid that was put on the sheet at age 14 no tourly Members, no uncle, mo aunt, no lousins, Nobody. This kid Never drops out of school he worked played sport and went to school.

She takes a Chana on the lid, as soon as she realizes the situation she takes oction, she calls the right people, she gets involve with demolish intention. This kid is being misheded in the system, they don't feed him, they don't take him to his Doctor's appointments, they don't pick him up from work late at night. This Lady (kelley Ray) Deides to contact the DSS (Department of social Service) supervisor to see it there is any thing she can do to help. she was already doing the work anyway. This lady agrees to change her toster porent lianse from City to Grunty forme. Just so I can get the proper coure, and attention . This lady becomes my toster parent to the fullest, till I go on semi independent living. (That's where the system requires you to go get on agartment, teaches you how to manage bills, you get a job pay your bills and they gay you the money money back. Is cause you are about to age out of the system.) I'm out of the system, with the right guidance, the proper discipline, and the grace of God I buy my house out 20 yearsold. She had all the right to say " well I did my Job, you are well off on your feet, bye bye now." But she didn't. She goes a step further. I'm going to adopt this K'd no help from anyhody, puts up her own money, hires her own afterney, To the biggest night move of this journey to tind out that she needs permission from a Bastard, selfish, Ignorant, incesponsible, psychopath woman, who will never pass or single chass on parenthood. only know how to open her legs to men, if it's ok to do her job for her?"

you put yourself in that situation, see how much anger and resentment you will have. This is someone that set me up for failure, I wild have been deal, stabled, faitet Joiled, she would n't have cared. I have to notity her that It a loving, caring mother is trying to do her job for her? " It's like someone who shoots you to kill you, you survive and the paramadics call that persone to tell them, oh by the way the person you shot is not dead, they survived, the are taking them to this hospital were need your signature before we stour to operate to take the bullet out." The worst thing you can ever do to a traumatized person. s to make them go back to their orbuser, or make them re live their rouma moments. For Starter I didn't know & I could be idopted again at my age I 28 years old night my mother been taking lave of me since 2012 it's 11 years now I know my mother. My higgest fear was what would happen to me if I'm not able to make decision on my own like at the hospital, they would have to call the psycho witch. Now with this adoption in glace no chance in hell she has to interfere with my life ever again, No attouchment what so ever. For what it's worth I think the process com be a little better. for instance, Not notifying the abuser if the kid is over 18 years old, and has been on his own for a while. The out of country journal advertisement is oil bigo headache because there one scammers they can take your movey and never get it done. Different Countries have different rulks. Not changone has a Jaster process like the U.S.

There is no other traigedy in life that can scare me. My biggest advantage in life is that is I've built survivor skills while being homeless. Nothing else Can scare

I'm four tuneste enough that my mother could afford it I do be lieve there should be a system in place to assist & those powents out there who "QuALIFY "and" De Serve" to adopt the kid they want to give a second Chana in life to.

Lord remows I needed theat sectored chance and kelley how gove it to me. Here I'm today telling my Story. Failure in life is not lack of will power, it's lack of guidance and there our many kids out there with a right parent they can achieve wonders. but some one stock in toster system with greedy parents poster parent who one just outer the state's Check. Some governts wont to stout the process but lack the tunds.
