# HB 28 – INCOME TAX CREDIT ELDER CARE SERVICES SUPPORT

GOOD AFTERNOON CHAIR ATTERBEARY, VICE CHAIR WILKINS AND MEMBERS OFTHE WAYS AND MEANS COMMITTEE. I AM HERE TO ASK FOR FAVORABLECONSIDERATION OF HOUSE BILL 28, WHICH PROVIDES UNPAID CAREGIVERS WHOOPROVIDE SERVICES TO OLDER FAMILY MEMBERS IN THEIR HOMES TO CLAIMQUALIFIED EXPENSES ON THEIR STATE INCOME TAXES OF UP TO \$5,000 FOR ONOFAMILY MEMBER AND UP TO \$10,000 FOR TWO OR MORE FAMILY MEMBERS. THEBILL CAPS THE TOTAL AMOUNT OF TAX CREDIT CERTIFICATES ISSUED IN ANYFISCAL YEAR AT \$5 MILLION.THIS BILL AIMS TO EASE THE FINANCIAL BURDEN FACED BY CARE GIVERS WHENTAKING CARE OF AN OLDER FAMILY MEMBER. TO BE ABLE TO CLAIM THE CREDIT, THE TAXPAYER MUST FIRST SUBMIT TO THE

DEPARTMENT OF HEALTH THE TAXPAYER AND QUALIFIED FAMILY MEMBER'S

NAME, PROOF OF QUALIFIED EXPENSES AND ANY OTHER INFORMATION THE

DEPARTMENT REQUIRES.

QUALIFIED EXPENSES FOR WHICH THE CAREGIVER CAN CLAIM CREDIT

#### INCLUDE:

HOME HEALTH SERVICES; ADULT MEDICAL DAYCARE; FOOD PREPARATION AND

GROCERY SHOPPING, LIGHT HOUSEKEEPING; RESPITE CARE; AND DURABLE

MUST SUBMIT WITH THE STATE INCOME TAX RETURN PROOF OF THOSE QUALIFIED

EXPENSES.

ALONG WITH PROOF OF EXPENSES, THE TAXPAYER MUST SUBMIT A LETTER OF MEDICAL NECESSITY SIGNED BY A LICENSED PHYSICIAN OR NURSE PRACTITIONER THAT THE APPLICANT PROVIDED ASSISTANCE TO THE QUALIFIED SENIOR FAMILY MEMBER ASSISTANCE WITH AT LEAST THREE ACTIVITIES OF DAILY LIVING. WE DO NOT HAVE SOLID STATISTICS ON HOW MANY MARYLANDERS ARE CARING FOR OLDER FAMILY MEMBERS IN THE CAREGIVER'S HOME; HOWEVER, THE DEPARTMENT OF AGING IN DESIGNING SUPPORT SERVICES FOR CAREGIVERS DURING COVID ESTIMATED THE NUMBER AT 250,000. WE **DO KNOW** THOSE WHO CARE FOR OLDER ADULT FAMILY MEMBERS FREQUENTLY GET LITTLE OR NO MONETARY COMPENSATION, AND IN MANY CASES IT CAUSES FINANCIAL HARDSHIP FOR THE CAREGIVER INCLUDING TIME OFF FROM A PAID JOB. 2017 FOUND THAT ACROSS THE UNITED STATES, OVER 53 MILLION US ADULTS WERE

THE STATE OF MISSOURI ENACTED AN ELDERCARE TAX CREDIT BILL NEARLY 25

YEARS AGO, WITH LITTLE OBVIOUS FINANCIAL DETRIMENT TO THE STATE. THE

STATE OF ARIZONA ADOPTED SIMILAR LEGISLATION IN 2021 AND THE NEW JERSEY

STATE ASSEMBLY IS CURRENTLY CONSIDERING AN ELDERCARE TAX CREDIT BILL.

MARYLAND CAREGIVERS NEED THIS KIND OF FINANCIAL RELIEF AND SUPPORT.
