AMENDMENTS TO HOUSE BILL 200  
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 12, strike “authorizing” and substitute “requiring”; and in line 13, strike “modify” and substitute “provide feedback on”.

AMENDMENT NO. 2

On page 4, in line 32, after “employ” insert “AT LEAST”.

On page 6, in line 3, strike “provide” and substitute “:

**(I) PROVIDE”;**

and in line 4, after “13A.04.16.01” insert “:AND

**(II) FUND COSTS ASSOCIATED WITH STAFF, CONTRACTED SERVICES, AND OTHER SUPPORT NECESSARY TO PLAN AND DELIVER WRAPAROUND SERVICES WITH FIDELITY”.**

On page 9, in line 6, strike “MAY” and substitute “SHALL”; and in line 10, strike “CORRECT”.

On page 10, strike beginning with “the” in line 20 down through “communities” in line 22 and substitute “,AT MINIMUM”:

**1. THE NEEDS RELATED TO STUDENT, FAMILY, AND COMMUNITY WRAPAROUND SERVICES, INCLUDING ACADEMIC SUPPORTS FOR STUDENTS FROM BIRTH THROUGH AGE 21, IF NECESSARY;**

**2. THE PHYSICAL, SOCIAL, EMOTIONAL, AND BEHAVIORAL NEEDS OF STUDENTS AND THEIR FAMILIES AND COMMUNITIES; AND**

**3. THE ADULT EDUCATION AND WORKFORCE DEVELOPMENT NEEDS OF STUDENTS AND THEIR FAMILIES AND COMMUNITIES”;**

in line 25, strike “, WHEN” and substitute “:

**1. WHEN”;**

and in the same line, after “AVAILABLE;” insert “AND

**2. MODIFIED AS NECESSARY BASED ON THE NEEDS OF THE COMMUNITY BEING SERVED;”.**

On page 11, in line 3, strike “APPROVED BY” and substitute “SUBMITTED TO”; in line 22, strike “MAY MODIFY” and substitute “SHALL PROVIDE FEEDBACK ON”; in the same line, after “ASSESSMENT” insert “TO THE COMMUNITY SCHOOLS COORDINATOR AND THE LOCAL SCHOOL SYSTEM”; in line 29, strike “STUDENTS” and substitute “THE”; and in line 30, after “NEEDS” insert “OF STUDENTS AND THEIR FAMILIES AND COMMUNITY”.

On page 12, strike in their entirety lines 3 and 4.
