Dear Delegates,

I am Stephanie Midgett and I am writing to you today, as a Parent and volunteer at The Chesapeake Public Charter School, to ask you for your support of HB1061 [School Construction - Public Charter School Facility Fund - Establishment](#) sponsored by Delegate Young.

As a member of the House Appropriations Committee, this bill will be before you on March 5th. I am writing to share why this bill is essentially to pass. Maryland public charter schools are an integral part of the public-school portfolio in Maryland, serving more than 24,000 students statewide. The communities with public charter schools, the teachers and staff that work there, the districts that include them, and the students that attend them would all benefit directly from the much-needed funding HB1061 would supply.

LEAs are able to utilize capital funding and general funds from other sources, not available to public charter schools, to support their facilities, operations, & maintenance. HB1061 seeks to establish a fund managed by the IAC that allows public charter schools to apply for up to \$2000 per pupil annually for eligible facilities-related expenses. This funding does not impact the Blueprint formula or take funding away from any other public-school students, as the funding would come from the State's General Fund. Instead, HB1061 will allow more Blueprint dollars to be spent IN the classroom on learning instead of ON the school's facility. It also sets strong parameters around spending accountability and transparency while ensuring there is standard bond bill language on repayment if a school should close or sell a privately-owned building.

Charter school students are public school students and they deserve to be educated in a safe, welcoming, adequate school buildings just like their traditional public-school peers. As a parent to four children who all attend the Charter school, I can personally attest the huge impact it has made in my children's lives. The difference a safe environment can create changes lives and for some students a public charter school is exactly that. My current 8th grader attended Mechanicsville Elementary School in St. Mary's County for K-3rd grade. The environment that my child experienced in and up to 3rd grade was horrendous. We had to fight the public school for services that she qualified for under several categories, she was forgotten, bullied and isolated. Her health both physically and mentally depleted so much because Mechanicsville despite my efforts could not provide her a safe environment. It is my belief that if my child had not gained acceptance into the charter school that she would not be with us today. The charter changed all of our lives. Just because a family decides to send their children to a public charter school and stay in the public-school system, why do they have to attend, on average, an older, more in need of repair, discarded building? Why do charter school teachers have to teach in buildings that do not have adequate space, amenities, or supports? My middle school is required to walk up three flights of stairs to his classroom multiple times a day because the building he is taught in was not meant to be a school. Why do charter school operators have to pull funding out of their Blueprint dollars to pay for their buildings, while traditional schools & LEAs pull from capital funding and general funds? Why does a public school like Mechanicsville where students are ignored or forgotten get to be remodeled while public charter schools like Chesapeake who meet each student where they are at and bring them to the highest-level possible struggle to keep the lights on in their building. Bottom line, it isn't equitable. Through your support, we can work to close inequities public charter school students, families, and teachers experience in their school buildings every day.

We have had more than 20 years of public charter schools in Maryland. It is about time we get to work funding their public-school facilities. So that the safe and welcoming learning environment they supply for our children is continued to be supported like the other public schools. We look forward to the hearing on March 5th and your support of HB1061, School Construction - Public Charter School Facility Fund - Establishment. Please know that it is not only myself, but the larger charter school community across the state of more than 24,000 families, 53 schools in eight districts standing behind you.
