AMENDMENTS TO HOUSE BILL 376
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 8, strike "Council" and substitute "Board of Education".

AMENDMENT NO. 2

On page 2, in line 10, strike "county departments" and substitute "State and county agencies"; in line 28, strike "Council" and substitute "Board of Education"; and in line 30, strike "December 31, 2024" and substitute "June 1, 2026".

On page 3, in line 3, strike "1 year" and substitute "2 years"; and in line 4, strike "2025" and substitute "2026".
