The Maryland Chiefs of Police Association (MCPA) and the Maryland Sheriffs' Association (MSA) **SUPPORT SB 1077.** This bill increases funding for school resource officers to provide adequate law enforcement coverage if a school is not assigned a school resource officer.

A school resource officer is a law enforcement officer who works closely with administrators in a school setting to create a safer environment for students and staff. In this role, the SRO also provides mentoring and conducts presentations on youth-related issues. Because of this broader role in a school system, an SRO participates in a specialized training program designed specifically for working with students in a school setting. This training curriculum includes Maryland school law, trauma-informed counseling, restorative practices, relationship building, and peer mediation techniques. To employ the skills taught through this training an SRO must work in the school system, engage with students, build positive relationships, and direct students to resources. For many students, an SRO is a positive role model in which they can trust and confide in. These strong relationships build community trust and understanding and improve safety in the school environment.

MCPA and MSA support an increase in funding for this purpose and encourage greater flexibility in how funds may be used. Under current guidelines, if an existing law enforcement officer receives training and transfers to an SRO unit, funds cannot be used to replace the law enforcement officer who transferred. As Chiefs and Sheriffs manage their agency budgets, this flexibility to use funds for this purpose as long as the number of SRO positions in the unit increases would meet the specified intent of the law while ensuring other agencies' needs are met. For these reasons, MCPA and MSA **SUPPORT SB 1077.**

The Washington County Board of Education supports Senate Bill 1077 as it aligns with the Board's 2024 legislative priority of encouraging the state to allocate additional funding for school security employees and school resource officers to help achieve the goal of providing a safe and secure learning environment for students and staff.

Washington County Public Schools enjoys a strong partnership with our local law enforcement agencies who provide school resource officers for our campuses. However, unlike most boards of education, Washington County Board of Education is responsible for the full cost (i.e., salary and benefits) for these school resources officers and reimburses Washington County Government and the City of Hagerstown the costs of the officers from its maintenance of effort funding which is intended to cover instructional expenses. The cost to the Board of Education under the contracts with the respective agencies has increased from \$849,607 in Fiscal Year 2022 to over \$1.2 million in Fiscal Year 2023. The Board of Education anticipates a total cost of over \$1.5 million being paid to Washington County Government and the City of Hagerstown for school resource officers in Fiscal Year 2024, an increase of more than \$250,000 from the previous fiscal year.

However, because school safety and security is a priority for the Board of Education, this year it made an investment of just over \$800,000, in addition to the \$1.5 million paid for school resources officers, to hire 19 school safety and security assistants to further enhance school safety at each secondary school in Hagerstown and Williamsport. The return on this investment is clearly evident. These new safety and security assistants have made our schools safer, been proactive in addressing safety concerns, assisted in responding to concerning student behaviors, and helped grow a positive school culture. They each have developed a positive rapport with their respective school communities and most importantly, the students they serve each day. Their important work was best characterized by one of our high school principals whose school has benefited greatly from the addition of our school safety and security assistants. He said, quote, "We're not policing students, we're supporting students."

The additional funding provided under Senate Bill 1077 will be important in helping to enhance safety efforts at schools across Maryland. Just as, if not more important, is the flexibility this bill will offer by allowing LEAs to utilize resources provided through the School Safety Fund to support school security employees, not just school resource officers as it currently does and from which Washington County Public Schools benefits from through the receipt of a grant of \$324,000 to provide adequate police coverage in our schools. Both school security employees and school resource officers are important components of achieving the goal of providing a safe and secure learning environment for students and staff.

The Washington County Board of Education respectfully requests a favorable report on Senate Bill 1077.

On behalf of the Maryland Center for School Safety (MCSS), thank you for the opportunity to submit this letter of support for Senate Bill 1077. MCSS remains committed to assisting Local Education Agencies (LEA) in implementing a layered approach to school safety.

MCSS fully supports county governments and school systems in making decisions about local school safety personnel and other layered approaches to school safety and security. The School Resource Officer (SRO) Grant Program is a non-competitive grant program designed for LEAs and law enforcement agencies to meet statutory requirements to provide each public school in Maryland with an SRO or adequate law enforcement coverage. Senate Bill 1077 would increase flexibility for locals to use this grant to support local decisions to include School Security Employees (SSEs) as part of the multi-pronged approach to school safety and security.

SSEs are individuals who (1) are not SROs, (2) are employed by the LEA to provide safety and security-related services at a public school, and (3) are required to complete the MCSS SRO/SSE model training. MCSS supports the creation of diverse school safety and security teams that include **both** SROs and SSEs, as each provides opportunities for strong connections with students, caregivers, and school personnel. As an employee of the LEA, the SSE works closely with school-based leaders on safety and security measures, often outside law enforcement's scope. The SSE can be closely involved in student behavior support, providing interventions to prevent, mitigate, and restore harm, something that an SRO can't do given their law enforcement duties.

MCSS's support for Senate Bill 1077 and the use of SSEs by local jurisdictions is not counter to support for SROs, as again, each position working together creates a layered approach to school safety.

Thank you again for taking the time to review this information and consider giving Senate Bill 1077 a favorable vote.

Thank you for the opportunity to present SB 1077. The School Resource Officers Adequate Funding Grant state allocation amount has been set at \$10 million dollars since its inception in 2018 as a part of the Safe to Learn Act. This grant fund can only be utilized to hire sworn law enforcement officers as SROs to provide adequate coverage. Currently there isn't flexibility to hire secondary School Security Employees, such as retired law enforcement officers.

SB 1077 will increase this grant allocation from \$10 million to \$15 million in fiscal 2026, and to \$20 million in fiscal 2027 and each year thereafter. Additionally, it expands the authorized uses of the grant funds to include school security employees so that school systems have more flexibility in hiring security staff in our schools. Finally, there is a change to allocated funding on per pupil basis as opposed to a per school basis. However, we have submitted an amendment to change that back to the language in the original statute.

The Maryland Catholic Conference offers this testimony in support of favorable with amendments for Senate Bill 1077. Senate Bill 1077 increases the annual appropriation for the Safe Schools Fund from \$10,000,000 to \$20,000,000 by fiscal year 2027. The Safe Schools Fund provides grants to local school systems and local law enforcement agencies for school safety. The bill also expands he allowable uses for the funds for the cost of school security personnel.

The safety of our school students in all Maryland schools is a paramount concern, whether they attend a public or private school. One in eight Maryland students, or around 135,000, attend a nonpublic school. Prior to 2023, the state budget was providing \$3.5 million for lower-tuition nonpublic schools to receive a per pupil allocation grant for school safety and security measures, but that has been removed this year. Especially with increased threats upon members of denominations of our diverse group of Maryland faith-based schools, security dollars are of great need. Thus, we respectfully request that this committee provide that same \$3.5 million in this legislation through the attached amendment.

Many of the schools with lower-income student enrollments would not have been able to complete the security upgrades without this funding and should be able to continue to do so annually. The program is making an impact statewide and is highly popular with administrators in every jurisdiction. Student safety should not be determined by whether you attend a public or nonpublic school. For this reason, we urge this committee to adopt the aforementioned amendment and issue a favorable report on Senate Bill 1077, as amended.

The Public School Superintendents' Association of Maryland (PSSAM), on behalf of all twenty-four public school superintendents, **supports** Senate Bill 1077 with **one amendment.** 

This bill increases the annual mandated appropriation to the Safe Schools Fund to provide grants to local school systems or law enforcement agencies to assist in providing adequate law enforcement coverage for public schools, from \$10.0 million to \$15.0 million in fiscal 2026, and to \$20.0 million in fiscal 2027 and each year thereafter. The bill also (1) expands the authorized uses of the grant funds to include school security employees and (2) alters the basis for the allocation of the funds to be the proportion of students enrolled in each local school system instead of the proportion of schools in each local school system.

PSSAM requests one amendment that the grant formula revert to the current model using the number of schools, rather than the proposal based on enrollment. The current model recognizes that school safety requires a campus deployment strategy and is a more equitable funding formula.

In 2018, the General Assembly passed the Safe to Learn Act and created a comprehensive initiative for the improvement of school safety, including the creation of the Safe Schools Fund to be administered by the Maryland Center for School Safety (MCSS). While local districts are in need of additional funding for school safety, the existing prohibition on using the funds for school security employees has resulted in lower usage of the Fund; this is reported in the fiscal note as expenditures of \$6.2 million of the \$10.0 million mandated appropriation in FY '23. The authorization under this legislation will greatly enhance the demand and usage of the entire Fund.

For these reasons, PSSAM supports Senate Bill 1077 and requests a favorable report with one amendment to maintain the current funding formula.

### SENATE BILL 1077: PUBLIC SCHOOLS-APPROPRIATIONS FOR SCHOOL SAFETY EXPENDITURES-SCHOOL SECURITY EMPLOYEES

DATE: FEBRUARY 28, 2024

**POSITION: OPPOSE** 

The Maryland Coalition to Reform School Discipline (CRSD) brings together advocates, service providers, and concerned citizens interested in transforming school discipline policies and practices within Maryland's public-school system. CRSD is committed to making discipline responsive to students' behavioral needs, fair, appropriate to the infraction, and designed to keep youth on track to graduate. CRSD provides this testimony in opposition to Senate Bill 1077.

Senate Bill 1077 aims to raise the annual budget allocated to the Safe Schools Fund to \$15 million for fiscal year 2026 and \$20 million for fiscal year 2027. Current law already requires that \$10 million per year be appropriated to the Safe Schools Fund specifically for SROs and law enforcement coverage in schools. A recent state audit of the Maryland Center for School Safety (MCSS) finds that these funds aren't being managed appropriately or fully used. The audit reported a "significant deficiency in the design or operation of internal control that could adversely affect MCSS' ability to maintain reliable financial records, operate effectively and efficiently, and/or comply with applicable laws, rules, and regulations." Specifically, the state audit found that "MCSS did not ensure School Resource Officer (SRO) grant payments were properly supported and subject to independent review."

- "MCSS did not obtain documentation to support the propriety of payments made to grantees and to ensure the grantees only claimed allowable costs."<sup>4</sup>
- "An audit test of 18 payments totaling \$2.3 million made to 8 grantees during the period from July, 2021 to April, 2022 disclosed that all 18 lacked sufficient supporting documentation."<sup>5</sup>
- "For one payment to an LEA totaling \$902,000, MCSS only received payroll reports for 13 employees with gross earnings totaling \$593,000. MCSS was not aware that the remaining \$309,000 in charges were not supported by the reports and it could not explain the difference."

"Grant payments were not subject to supervisory review and approval... Specifically, our test
of nine payments over \$100,000 disclosed that seven payments totaling \$967,000 lacked
documentation of an independent supervisory approval."

Moreover, during fiscal years 2020 through 2022, SRO grant payments totaled \$8.0 million.<sup>8</sup> Some school systems received multiple grants to local law enforcement agencies while *other school systems did not apply for SRO grants.*<sup>9</sup> There is no reason to double the amount of funds being appropriated for SROs and law enforcement coverage when the current funding is not being fully used and there are concerns about the management of the current funds. The MCSS needs to put in place additional oversight, protocols, and accountability measures before it is given additional funding and responsibilities.

Senate Bill 1077 is also misguided because adding more police and security employees to our schools will not make our schools safer but will contribute to the school-to-prison pipeline. Studies have found that the presence of SROs has limited effects on school safety but results in negative student outcomes such as increased suspension, expulsion, police referrals and arrests. Black students and students with disabilities are disproportionately harmed by the presence of police in schools. In Maryland, for the 2021-22 school year, Black students received 61% of school arrests despite comprising only 33.2% of the student population. Special education students received 28% of school arrests despite comprising 12% of the student population.

The state should not increase funding for SROs, security employees, and law enforcement coverage--an ineffective and unproven safety strategy. Rather, we should focus on ensuring that the *Blueprint* plan, specifically pillar 4, is fully implemented.<sup>12</sup> Evidence-based strategies and resources such as mental and behavioral health services, community-based wraparound services, community schools and restorative approaches are *proven* strategies that serve to foster strong relationships between students and school staff to create safe school environments.<sup>13</sup>

### For these reasons, CRSD opposes Senate Bill 1077.

SENATE BILL 1077 Public Schools - Appropriations for School Safety Expenditures - School Security Employees

#### STATEMENT OF INFORMATION

DATE: February 28, 2024

**COMMITTEE: Budget and Taxation** 

**SUMMARY OF BILL:** Senate Bill 1077 increases the annual mandated appropriation to the Safe Schools Fund to provide grants to local school systems or law enforcement agencies to assist in providing adequate law enforcement coverage for public schools, from \$10 million to \$15 million in fiscal 2026, and to \$20.0 million in fiscal 2027 and each year thereafter. The bill also (1) expands the authorized uses of the grant funds to include school security employees and (2) alters the basis for the allocation of the funds to be the proportion of students enrolled in each local school system instead of the proportion of schools in each local school system.

**EXPLANATION:** Senate Bill 1077 increases State general fund mandated costs by \$5 million in fiscal 2026 and by \$10 million in fiscal 2027 and every year thereafter.

The Department of Budget and Management (DBM) is charged with submitting a balanced budget to the General Assembly annually and will be working with the General Assembly to achieve structural balance over the long-term. In light of current projected general fund deficits in fiscal 2026 forward, the Department urges caution in passing legislation significantly reducing general fund revenues. State government must be intentional, disciplined, and strategic with its allocation of State funding to ensure maximum impact toward priority outcomes. It would be challenging for the State to manage a significant increase in spending given the forecasted out-year deficits for the General Fund.

However, DBM notes that the provisions in Senate Bill 1077 expanding authorized uses of grant funds are beneficial given that the Maryland Center for School Safety has insufficient demand for the program as it exists currently in statute. The annual appropriation has been \$10 million since fiscal 2020, yet annual grant expenditures have remained at or below \$5.2 million. Authorization to use the funds for school security employees may encourage local school systems to use a greater portion of the funds than they have in the past.
