Chairman Wilson,

The Maryland Department of Emergency Management (MDEM) writes in support with amendments for HB1077 - Office of Small, Minority, and Women Business Affairs – Small Business Climate Change Coordinator – Establishment.

Climate change and the natural hazard impacts associated with it pose a challenge to Marylanders. As the home of the Maryland Office of Resilience, MDEM supports the development of capacity and capability within each executive branch to integrate resilience efforts into their mission. We support this bill as it will provide dedicated assistance to small, minority, and women-owned businesses in addressing the unique challenges of climate change faced by these businesses, and it will provide support to businesses interested in developing services in the climate change and resilience sector.

Amendment requested: Include coordination with the Office of Resilience (recommended changes attached)

Justification: The Office of Resilience was established in statute in 2022 and funded in FY24. One of the roles identified in statute for the Office is "to coordinate across State and local agencies to prepare and implement resilience strategies"; an additional role includes "working with business leaders from industries vulnerable to the risks to identify best practices for preparing for and responding to risks" (PS §14-1202). To avoid duplication of effort or redundancy, we recommend the activities
