A BILL ENTITLED

1 AN ACT concerning

2 **Business Regulation - Cigarette, ~~Other Tobacco Product,~~ and Electronic**  
3 **Smoking Device Retailers - Nicotine Replacement Therapy Products**  
4 **(Make Quitting Convenient Act)**

5 FOR the purpose of requiring licensees that sell cigarettes, ~~other tobacco products,~~ or  
6 electronic smoking devices at retail to keep in stock and offer for sale at retail at  
7 least one kind of nicotine replacement therapy product and to post certain signs; and  
8 generally relating to the retail sale of nicotine replacement therapy products.

5 this subtitle to act as a retailer.

12 (a) A licensee shall display a license in the way that the Executive Director  
13 requires by regulation.

14 (b) A licensee who sells cigarettes through a vending machine:

15 (1) shall place each package of cigarettes in the machine so that when the  
16 package is visible the tax stamps required by § 12-304 of the Tax - General Article are also  
17 visible; and

18 (2) in the way that the Executive Director requires by regulation, shall:

19 (i) identify each vending machine with a conspicuous label that  
20 states the licensee's name, address, and telephone number; and

21 (ii) display on a conspicuous label applicable prohibitions and  
22 penalties under § 10-107 of the Criminal Law Article.

 25 separately, including any substance intended to be aerosolized or vaporized during use of  
 26 the device.
