This approach supports the integration of technology into the learning process and reflects a consensus within the community, involving parents, educators, and students in shaping guidelines suitable for the local educational environment.

#### SB112 – County Boards of Education – Student Cellular Phone Use – Policy Required

### **OPPOSE**

Anne Arundel County Public Schools (AACPS) opposes **SB112 – County Boards of Education – Student Cellular Phone Use – Policy Required**. This bill requires each county board to develop and adopt a policy prohibiting students from using a cell phone during instructional time unless a teacher expressly directs students to use cell phones for educational purposes.

State law establishes educational matters that affect the counties shall be under the control of the county board of education, and that local boards of education, "determine, with advice from the county Superintendent, the educational policies of the county school system." AACPS supports local control of educational policies and opposes efforts such as this that would reduce or circumscribe local board authority to establish school system policy. Local boards of education receive and rely on public input and are best able to address local needs. The relationship between the community and local public schools encourages participation by parents, guardians and other community members.

While AACPS believes that students should not be using cell phones during instructional time unless directed by a teacher, this bill infringes upon the ability of local school systems to establish policies and procedures that best address the needs of their communities.

Accordingly, AACPS respectfully requests an UNFAVORABLE committee report on SB112.

The Maryland Association of Boards of Education (MABE) opposes Senate Bill 112.

MABE appreciates the intent of this bill to improve conditions for teaching and learning by requiring that each school system adopt a policy regarding student cell phone use in the classroom. However, MABE believes that the decision on whether and how to adopt such a policy should be the responsibility of each local board of education. In addition, because this bill would mandate local policies imposing strict prohibitions on cellular phone use in a classroom unless expressly permitted by the teacher, in enacted it would likely result in mandatory changes to student discipline policies and practices as well.

Local boards of education play a vital role in governing the local school system, advocating for public education, and engaging local communities and promoting participation by parents and other community members in the education process so that everyone feels a responsibility for, and ownership of, Maryland's public schools and our students' futures. The development and adoption of local board policies on the use of cell phones in the classroom should certainly be the subject of this locally-drive policy-making process.

Again, MABE believes that by retaining decision-making authority at the local level, local boards of education can fulfill their obligation to consider educational practices, available resources to implement those practices, community input, and academic and financial accountability.

MABE is resolved to continue to support programs to prepare students for college and career readiness through access to online learning, educational technologies, and high-quality digital content; create a fully technology-proficient PreK-12 educator workforce; and provide equitable access to current and emerging technologies for all students and educators and expanded opportunities for parents, families, and the community.

For these reasons, MABE requests an unfavorable report on Senate Bill 112.
