Support of: SB 88 – AN ACT concerning Maryland Commission on Veterans and Military Families.

Testimony

Chairman and honorable committee members, the Department of Defense is grateful for the opportunity to support the policies reflected in Senate Bill 88, for the purpose of establishing the Maryland Commission of Veterans and Military Families, to study developing and implementing a strategic plan to make Maryland the best state for military families. By including the military community's perspective in state planning documents and adding military community representation to state boards and coucils, states help ensure that unique operational requirements and military family priorities are considered across pertinent policy areas.

My name is Christopher Arnold. I am the Mid-Atlantic Region Liaison at the United States Department of Defense-State Liaison Office, operating under the direction of Under Secretary of Defense for Personnel and Readiness.

We represent the Department and establish relationships with state leaders across the country who are concerned for troops and their families' welfare by harmonizing state and federal law and regulation on policy problems of national significance. These are identified by the Office of the Secretary of Defense, the Military Departments, and the National Guard Bureau as areas where states can play a crucial role.

Across the nation, we have seen states recognize the value of having military voices at the table, including military families. This inclusion strengthens mission readiness, addresses family concerns, and fosters deeper collaboration between communities and state leaders. The policies in Maryland Senate Bill 88 take this vital step by establishing the Maryland Commission on Veterans and Military Families, offering a platform for diverse voices within the military

community to actively contribute toward shaping a statewide strategic plan which prioritizes the well-being of veterans and military families.

With nearly 77,000 service members and their families in Maryland, including the viewpoint of military families on this commission helps ensures unique operational requirements and military family priorities are considered.³ Senate Bill 88 helps achieve the ambitious goal to make 2024 the 'Year for Military Families' in the Old Line State.⁴

Military community representation on state boards and councils can have a profound impact on creating livable communities, enhancing military mission readiness, and influencing the qualityof-life factors that are critical in strategic basing decisions. ⁵ The policies proposed in Senate Bill 88 include appointing representatives of military family advocacy organizations, who would bring a wealth of experience and diverse perspectives that can lead to more innovative solutions to community challenges. Understanding the specific needs of military families, such as accessible healthcare, quality education, and employment opportunities for spouses, military community representatives can advocate for improvements in these areas.⁶

When military families are supported in their communities through improved education, healthcare, and employment opportunities, it reduces stress and distractions for service members, allowing them to focus more effectively on their mission. Livable communities with robust support systems for military families can be a key factor in the decision of service members to continue their military career. 8 Additionally, such communities are attractive to potential recruits who consider the quality of life for their families when deciding to join the military.

The quality of life in surrounding communities is also a critical factor in basing decisions. Bases located in areas with strong support for military families, good schools, and accessible child care and healthcare are more desirable and can influence the Military Departments' strategic basing decisions. 10 Bases benefit from being in communities that understand and are responsive to the

unique needs of military families. The result is a mutually beneficial relationship between military installations and their surrounding communities, enhancing the quality of life for all residents.

While the military has its internal support structures, these often focus on the immediate and internal aspects of military life. State boards and commissions such as the proposed Maryland Commission of Veterans and Military Families, on the other hand, address broader issues that intersect with civilian sectors, such as education, healthcare, and employment. The role of the Maryland Commission is to bridge the gap between military and civilian spheres, ensuring that the needs of military families are understood and met in the wider community context.

Such bodies often lead to long-term cost savings and efficiency improvements, providing a focused platform for addressing specific needs of the military community, which can streamline services and prevent the misallocation of resources, complementing existing structures by filling gaps in services and offering specialized insights that might otherwise be overlooked. The inclusion of the military community onto the Commission is a strategic decision to leverage their unique skills, perspectives, and experiences.

In closing, let me say that we are grateful for the tremendous effort that the Maryland has historically given in supporting our Service members and their families. On behalf of the Department of Defense, we appreciate your consideration of the policy changes expressed in Senate Bill 88 and thank Senator Gile for her sponsorship and leadership.

Dear Chair Feldman and distinguished members of the Education, Energy, and the Environment Committee:

On behalf of the members of the Maryland Military Coalition (MMC) and as its President, I write to recommend a **FAVORABLE report** by the Committee on **SB 0088, Maryland Commission on Veterans and Families**, sponsored by Senator Dawn Gile. This bill will establish a Commission on Veterans and Military Families which will develop a strategic plan to make Maryland the best state for veterans and military families.

Although many notable legislative and administrative proposals have been identified to improve the lives of Maryland veterans and military families, these ideas are considered in isolation without a comprehensive analysis. The Commission will be able to develop a statewide strategic plan to guide legislative and budgetary decisions. Maryland is in competition with other states for military retirees. Other states – including Virginia – have established similar commissions to advise the legislature and Governor on actions that can improve the lives of veterans and military families.

The strategic plan to be developed by the Commission will guide legislative and budget decisions. The Commission will identify key performance indicators and quantifiable metrics to assess the effectiveness of initiatives and determine whether what other states are doing should be adopted in Maryland.

We are impressed by and fully endorse the diversity of voices and representation required in the Commission's membership by SB 0088. We are also gratified to see the inclusion of a

representative of the Federal Reserve, a significant part of the military that all too often lacks a seat at the table.

The Maryland Military Coalition **strongly supports SB 0088** and asks for a *FAVORABLE* report from the Education, Energy, and the Environment Committee. Establishing this Commission directly supports and enhances the Moore Administration's Year of the Military Families.

The Maryland Military Coalition is a non-partisan organization of 21 Veteran organizations representing over 150,000 Maryland uniformed services men and women and their families -- almost half of the 355,000 veterans in the State.

We want to thank Senator Gile for sponsoring this legislation and her strong support of the uniformed services community in Maryland.

Dear Chair Feldman, and Members of the Committee,

I am writing on behalf of the Army Alliance, a nonprofit advocacy organization whose sole mission is to provide support for one of our major military installations in the State – the Aberdeen Proving Ground (APG). From its founding in 1917, APG has grown into the central research facility for the United States Army, one of a number of such military installations in our State.

The defense industry is one of the most important elements of our State economy. Anchored by major installations such as APG, the industry provides a large number of professional, highly compensated jobs for those who work in uniform and the substantially higher number of private sector individuals who support them. Within the APG ecosystem, for example, there are approximately 2,000 uniform military personnel supported by over 20,000 civilian support staff. APG and its surrounding defense community comprise the largest employer in Northeastern Maryland.

Senate Bill 88 represents a new legislative initiative in support of the defense community in Maryland. By identifying the primary mission of developing *and implementing* (emphasis added) a strategic plan to make Maryland the best State for veterans and military families, the bill clearly states its simple goal. The bill therefore represents, for the first time in memory, a public statement of our collective commitment to constant improvement of State policies to achieve this status. Importantly, the bill also is structured to measure performance by comparing Maryland to other states.

The Army Alliance enthusiastically supports both the object of the bill and the metrics by which its future performance will be measured. We respectfully request a favorable report on Senate Bill 88.

Testimony in Support of SB0088 - Maryland Commission on Veterans and Military Families

Mr. Chair, Madame Vice Chair, and Members of the Senate Education, Energy, and the Environment Committee:

SB0088 establishes the Maryland Commission on Veterans and Military Families, which will be staffed by the Maryland Department of Veterans Affairs (MDVA). The commission must (1) study and make recommendations for developing and implementing a statewide strategic plan to make Maryland the best state for veterans and military families, including legislative and budgetary recommendations and (2) identify key performance indicators to assess the quality of life for veterans and military families in Maryland relative to other states. The commission must report its findings and recommendations to the Governor and the General Assembly by December 1, 2024.

Background

As Governor Moore declared, 2024 is the year for military families in Maryland. As a longtime advocate for military families and the spouse of a 24-year veteran of the U.S. Army, I am elated by this announcement. In collaboration with the Administration including Department of Veterans Affairs Secretary Anthony Woods, I am proud to sponsor key bills aimed at providing tangible support for Maryland veterans and military families. One significant initiative is the renaming of the Maryland Department of Veterans Affairs to the Maryland Department of Veterans and Military Families to better reflect the agency's mission. Additionally, I am sponsoring a bill to designate military status, including as a military spouse, a protected class for hiring purposes. The combined impact of these bills, alongside the one currently under consideration before this Committee, significantly advances the realization of our shared vision: positioning Maryland as a leader among military-friendly states.

An integral aspect of bringing this vision to life is the establishment of a framework where stakeholders can converge, exchange ideas, and outline a strategic course for both the Administration and the General Assembly. This includes developing tangible steps needed to make Maryland an attractive place to live and work for veterans and military families. That's what SB0088 is all about.

Solution

SB0088, which is based on a bill passed into law by Virginia and made at the request of Secretary Woods, would:

- Create a commission comprised of:
 - Members of the General Assembly
 - o The Secretary of Veterans Affairs, or the Secretary's designee;
 - o The Adjutant General, or the Adjutant General's designee;
 - The chair of the Maryland Veterans Commission, or the chair's designee;
 - o The chair of the Maryland Veterans' Home Commission, or the chair's designee;
 - The chair of the Maryland College Collaboration for Student Veterans Commission, or the chair's designee; and
 - Representatives that advocate on behalf of women veterans and members of the Armed Forces (not including the National Guard).
- Study and make recommendations for developing and implementing a statewide strategic plan to make Maryland the best state for veterans and military families, including legislative and budgetary recommendations.
- Identify key performance indicators to assess the quality of life for veterans and military families in Maryland relative to other states.
- Report its findings and recommendations to the Governor and the General Assembly by December 1, 2024.

Per the Fiscal Note, SB0088 has a marginal one-time expense to the state. However, the Fiscal Note makes clear that if the Commission completes its work after submitting its report (as expected), the contractual position may terminate earlier, and expenditures may be reduced.

For these reasons, I respectfully request a favorable report on SB0088.

Dear Chair Feldman:

On behalf of the Maryland Hospital Association's (MHA) 62 member hospitals and health systems, we appreciate the opportunity to comment in support of Senate Bill 88.

Maryland hospitals are experiencing historic workforce shortages, with one in every five nurse positions vacant. A 2022 <u>GlobalData</u> report estimates a statewide shortage of 5,000 full-time registered nurses and 4,000 licensed practical nurses. Without intervention, shortages could double or even triple by 2035. MHA's <u>2022 State of Maryland's Health Care Workforce report</u> outlines a roadmap to ensure Maryland has the health care workforce it needs now and into the future.

The report recommends Maryland leverage the state's military bases by launching a "Green to Blue" campaign to help discharged and retired military personnel with caregiver experience work in hospitals. We must invite every qualified health care worker to join the workforce. This includes our service members who have valuable training and experience. Easing the transition to working in a civilian capacity would benefit the entire health care system.

Senate Bill 88 would create a Commission to develop and implement a strategic plan to make Maryland an attractive state for veterans and military families. We recommend adding a representative with experience in workforce development, such as a member of the Governor's Workforce Development Board, and a representative with experience in health care careers and/or education. We also suggest the Commission explore how to reduce barriers to education and careers to help service members and their families transition into civilian roles. This is particularly important for careers in high-need industries like health care.

This bill could help ensure Maryland does not lose qualified health care workers with valuable experience to neighboring states.

For these reasons, we request a *favorable* report on SB 88.
