SB 364 Election Law – Casting General Election Ballot in Multiple States – Prohibition

Chair Feldman, Vice Chair Kagan, and members of the Senate Education, Energy, and the Environment Committee

Senate Bill 364 will prohibit a person from willfully and knowingly casting a ballot in the general election in more than one state. A person who violates the prohibition is guilty of a misdemeanor and subject to a fine of up to \$5,000 and/or imprisonment for up to five years.

This was requested in the past by the Carroll County Board of Election, this legislation is based on a 2018 case where it was discovered that a Westminster, MD man, Jeffrey Hartman, had voted nine times in both Maryland and West Virginia beginning in 2006. Mr. Hartman was prosecuted in West Virginia and sentence to 30 days in jail, one year of probation, and order to pay \$100 in court costs. Mr. Hartman should have also been charged in Maryland. This bill simply fixes a loophole in our law.

Senate Bill 364 will add voting in two states to the list of voting violations already listed in the Election Law Article and allow for proper enforcement. I respectfully request a favorable report on Senate Bill 364.

Another Voting Fraud Conviction Obtained in West Virginia

Charleston, W.Va.— Secretary of State Mac Warner has announced that another conviction for voter fraud has been secured by his office.

Jeffrey Hartman, 73, of Westminster, Maryland, plead guilty to illegal voting in the Morgan County Magistrate Court on Tuesday. The investigation, conducted by West Virginia Secretary of State Investigator Gary Harmison, revealed Hartman was registered to vote in both West Virginia and Maryland. Hartman had cast ballots nine times in both states since 2006.

Hartman was sentenced to 30 days in jail, suspended for one year of probation and ordered to pay a \$100 fine and court costs.

The League always testifies in favor or in opposition to a bill when we have an adopted position or principle to do so. Understandably, we have not adopted a position that prohibits passing laws about things that are already prohibited by law.

Note that SB 364 proposes enacting a prohibition against something that's <u>already</u> <u>illegal</u>. See Title 52 of the **U.S. Code (Voting and Elections)**, §10307:

(e) Voting more than once:

(1) Whoever votes more than once in an election referred to in paragraph (2) shall be fined not more than \$10,000 or imprisoned not more than five years, or both.

(2) The prohibition of this subsection applies with respect to any general, special, or primary election held solely or in part for the purpose of selecting or electing any candidate for the office of President, Vice President, presidential elector, Member of the United States Senate, Member of the United States House of Representatives, Delegate from the District of Columbia, Guam, or the Virgin Islands, or Resident Commissioner of the Commonwealth of Puerto Rico.

In addition, as the bill itself shows, §16-201 of the **Maryland Code of Election Law** already says:

(a) A person may not willfully and knowingly: ...

(2) vote more than once for a candidate for the same office or for the same ballot question;

(3) vote or attempt to vote more than once in the same election, or vote in more than one election district or precinct;

This bill sends the erroneous message that voting in multiple states is a common practice that needs to be addressed in new legislation. In addition, it risks creating conflict in the applicable law. We urge you to reject this bill and issue an unfavorable report.
