Senate Bill 1035: Focusing Federal Career and Technical Education Act Funds on Blueprint School-to-work Apprenticeship Goals Act

Date: March 6, 2024

Position: Support

Disability Rights Maryland (DRM) is the protection and advocacy organization for the state of Maryland; the mission of the organization, part of a national network of similar agencies, is to advocate for the legal rights of people with disabilities throughout the state. Over the years, DRM has focused significant effort on both representation of older students with disabilities who are preparing to exit the school system and on addressing through policy work, the systemic barriers that have prevented many students with disabilities from accessing vocational and technical programs that would prepare them for successful careers. DRM supports Senate Bill 1035, which would require the State Board of Education to collaborate with the Career and Technical Education Committee (CTE) to develop and implement the Carl D. Perkins Career and Technical Education Act.

Senate Bill 1035 would require the State Board of Education to provide the CTE committee with its proposed strategy and priority for funds received in accordance with the Carl D. Perkins Career and Technical Education Act. The CTE will be required to approve the State Board of Educations plans before they are able to be implemented. Additionally, the CTE will be given the power to allocate funds directly, in accordance with the Carl D. Perkins Career and Technical Education Act.

The purpose of the Carl D. Perkins Career and Technical Education Act is to ensure that students have access and opportunity to engage in career programs of study that (1) align to high-skill, high-wage and/or in-demand careers, (2) lead to earning industry-recognized and/or postsecondary credentials that will allow entrance and/or advancement in a specific cluster; and (3) provide career-based learning experiences that require the application of academic and technical knowledge and skills in a work setting. By providing the CTE Committee with the power to both oversee how funds are being implemented and the power to actively distribute funds itself, the CTE Committee will be poised to better implement strategies to achieve the goals set forth by the Carl D. Perkins Career and Technical Education Act.

All students will benefit from a more effective implementation of strategies to achieve the goals set forth by the Perkins Act. However, students with disabilities are poised to see an immense impact from the expanded availability of effective transition services and opportunities to prepare for life after high school. Therefore, it is not only imperative to prioritize the inclusion of students with disabilities in receiving these resources but also as a voice dictating the method and strategies by which these resources are put in practice. In the State of Maryland and across the country, students with disabilities

have had difficulty accessing the same CTE programs provided to their general education peers.¹ The National Center for Learning Disabilities states that:

"When students with disabilities have access to and the supports needed to thrive in highquality CTE programs, the outcomes are promising. In general, participation in CTE courses has been tied to a positive impact on wages, and concentrated CTE participation improved graduation and employment for students with physical and learning disabilities."²

Given that the data supports positive outcomes from CTE enrollment by students with disabilities, ensuring access to CTE programming for *all* students must be a priority through the implementation of Senate Bill 1035. The additional oversight and guidance for funding constructed by this legislation, creates an important opportunity for prioritization and inclusion of students with disabilities that must not be ignored. For these reasons, DRM supports SB 1035.

I am submitting this testimony in favor of SB1035 on behalf of the Maryland Legislative Coalition. The Maryland Legislative Coalition is an association of activists - individuals and grassroots groups in every district in the state. We are unpaid citizen lobbyists, and our Coalition supports well over 30,000 members.

The Focusing Federal Career and Technical Education Act Funds on Blueprint School-to-Work Apprenticeship Goals Act aims to enhance career and technical education (CTE) by aligning federal funds with the goals outlined in the Blueprint for Maryland's Future. To do so, the State Board of Education will collaborate with the Career and Technical Education (CTE) Committee to develop a plan that aligns with the Blueprint's school-to-work apprenticeship goals while our Department of Education will administer the funds from the Carl D. Perkins Career and Technical Education Act

For fiscal year 2024, Maryland has been allocated \$16,621,068 in funding through this grant. The purpose of this program is to support and expand local CTE programs, enhance Maryland's CTE system, and improve student outcomes. By aligning federal funds with the Blueprint's vision, Maryland aims to create a robust and responsive CTE system that benefits students, employers, and the state's economy.

Our Coalition worked hard to get the Blueprint for Maryland's Future passed to transform Maryland's education system into a world-class model, benefiting students, educators, historically underserved communities, and the state's economic competition. However, The Blueprint initiative is facing a budget shortfall. In 2023, the Department of Legislative Services reported that the Blueprint Fund is projected to have a budget shortfall by 2027 of approximately \$200 million. Therefore, we need to optimally manage our resources, including the CTE grants, for the best results.

The alignment of CTE funds with the Blueprint goals called for in SB1035 facilitates the best results for our students and employers. We support this bill and recommend a **FAVORABLE** report in committee.

On behalf of the member families of the Maryland Farm Bureau, I provide written testimony in favor of SB1035. This bill would require the State Board of Education to collaborate with the Career and Technical Education (CTE) Committee to develop and approve a certain plan to administer the Carl D. Perkins Career and Technical Education Act beginning in fiscal year 2025.

Maryland Farm Bureau is extremely supportive of Agriculture Education programs within the state and hopes to see the programs continue to grow and flourish. The Future Farmers of America (FFA) also falls under the Agriculture Education programs in most schools that offer FFA as an intraarticular activity. Under the Blueprint, Agriculture Education and FFA would fall under the Career and Technical Education Committee. By implementing a start date and plan to administer the Carl D. Perkins Career and Technical Education Act would give those programs the confirmation needed to continue moving forward.

MDFB Policy: We support the career technology education program in Maryland. We recommend that local boards of education, with state support, expand Maryland State Department of Education (MSDE) approved agriculture education programs in middle schools and high schools. We strongly recommend that the State board of education institute a more comprehensive agriculture education program. We highly recommend MDFB have representation on boards and commissions at the Maryland State Department of Education, and the Department of Labor especially in Career & Technology Education. We support the Environmental, Agriculture & Natural Resources Pathway (Certified Agriculture Education Program). The program should include all three rings of the Agriculture Education model (classroom/laboratory instruction, FFA, and Supervised Agricultural Experiences) and be fully funded and staffed to ensure all local and state programs are viable.

EXPLANATION:

The Maryland State Board of Education (State Board) and the Maryland State Department of Education (MSDE) respectfully submits this letter to **support** Senate Bill (SB) 1035 *Focusing Federal Career and Technical Education* (*CTE*) *Act Funds on Blueprint School-to-Work Apprenticeship Goals Act,* **with amendments**. The bill requires the State Board, MSDE, and the CTE Committee of the Governor's Workforce Development Board (CTE Committee) to collaborate on the development and approval of the 4-year State Plan for CTE, and to ensure mutual programmatic and fiscal alignment with the federal Carl D. Perkins Act and the Blueprint for Maryland's Future.

After significant discussion with the bill sponsor, the MSDE and the State Board extend their support for SB 1035 with the following agreed-upon amendments:

- 1. On p. 1, line 10, remove "allocate" and insert "review the allocation of"
- 2. On p. 2, change (c)(6) to "collaborate with the CTE Committee to jointly align the plan with the Department's and the CTE Committee's responsibilities detailed in the Blueprint for Maryland's Future, as defined in §5–401 of this article, and the federal act."
- 3. On p. 3, line 7, following "... of this article" insert "and the federal act."
- 4. On p. 3, change (d)(3) to "The Department shall coordinate with the CTE Committee to develop its proposed strategy and priorities for funds received in accordance with the Carl D. Perkins Career and Technical Education Act and be responsive to requests for information by the committee related to the administration of the Carl D. Perkins Career and Technical Education Act."
- 5. On p. 3, change 4(II) to "(II) Before submitting a plan in accordance with subparagraph (i) of this paragraph, the State Board of Education and the CTE Committee shall approve the plan."
- 6. On p. 3, insert "4(III) In the event of a disagreement or dispute arising out of or in connection with the joint approval of the state plan, the Governor shall resolve the dispute."
- On p. 3, change (19) to "Review the Department's allocation of funds received in accordance with the Carl D. Perkins Career and Technical Education Act to ensure the use of funds are consistent with the Blueprint for Maryland's Future, as defined in § 5–401 of this article, and the federal act."

The collaboration between the Maryland State Department of Education (MSDE) and the Career and Technical Education (CTE) Committee on the development of the Four-Year State Plan for Career and Technical Education is essential for aligning CTE programs with workforce needs and ensuring the strategic direction of education in Maryland. This partnership is strengthened and codified as a result of the proposed amendments to SB1035 and will help to ensure the creation of a robust education and workforce pipeline that addresses the dynamic career demands within the state. Through this concerted effort, MSDE and the CTE Committee aim to provide students with the skills and knowledge required for high-wage, high-skill, and in-demand careers, enhancing Maryland's economic growth and competitiveness.

Furthermore, under the federal Carl D. Perkins Career and Technical Education Act, the State Board and MSDE are vested with the authority to administer the Carl D. Perkins grant and oversee all fiscal activities mandated by the federal statute. This critical role includes the allocation of funds, oversight of program quality, and ensuring that CTE programs meet federal requirements. This federal backing not only supports the advancement of high quality CTE programs in Maryland but also ensures that career awareness, career exploration, and academic and career objectives are available across the educational space so that all students have the opportunity to succeed in career, postsecondary education, and life.
