We are grateful for your advocacy on behalf of students, parents, teachers, and, of course, **PRINCIPALS**. We hope you'll give a favorable report for SB598.

# Testimony in SUPPORT of House Bill 1058 – Education - Curriculum Standards – Antihate and Holocaust Education (Educate to Stop the Hate Act) – Education, Energy, and the Environment Committee February 23, 2024


The Jewish Community Relations Council of Greater Washington (JCRC) serves as the public affairs and community relations arm of the Jewish community. We represent over 100 Jewish organizations and synagogues throughout Maryland, Virginia, and the District of Columbia. The JCRC is strongly committed to cultivating a society based on freedom, justice, and pluralism. We work throughout the region to advocate for our agencies that serve the most vulnerable residents and to campaign for important policy interests on behalf of the Jewish community and all Marylanders.

House Bill 1058 requires that the State Board of Education develop curriculum standards and resources for antihate and Holocaust education by January 1, 2025. The Bill applies to elementary, middle, and high school classrooms in all public and nonpublic schools that receive state funding. Additionally, the curriculum would include utilizing historical contexts that have led to contemporary racism and prejudice and the Holocaust. It also will revise the high school history framework to include the contributions of historically disadvantage racial and ethnic groups.

We are living in a time of heightened hate where every marginalized community seems to be under attack. The spike in racism, antisemitism, Islamophobia, and anti-Asian hate is unprecedented. House Bill 1058 is a critical piece of legislation to combat such hatred. Students of all ages need to understand history, including bigotry and prejudice, so that horrific events of the past - like the Holocaust - will never be repeated. In the last few months, the Jewish community has seen a 361% increase in antisemitic incidents compared to the same period a year ago. At the JCRC, it seems like a week doesn't go by without a call about vandalism at a synagogue, bullying on a playground, or a swastika found on a school desk. It's unacceptable and has to be addressed.

The Educate to Stop the Hate Act is not a panacea, but it certainly is a necessary step to help stem the tide and fight back against the harmful impact of hatred which undermines the very fabric of our society. HB 1058 is an opportunity to attack all forms of hatred. It's an opportunity we can't afford to miss. For these reasons, we ask for a favorable report on HB 1058.

The Maryland Association of Boards of Education (MABE) supports Senate Bill 558. This bill will enhance the composition of the Maryland State Board of Education by adding a member representing school principals.

MABE supports this addition in order ensure the representation of school administrators responsible for leading the delivery of teaching and learning in the 1,400 public schools throughout the State. MABE notes that the association historically opposed adding members to the State Board, including representatives from teachers' associations and parents' associations. However, since these additions were enacted in 2019, MABE now supports the addition of a school principal as an appropriate complementary voice and perspective on the State Board of Education.

MABE firmly believes that the role of a full complement of qualified school-based staff will be pivotal to the successful implementation of Blueprint for Maryland's Future. School Principals are leading the day-to-day operations of schools, and all that entails, but are also doing so in accordance with the comprehensive school-based reforms mandated by the Blueprint.

To be clear, MABE supports adding a school principal representative on the State Board in order to better inform the Board's state-level policy making on all public education matters. The State Board is responsible for regulations spanning issues such as curriculum standards, assessments, student health, student discipline, special education, student transportation, school meals, among many others. MABE believes that on all of these matters, the principals' voice will be uniquely and highly beneficial in informing the Board's deliberations.

Again, MABE supports the addition of a school principal able to share their expertise and experience working every day with teachers, staff, students, and families toward the ultimate goal of each student learning to love learning and meeting the challenges of attaining college and career readiness.

For these reasons, MABE urges this Committee to issue a favorable report on Senate Bill 558.

The Public School Superintendents' Association of Maryland (PSSAM), on behalf of all twenty-four public school superintendents, **supports** Senate Bill 598.

Senate Bill 598 would add an active, certified principal to the Maryland State Board of Education (MSDE). This bill would require a state-wide election to be held for all active and certified principals in the State, as well as require that the principal member who receives the highest number of votes be appointed to the vacancy by the Governor. Additionally, Senate Bill 598 provides parameters for the voting capacity and term length of the principal member.

PSSAM understands amendments may be forthcoming from the sponsor and the State Board and certainly yields to the wisdom and direction of those discussions and decisions by this Committee.

PSSAM appreciates the goal of this legislation to allow for the appointment of a principal member to the Maryland State Board of Education. Maryland's superintendents have found value in adequate representation of other populations through elections and appointments to the State Board, such as teacher and student members. PSSAM sees this legislation as a natural extension, as well as a vehicle for adequate representation of school leadership, which is essential for equitable outcomes in education.

For these reasons, PSSAM supports Senate Bill 598 and urges a favorable committee report.

The Maryland State Education Association supports, with an amendment, Senate Bill 598, which would alter the membership of the State Board of Education to include a school principal as a member and provide for the initial term of the principal member.

MSEA represents 75,000 educators and school employees who work in Maryland's public schools, teaching and preparing our almost 900,000 students so they can pursue their dreams. MSEA also represents 39 local affiliates in every county across the state of Maryland, and our parent affiliate is the 3-million-member National Education Association (NEA).

Including a teacher and principal on the State Board of Education provides valuable insight into the daily operations and needs of Maryland's schools. However, we continue to lack the perspective of a non-supervisory, non-certificated education support professional, such as a paraeducator, food service staff member, or one of the many other roles that keep our schools functioning. Such a member would bring a unique and essential perspective to the State Board's role in the oversight and regulation of education policy.

We therefore urge an amendment to add an elected non-supervisory education support professional to the State Board with the same voting rights and restrictions as the teacher member and principal member. The education support professional member should be elected in a manner and to a term comparable to the teacher member, with voting made available to all non-supervisory, noncertificated school employees in the state.

With the inclusion of the proposed amendment, we urge the Committee to issue a Favorable Report on Senate Bill 598.

#### Chair Feldman and Members of the Senate Education, Energy, and Environment Committee,

The Maryland State Board of Education (State Board) would like to share a few proposed amendments to **SB 598**, which would add an additional member to the State Board who is required to be a certified, active school principal in Maryland, and who would be selected through an election conducted by the Maryland State Department of Education (MSDE).

The State Board appreciates the intent of this bill to ensure that the principal voice is well represented on the board. We concur that the experience, knowledge, and perspective of an active principal would be valuable. We are fortunate to have current members of the State Board who have served as principals in our public schools.

We have some concerns with continued growth of the size of the State Board, which is already one of the largest <u>state boards of education</u> in the United States at 14 members. Additionally, we want to ensure that the Governor retains the flexibility to appoint members of the State Board who have a wide array of experiences and skill sets.

The State Board does not oppose an active, certified principal serving as a member of the State Board and requests that the committee consider the following amendments that would allow for that flexibility without increasing the size of the State Board:

- 1. On page 1, line 16, page 2, line 8, and page 4, line 13, remove the increase in the number of regular members of the State Board from 13 members to 14 members.
- 2. On page 3, lines 2-3, strike "who received the highest number of votes after an election of principals in the State", and strike lines 4-8 in their entirety.
- 3. On page 4, lines 13-18, strike the suggested uncodified language in its entirety and provide that the principal member of the State Board shall begin their term on July 1, 2025.

The State Board requests that the committee consider this information and suggested amendments to **SB 598**.
