### Delegate Dana Stein Testimony in Support of HB 993 Commemorative Weeks – Maryland Climate Education Week

Each year, the Maryland Commission on Climate Change issues a report with recommendations for the legislature and state agencies to consider. In Fall of 2023, the Commission issued a report with 27 recommendations. One of the recommendations, from the Workgroup on Education, Communication and Outreach (ECO), was to declare the first week of April, which is Earth Month, as "Climate Education Week."

This declaration would provide an opportunity for state agencies, local governments, and private organizations to provide educational opportunities on climate issues. The ECO workgroup will provide free online resources for teachers and instructors to use. The idea is to encourage anything from short discussions in the classroom to day-long or half-day seminars, if desired.

An example of the type of activity envisioned is a climate teach-in, one which is taking place from April 1 to 7 in schools around the State. This teach-in will focus on education on climate change and solutions.

I hope you will give HB 993 a favorable vote.

The Alliance for the Chesapeake Bay ("the Alliance") respectfully requests a favorable report for House Bill 993 - Commemorative Weeks - Maryland Climate Education Week, which would establish the first week of April as a time to encourage all Marylanders to participate in climate educational activities and take action toward the State's climate commitment.

The Alliance restores the lands and waters of the Chesapeake Bay watershed. Our collaborative and action-oriented approach delivers on-the-ground solutions, technical assistance, and builds capacity to achieve healthier lands and waters.

In Maryland, the Alliance collaborates with all four of the state's Historically Black Universities (HBCUs) to increase student exposure to green careers through experiential learning, workforce development opportunities, and jointly developed restoration projects. Since 2021, the Alliance has coordinated and co-planned with our Maryland HBCU partners over 14 seminars reaching 300+ students. We identify each Chesapeake Bay-related seminar topic based on the issues of most importance to the student body. Climate change and its intersection with environmental justice are consistently top of the list. In particular, we see this interest within the Bowie State University community, with whom we hold our most mature HBCU partnership. For example, together we hosted a <u>Climate Justice Dinner & Dialogue</u> in 2022 and a Leadership in Climate Action Town Hall as part of the <u>inaugural 2023 Maryland Climate Teach-In</u>.

It is clear to the Alliance that the next generation of Maryland's HBCU graduates and environmental stewards are asking us to prioritize and commit to climate education and action. The establishment of Maryland Climate Education Week would be an impactful way to reaffirm Maryland as a leader in climate change education. It would also signal to these students that the state takes climate change action as seriously as they do. **We urge the Committee to issue a favorable report on HB 993.**

The National Aquarium respectfully requests a favorable report for House Bill 993 – Commemorative Weeks – Maryland Climate Education Week, which would establish the first week of April, at the start of Earth Month, as a time to encourage all Marylanders to participate in climate educational activities and take action toward the State's climate commitments.

The National Aquarium connects people with nature to inspire conservation action; combatting climate change is one of our three overarching goals. We take a holistic approach which encompasses climate mitigation, adaptation, education, and communication. We recognize that not everyone is experiencing climate impacts to the same degree, and climate solutions should prioritize equity and environmental justice. The National Aquarium is committed to achieving net-zero greenhouse gas emissions by 2035. We work with communities and partners throughout the state to implement nature-based solutions that support climate resilience and have decades of experience in translating ocean and climate science. We advocate for policies, like this one, that empower people to learn about and act on climate.

The National Aquarium welcomes 1.2 million visitors and engages thousands of people throughout the country through our public messaging each year. We aim to educate and empower our audience to take meaningful actions to address climate change. Climate change and climate solutions are not discussed as often and as openly as they should be. Research shows that across the U.S., majorities of Americans understand global warming is happening, is driven by human activities, and is causing harm<sup>1</sup>. Most Marylanders support climate policy solutions and think that schools should teach about climate change<sup>2</sup>. However, 65% of Americans report rarely or never discussing climate change in their communities; only 40% of Marylanders say they have at least occasional climate change conversations.

Maryland is a climate leader with a commitment to environmental justice. Our state has enacted some of the most ambitious climate goals in the country, but to achieve these goals we need to talk more about climate change and solutions. We appreciate the work of the Maryland Commission on Climate Change and its efforts to expand climate conversations and applaud Delegate Stein's sponsorship of this bill to ensure that climate education gets the spotlight it deserves for at least one week each year. The time is now: climate impacts will continue to worsen without implementation of existing policies and further action. Broad climate awareness and discussions among Marylanders of all ages and backgrounds will help catalyze community involvement, equitable workforce development, and progress toward a more livable and resilient future. We urge the Committee to issue a favorable report on HB 993.

Mr. Chair and Members of the Committee:

Maryland LCV and the organizations below support HB 993 Commemorative Weeks - Maryland Climate Education Week and we thank Delegate Stein for his enduring leadership on this issue.

HB 993 has a simple premise, to proclaim the first week in April Maryland Climate Education Week, with a projected outsize impact to create the space for students of any age across Maryland to engage in projects, education, and advocacy to raise awareness about climate impacts and solutions.

Declaring "Climate Education Week" is a recommendation in the 2023 <u>Maryland Commission on Climate</u> <u>Change Annual Report</u>. The Education, Communications, and Outreach (ECO) Working Group "recommends that the Maryland General Assembly proclaims the first week of April, coinciding with Earth Month, as "Climate Education Week." This annual declaration would provide a unique opportunity for state agencies, county and municipal governments, and private organizations to come together in celebration and education. During Climate Education Week, schools, colleges, universities, and various institutions can host exceptional events, workshops, and activities that focus on climate education and action. The ECO is fully committed to providing abundant resources to assist all Marylanders who wish to participate in and celebrate this week, fostering a culture of climate consciousness throughout our state. By implementing these recommendations, our state will make significant strides toward enhancing public awareness, education, and engagement in climate action, ultimately contributing to our shared goals of reducing [greenhouse gas] GHG emissions and building a more equitable, sustainable, and resilient future for all Marylanders."

The first week in April is a strategic decision, as it is <u>Worldwide Climate and Justice Education Week</u> and National Public Health Week, which usually has a dedicated <u>daily theme</u> of climate change because of the recognized impacts on human health and wellbeing. An example of information provided is the <u>Climate and Health Youth Education Toolkit</u>. Bringing these international and national themes to Maryland gives us the opportunity to join a global movement in supporting a healthy climate and environment for future generations.

Youth across the country face ecoanxiety in the face of a changing climate, with <u>demonstrated</u> <u>improvements in mental health when they are part of the solution</u>. Education is the universal key to unlocking a student's potential.
