Senate Bill 347: Medical Cannabis—Employees in Health Care Settings Caring for Qualifying Patients

On behalf of the Maryland Dispensary Association (MDDA) Senate Finance Committee Support February 15, 2024

The Maryland Dispensary Association (MDDA), formerly the Maryland Medical Dispensary Association (MDMDA), was established in May, 2017 in order to promote the common interests and goals of the Medical Cannabis Dispensaries in Maryland. MDDA advocates for laws, regulations and public policies that foster a healthy, professional and secure medical cannabis industry in the State. MDDA works on the State and local level to advance the interest of licensed dispensaries as well as to provide a forum for the exchange of information in the Medical Cannabis Industry.

The. MDDA has been a consistent supporter of policies that ensure access to medical cannabis for qualifying patients. Senate Bill 347 would allow designated medical personnel to administer medical cannabis to qualifying patients without having to register with the Maryland Cannabis Administration. On behalf of Grow West MD, a cannabis cultivator in Cumberland, Maryland, I would like to express my unqualified support of Senate Bill 347: Medical Cannabis - Employees in Health Care Settings Caring for Qualifying Patients.

The Maryland Medical Cannabis program opened access to patients, with a recommendation from a physician, to purchase cannabis products, and with the passing of the Adult Use program anyone over the age of 21 is now able to join the group. However, there is still a large, overlooked group of people in our communities. I am referring to our senior population living in assisted living facilities who rely on the expert care of staff to meet their needs. Dear Chair Beidle and Committee Members,

The Maryland Department of Health (Department) respectfully submits this letter of concern for Senate Bill 347 (SB) 347 entitled "Medical Cannabis - Employees in Health Care Settings Caring for Qualifying Patients." SB 347 will allow a qualified patient to obtain medical cannabis through medical personnel who are employed by medical agencies and healthcare facilities.

The provisions of SB 347 could jeopardize receipt of federal funds and certification through the Centers for Medicare & Medicaid Services (CMS) for healthcare facilities and certain community providers. Currently, under federal law, cannabis remains illegal while many states including Maryland have legalized it in certain forms. The conflict between state and federal law places healthcare facilities and community providers in a unique situation as the use or administration of cannabis within the enumerated healthcare facilities could violate conditions of participation with CMS, impacting certification, and possibly leading to loss of federal funding.

As a result, the Department is concerned that SB 347 could jeopardize the Department's CMS certification and federal funding for its operated healthcare facilities¹, as well as Medicaid waiver funding for home and community based services. In part, federal funding for certain residential provider services offered under the State's Medicaid waiver programs through the Developmental Disabilities Administration may be impacted. Loss of Federal funding could

result in an additional General Funds burden for the Healthcare System and for the Department generally. Additionally, individual healthcare providers in the State who bill CMS for services provided under Medicare, Medicaid, or related programs are also subject to these conditions of participation and would jeopardize their own federal funding.

Letter of Information

The Arc Maryland is a statewide disability advocacy organization that is dedicated to the preserving the rights, and improving the quality of life, of individuals with intellectual and developmental disabilities.

<u>The medical use of Cannabis and cannabinoids has been shown to have beneficial health impacts for some people with intellectual and developmental disabilities</u>. Medical Cannabis can effectively be used in treatment to reduce anxiety, reduce pain, increase appetite, control inflammation and muscle spasms, and help manage seizures. For these reasons, medical cannabis is referred to as a miracle treatment by some families connected to The Arc and we are hopeful for its expanded availability and use to address behavioral and physical health needs.

Although cannabis was legalized in Maryland this past year, cannabis continues be illegal under federal law and is categorized as a Schedule 1 controlled substance.

Providers like The Arc deliver Home and Community Based Services under a Medicaid 1915(c)Waiver. The Waiver allows people with developmental disabilities to receive institutional-level services in their home communities, and allows the state to draw a federal funding match on state funds utilized for these critical services.

<u>Prior to passage of this bill, we hope there is a thorough analysis into how the authority, created through this legislation, and activity to administer medical cannabis may impact our ability to receive federal funding matches.</u>

Dear Chair Beidle -

The Maryland Cannabis Administration (MCA) is submitting this letter of Information for Senate Bill 347 – Medical Cannabis - Employees in Health Care Settings Caring for Qualifying Patients (SB0347).

SB0347 creates a pathway for designated personnel at certain medical facilities to administer medical cannabis to patients receiving inpatient treatment. Delivery of medical cannabis to these facilities is already authorized through the MCA's medical cannabis regulations, under COMAR 10.62.30.04 (E) and (F), below:

E. Only a qualified patient or caregiver, or a medical facility where the qualifying patient is receiving in-patient treatment, may accept delivery of medical cannabis. F. A licensee or registrant may only deliver medical cannabis to a private home or residence, or a medical facility where the qualifying patient is receiving in-patient treatment.

The MCA believes that the provisions under SB0347 are consistent with these existing regulations, and may expand patient access without creating an additional administrative burden on the MCA, patients, or caregivers. The State currently has over 137,000 medical patients registered and over 8,000 registered caregivers. SB0347 requires the registered caregiver of the patient to provide the designated medical personnel with the cannabis or cannabis product for administration, in a manner that is prescribed by the patient's certifying provider.

Under the current medical cannabis program, a registered caregiver may only serve as a caregiver for up to five patients, and a patient may not have more than two caregivers¹. SB0347 makes explicit that the designated medical personnel established under this bill do not fall under the existing patient, caregiver, or certifying provider relationship.
