At some point, maybe 20 minutes into the movie, the captions froze in place. I went downstairs to ask for a replacement. After receiving a replacement, re-entering the theater, and returning to my seat, I realized that the second device was even worse than the first. It was even less stable and kept sliding away from me instead of staying in place. When I managed to get it to stay, the captions froze on the top, and half of the remainder of the captions appeared on the bottom. I waited in line to get a replacement. By the time it was my turn to have my needs addressed, I had already missed about 45 minutes of the movie, so I asked for a refund. Because I didn't personally purchase the ticket (my sister did), they gave me a re-admit pass for another movie in any AMC theater.
