Many international film festivals, including Cannes and Venice, already include open captions or subtitles in multiple languages on the screen. Even international audiences in many countries loved to watch open-captioned movies or subtitled movies being subtitled in multiple languages on the screen and they were never distracted by either open-captioned movies or subtitled movies. They are smarter than US people.

A study found that only 22% of viewers find subtitles more distracting than helpful, from which it can be inferred that over three-quarters of potential viewers don't find subtitles distracting. The study also found that:

- * 74% of viewers say subtitles help them comprehend the plot.
- * 68% say subtitles help hold their attention on the screen.
- * 55% say they often have to rewind after missing things said when they don't use subtitles.

It would be good for the US because there are many foreign-speaking people, people with hearing loss including military personnel, deaf people whose first language is ASL, people with disabilities, elders with hearing loss, and a general audience who want to understand English rather than having hard times hearing strong accents prefer open captioning. Why wait so long to make movies open captioning without hassles? We know that It is not costly and it won't affect the movie theater business. The inclusion of open captions in international film festivals and movies in many countries demonstrates that it is indeed a feasible and widely accepted practice.
