The Office of the Attorney General (OAG) urges the Judicial Proceedings Committee to give Senate Bill 100 – Criminal Law – Organized Retail Theft sponsored by Senator Ronald Watson a favorable report. Senate Bill 100 allows all thefts committed as part of "one scheme or continuing course of conduct" to be "joined and prosecuted in any county in which any of the thefts occurred." Senate Bill 100 also creates a new criminal offense called "organized retail theft" which would cover "the commission, either alone or in concert with one or more other persons, of a series of thefts of retail merchandise form one or more retail merchants over a 90-day period."

Senate Bill 100 defines organized retail theft as "the commission, either alone or in concert with one or more other persons, of a series of thefts of retail merchandise from one or more retail merchants." Organized retail theft/crime is a serious public safety issue in Maryland and is difficult to curb due to the manner in which theft is prosecuted in Maryland.

Currently, Maryland has a consolidated theft statute. Unlike other states that have separate offenses for larceny, shoplifting, possessing stolen property, etc., Maryland considers all of those

crimes simply "theft" under Criminal Law Article 7-104. The penalty for theft (both in terms of jail time exposure, as well as whether the crime is a misdemeanor or felony) is determined by the value of the items taken. Under current law, if someone commits multiple thefts in one county as part of "one scheme or continuing course of conduct," then "the value of the property or services [taken] may be aggregated in determining whether the theft is a felony or a misdemeanor." For example, if someone commits nine \$200 thefts in one county as part of the same scheme, what would normally be nine misdemeanors could be considered one felony theft scheme.

Senate Bill 100 would allow all thefts committed as part of "one scheme or continuing course of conduct" to be "joined and prosecuted in any county in which any of the thefts occurred." For example, if an individual commits nine \$200 thefts as part of the same scheme (three in Montgomery County, three in Prince George's County, and three in Charles County), then what would under current law be three misdemeanors each in three counties, under this bill could be one felony theft scheme consolidated in one county.

For the foregoing reasons, the Office of the Attorney General urges a favorable vote on **Senate Bill 100.**

Dear Chairman Smith, Vice Chairman Waldstreicher, and Members of the Committee:

I am writing to show my strong support for Senate Bill (SB) 100. I am the State's Attorney's for Prince George's County.

The Special Prosecutions Unit (SPU) for our Office prosecutes, among other offenses, organized financial and economic crimes. These crimes usually involve predatory activities such as identity theft, computer fraud, and so-called Ponzi schemes. The recent spate of events involving systematic looting of our region's retail outlets by identifiable, organized crews, often wielding firearms, and other deadly weapons, presents an additional insidious challenge to our efforts to enforce the law.

The provisions proposed under SB 100 would provide a powerful tool for prosecutors to use in confronting this emerging challenge by allowing individual instance of retail theft committed in furtherance of an organized criminal scheme to be joined in one prosecution, even if the perpetrator committed such crimes in multiple Maryland jurisdictions. Otherwise, perpetrators are able to hide behind the legal fiction that each of their retail looting crimes somehow stand alone, without connection to the organized criminal enterprise of which each of these crimes is the essence.

For the foregoing reasons, I respectfully urge a favorable report, and ultimately passage, on SB 100.

The Office of the Prince George's County Executive **SUPPORTS SB 100 - Criminal Law - Organized Retail Theft**, which establishes the offense of "organized retail theft" of property with an aggregate "value" exceeding \$1,500. A violation of this prohibition is a felony punishable by imprisonment for up to five years and/or a \$5,000 maximum fine. A person who violates this prohibition must (1) restore the property to the owner or (2) if unable to restore the property to the owner, pay to the owner the full value of the property. A conviction for organized retail theft merges into a conviction under the general theft statute (§7-104 of the Criminal Law Article) for the purposes of sentencing where the two convictions arise from the same acts or transactions. The bill also clarifies the venue for prosecution of a case involving multiple thefts in multiple counties committed by the same person under one scheme or continuing course of conduct.

Unlike amateur theft or spontaneous shoplifting by people with little to no premeditation, organized retail crime entails careful planning and high-level coordination. Trade group RILA says organized retail crime cost US retailers nearly \$70 billion in 2020 and notes that things have worsened since the COVID-19 pandemic when stores were short on staff.

We at the local level have been grappling with how best to fight this growing problem, but current Maryland law does not do enough to deter organized retail theft. **SB 100** will correct this by allowing all thefts committed as part of "one scheme or continuing course of conduct" to be "joined and prosecuted in any county in which any of the thefts occurred." This will reduce repeat offenders who are using the law to their advantage.

For the reasons stated above, the Office of the Prince George's County Executive **SUPPORTS SB 100** and asks for a **FAVORABLE** report.

### Senate Bill 100—Criminal Law- Organized Retail Theft: Support

Chair Smith, Vice Chair Waldstreicher and Members of the Judicial Proceedings Committee,

ICSC respectfully asks for your support on Senate Bill 100, *Criminal Law- Organized Retail Theft.* ICSC is the member organization for the advancement of the Marketplaces Industry, made up of shopping centers, malls and main streets, and the commerce they drive and the communities they create. Our member network includes property owners, developers, financial institutions, professional service providers and, importantly, shotting center tenants such as retailers, restaurants, gyms, childcare providers, and health centers. In Maryland, 1900 marketplaces with over 525,000 jobs, make up nearly 14% of the State's job force. For over 65 years, ICSC has promoted and elevated the marketplaces and spaces where people shop, dine, work, play and gather as foundational and vital ingredients to everyday life. On behalf of our Maryland membership, we are submitting the comments below that focus on our concerns with the currently proposed building energy performance regulations.

Organized Retail Crime (ORC) is not petty shoplifting. It is coordinated, sophisticated, and targeted retail theft, usually carried out by organized criminal networks, where substantial quantities of high-demand products are stolen and re-sold, often on online marketplaces. These organizations recruit participants, enforce quotas, and use their profits to fund other illicit activities.

According to the National Retail Federation; Buy Safe America Coalition, ORC accounted for:

- > \$100 Billion in inventory loss in 2022 alone
- \$15 Billion loss to federal and state governments in personal and business tax revenue, not including lost sales taxes
- > An 81% increase in retailers reports of violence and aggression
- \$500 of additional cost to the average American Family
- A 26.5% increase in organized theft incidents in 2021

Organized retail crime impacts everybody — from retailers and retail employees to shoppers, community residents — as well as the entire economy. While ORC groups most often target large retailers, the economic impact of their activity is significant and extends far beyond those immediately involved. ORC is on the rise and store fronts, supply chains, and businesses' bottom lines are being negatively affected. Our industry must join with others to ask lawmakers at every level of government to take further action to fight ORC.

From a Maryland perspective, it is easy to extrapolate the impact of ORC given estimated sales tax revenue generated per establishment:

- ➢ General Merchandise \$4,437,890
- ➢ Food and Beverage (Grocery) \$2,044,207
- Apparel \$363,147

Drug Stores - \$1,024,020

ORC groups are discerning in their selection of targets and primarily favor large national retailers, big-box retailers, and cargo shipments, largely targeting everyday consumer goods. In areas specifically targeted, ORC leads to forcing many stores that anchor neighborhoods and community shopping centers to leave, costing localities jobs, state and local tax revenues and ultimately the character of the places we live.

In 2023, 7 states across the United States, enacted legislation that would work to address prosecutorial issues related to ORC: including Alabama, Kansas, Nevada, New Mexico, North Dakota, Oregon and Virginia.

In the opinion of the Maryland members of ICSC, we urge the General Assembly to also take action. We urge a favorable report of Senate Bill 100.


