Even then, he gets a headache looking at the captions through the glasses. Open captions do not harm anyone- they only benefit. They benefit even people who are not deaf or hard of hearing. They enhance literacy for younger people. They help allow hearing people to catch words or phrases that they may have missed in the movie due to loud noises from special effects and such. The films are already coded with captions, so it doesn't cost the theater anything to just turn them on and have them displayed on the screen.
