Also, after the movie, it's become a running joke among our family members: we all always have red lines on the bridges of our noses and sides of our faces from the glasses. That's how uncomfortable they are...especially if you have to wear glasses already.

While these may seem like minor inconveniences, they do add up. We want to just be able to walk into the movie theater, sit down, and watch the film like any other theatergoer, deaf or hearing. We don't want to have to do additional work. We don't want to have to sign a piece of paper with our personal addresses and names so that others who sign the paper can also see where we live or who we are. We want to simply have an equitable movie theater experience — and for that to happen, open captioning needs to be the norm. In fact, many times when I go to open captioned films, there are more hearing people than deaf — which means they enjoy it, too.
