Dear Chair Smith and Committee Members:

On behalf of LifeBridge Health's Center for Hope we thank you for this opportunity to provide information on Senate Bill 668. Center for Hope provides intervention and prevention for: child abuse, domestic violence, community violence, and elder justice for survivors, caregivers, and communities. At LifeBridge Health, we recognize the devastating impact of violence in our communities, and the growing number of victims of all ages. This is a public health issue and we need to help our communities by partnering with the people in them, to break the cycle of violence. We need to partner alongside community leaders, stand shoulder to shoulder with parents and caregivers, and help provide survivors of violence and crime with support and healing, in order to grow a collective hope for a better city and a better world.

At Center for Hope's medical suite, we see children of all ages from Baltimore City and County coming in for initial health visits within five days of removal and entry into foster care. We are so grateful to Comfort Cases and the ability to be able to give each child a bag full of toiletries, hygiene products, new clean pajamas, socks, and comfort items like a stuffed animal, blanket, and a book. Each child is so thankful to receive a bag for their items. Many little ones are excited to tell us what they are going to put inside their bag and show off wearing their new backpack. Several teens have stated they can't wait to use this bag for their items instead of using their school backpack. Other children are just so excited and appreciative to have items they can call their own.

We have seen so many children that had just had their lives flipped upside down and are living with complete strangers to them. Many teens living in hotels with one-to-one mentors while workers are attempting to find placements for them. So many of these children don't have a bag big enough to grab shoes, underwear, medications, etc. and they come to us for medical exams not wearing any underwear. Many children were not able to bring anything at all with them except for the clothes on their back.

By supporting this bill, you are giving these children and teens a chance to feel human. Children and teens that have been through this traumatic event don't need their lives to be any harder than it already is. By giving each child a bag to carry their belongings from location to location you are treating them like a human, like someone that is important enough to be cared for.

For all the above stated reasons, we request a Favorable report for Senate Bill 668.

The Coalition to Protect Maryland's Children (CPMC) is a consortium of Maryland organizations and individuals formed in 1996 to promote meaningful child welfare reform.¹ **CPMC urges a favorable report on SB0668 - Department of Human Services – Children in Foster Care – Luggage.**

The transition for children entering or moving within the foster care system is a period marked by uncertainty, anxiety, and often, a sense of loss. For many of these children, the process involves moving their belongings in trash bags, which, albeit unintentionally, sends a disheartening message about their worth and stability in life. Providing new luggage is a seemingly small gesture that can significantly impact these children's self-esteem and sense of security.

SB0668 would establish and maintain a decentralized supply of new luggage to be used to transport the personal belongings of a child in foster care and require the Department to provide new luggage to a child who is being removed from a household under certain circumstances. More than just a policy change; it is a statement by our state that we see and value each child within the foster care system. This bill acknowledges the challenges faced by these children and takes a step towards alleviating the additional burden of feeling like their belongings, and by extension, their lives, are disposable.

The importance of this bill extends beyond the physical luggage. It is about instilling a sense of dignity and respect in these young individuals. It tells them that they are worth the investment, that their comfort matters, and that they are not alone during this tumultuous time in their lives. Such positive reinforcement is crucial for their emotional and psychological well-being. Moreover, the implementation of SB0668 can serve as a model for compassionate care in foster systems nationwide, showcasing our state's commitment to enhancing the foster care experience and setting a precedent for others to follow.

In conclusion, we urge you to consider the profound impact that passing SB0668 will have on the lives of countless children within our foster care system. Let us come together to make a meaningful difference in their lives by providing them with the dignity of new luggage during their transitions. Your support for this bill is a step towards reaffirming our collective responsibility towards the well-being of all children in our care.

For the aforementioned reasons, the Coalition to Protect Maryland's Children urges the House Judiciary Committee to make a favorable report on SB0668 - Department of Human Services – Children in Foster Care – Luggage.

The Maryland Catholic Conference (MCC) is the public policy representative of the three (arch)dioceses serving Maryland, which together encompass over one million Marylanders. Statewide, their parishes, schools, hospitals, and numerous charities combine to form our state’s second largest social service provider network, behind only our state government.

Senate Bill 668 requires then Maryland Department of Human Services to establish and maintain a decentralized supply of new luggage to be used to transport the personal belongings of child in foster care; requiring the Department to provide new luggage to a child who is being removed from a household under certain circumstances; requiring the Department to maintain certain records regarding luggage and children in foster care.

Some of our nation’s most vulnerable youth are in foster care, with 4,237 children in foster care in Maryland as of 2022.¹ These children are placed in foster care for various reasons such as abandonment, death, incarceration, neglect, abuse, and voluntary placement. Foster care aims to provide a safe environment for children to live and grow. However, many children in foster care lack basic belongings. When moving between homes, their belongings are often packed in plastic trash bags, which diminishes their sense of worth. Providing foster children with their own luggage is essential for their well-being. It offers them a sense of dignity and value, showing them that they are not disposable. As Pope Francis noted, “every child is God’s gift, in every case, and in whatever situation.”² With their own luggage, foster children can have a constant and personal belonging, easing the transitions between homes. This bill aims to provide dignity and hope to foster youth, emphasizing their inherent value and importance in our communities.

For these reasons, the MCC asks for a favorable report on **SB 668**.

Maryland Legal Aid (MLA) submits its written and oral testimony on SB0668 at the request of bill sponsor Senator Nick Charles.

MLA serves residents in each of Maryland's 24 jurisdictions providing free legal services to the State's low-income and vulnerable residents in a range of civil legal matters. MLA is Maryland's largest civil non-profit law firm, representing vulnerable young people in Child in Need of Assistance (CINA) matters across the State of Maryland. SB0668 is a vital measure to ensure that children who have been removed from their homes receive new luggage to be used to transport their personal belongings. MLA urges the Committee's favorable report on SB0668.

SB0668 will help ensure dignity and humanity for the Children in Need of Assistance in Maryland, by ensuring that their belongings are transported in luggage. This would prevent the use of trash bags which have been used for many children in foster care. When a child who has been determined to be a Child in Need of Assistance is removed from their household, it can be traumatizing. The youth must adapt to a new placement, and possibly a new school. For many of our Children in Need of Assistance, they have been abused and/or neglected and come from backgrounds of instability and therefore understandably often do not feel valued.

In some unfortunate cases, insult is added to injury when their valued personal belongings are stuffed in trash bags. This is degrading to the youth and can undermine their self-worth. This bill will provide these youth with the dignity of bringing their belongings in new luggage.

Maryland Legal Aid has represented several Children in Need of Assistance recently who have had to move to new placements with their clothes shoved in plastics bags. We have attached a recent photo of a client's items stuffed into trash bags. When we put a youth's personal items in trash bags, it sends a direct message that their items are not valued or important and by extension they are not valued or important.

Some counties receive donations that provide luggage and backpacks, but others are not so fortunate. Every Child in Need of Assistance in the state of Maryland deserves to have the minimum dignity that this bill will provide.

SB668: Department of Human Services - Children in Foster Care - Luggage

Chair Smith, Vice Chair Waldstreicher, and Members of the Senate Judicial Proceedings Committee:

No child in Maryland should be forced to carry around their belongings in a trash bag. Children in the foster care system experience hardships that those who have not been in foster care cannot relate to. For example, children in foster care are subject to relocations from one household to another, during which they must collect all of their belongings to bring with them to their new home.

This process can be unnerving for children who may already feel vulnerable and isolated. To compound this, children are often given *trash bags* for the purpose of moving their belongings. This current standard is inhumane, and does not reflect the fundamental dignity that every individual deserves.

SB668 would require the Department of Human services to create and manage a decentralized supply of new luggage to be utilized by children experiencing foster care to transport their belongings. The department may solicit and accept grants, gifts, and donations of any kind to meet this requirement.

Furthermore, the Department must report to the General Assembly the number of instances in which a child was provided a plastic bag, and the reason why they failed to provide new luggage. Under this bill, children are to be given new luggage once, not every time they are relocated, and luggage provided is theirs to keep.

It is essential that we end the shameful practice of providing trash bags for children in foster care to move their belongings. It is imperative that those experiencing foster care feel supported and are afforded the dignity that we would expect for our own children.

I urge the committee to give a favorable report on HB542.

The National Association of Social Workers – MD Chapter is the professional organization representing over 3,000 social workers statewide. We are asking for your support for SB 668, which would require the Department of Human Services (DHS) to establish and maintain a supply of new luggage to be used to transport the personal belongings of a child in foster care; require DHS to provide new luggage to a child who is being removed from a household under certain circumstances; and require DHS to maintain certain records regarding luggage and children in foster care.

Ensuring that children separated from their parents as a result of maltreatment or moving placement have luggage to transport their possessions is a no-brainer, and easy to support. Little is more demeaning than being forced to carry one's worldly possessions in a trash bag.

From querying social workers, we were encouraged to learn that DHS's foster parent policy already requires the purchase of luggage, and that local departments have purchased new luggage for years using a variety of funds. We also learned that in the 21 years of DHS's sibling sleepaway camp, Camp Connect, no camper has ever attended without luggage. Nonetheless, centralizing the purchase makes sense and can reasonably assure equitable access across the state without regard to the local department's resources.

With respect to the reporting requirements, we appreciate the keen interest in information about the number of instances when a disposable bag may have been used, and the reason the Department failed to provide new luggage. However, given the hundreds of existing requirements for documentation in an area of human services in which it's relationships that make the difference, not paperwork, social workers offered a cautionary note that a strategy for adding the collection of data from caseworkers about luggage may be a challenge.

Moreover, in light of children in the state's legal custody with literally nowhere to go – children and youth in hospitals on overstay and in hotels with 1:1 at a cost of roughly \$40,000 to \$60,000 month per child - social workers were hopeful that there might be as much concern about a place for the children to go as there is about luggage to bring with them.

In summary, maltreated children and youth who are separated from their parents and in the state's custody are entitled to the best possible care. As a sign in a colleague's office read, "If we are doing things to a child we wouldn't do with our own, we need to stop and ask ourselves why." While we have some significant progress to be made on supportive and therapeutic places for our children and youth to live, we can at least be sure their belongings aren't carried in trash bags.

Dear Chair Smith and members of the Judicial Proceedings Committee:

The Maryland Department of Human Services (DHS) thanks the Committee for the opportunity to provide support with recommended amendments to strengthen Senate Bill 668 (SB 668). With offices in every one of Maryland's jurisdictions, DHS provides preventive services, support, and care for children entering out-of-home services through kinship and foster care. The Social Services Administration (SSA) within DHS implements the state's child welfare program which serves the children SB 668 would benefit through the provision of new luggage for their belongings.

On February 15, 2024, DHS submitted a Letter of Information regarding House Bill 542, the cross-file of SB 668. Senate Bill 668 directly addresses concerns around the dignity of every child entering care or transitioning between out-of-home placements. To be clear: no child should ever have their belongings transported in trash bags. Such practices by DHS and/or any of its partners is unacceptable.

We reached out to each of the 24 Local Departments of Social Services (LDSS) to better understand the policy and practice related to providing luggage to children and youth. Though we verified that every LDSS has luggage available at the local level, we also learned there is no formal Department policy clearly articulating expectations on this matter. That ends now. We drafted and will issue immediate policy guidance to all LDSS on providing luggage to children and youth in our care; whether it's at the time of entry or a change in placement.

Local departments have developed strategies over the years to address the need for children and youth to have appropriate luggage items when they enter foster care and during placement changes to ensure no disposable bags are used to transport belongings. New luggage is currently provided through a range of locally driven, community partnerships, including donations from non-profit organizations, the local social services board, or through the use of State resources. Luggage is replenished as necessary by the local departments.



Making sure every child in kinship or foster care receives new luggage when they enter care is of critical importance. It is also essential that children have appropriate luggage when experiencing a placement change. As such, the Department recommends the bill address all children in care-not just at the time of entry-including those who are not in a traditional "household" and those who may be transitioning placements by amending § 5-505.2(C)(1) to read as follows:

~~(C) (1) SUBJECT TO PARAGRAPHS (2) AND (3) OF THIS SUBSECTION, THE DEPARTMENT SHALL PROVIDE NEW LUGGAGE TO A CHILD IN FOSTER CARE WHO IS BEING REMOVED FROM A HOUSEHOLD, AND~~
WHEN A CHILD OR YOUTH ENTERS CARE, IS MOVING FROM ONE FOSTER CARE PLACEMENT TO ANOTHER, OR IS LEAVING FOSTER CARE, THE DEPARTMENT WILL PROVIDE THE CHILD OR YOUTH WITH APPROPRIATE LUGGAGE, TAKING INTO ACCOUNT THE CHILD OR YOUTH'S AGE, MOBILITY, PREFERENCES, AND THE PERSONAL ITEMS TO BE TRANSPORTED.

The Department recommends adding to § 5-505.2(C) the following language:

(4) PLASTIC TRASH BAGS AND DISPOSABLE BAGS MAY NOT BE USED TO TRANSPORT ANY ITEMS FOR CHILDREN AND YOUTH IN CARE.

We support Senate Bill 668 with these amendments meant to strengthen the bill. We must all raise the bar of excellence in our work to ensure that every child and youth is treated with the respect and dignity they deserve. We look forward to your decision and welcome continued collaboration on SB 668.

We respectfully request a favorable report from the Committee with our recommended amendments.
