

**Support in Concept** 

The Office of the Attorney General supports House Bill 1041 in concept. House Bill 1041 is essentially technical in its effect. The current law already includes a prohibition on hate crimes based on "religious beliefs." House Bill 1041 also proposes to include the American with Disabilities Act (ADA) definition of "disability" in relation to the prohibition of hate crimes based on disability. Reliance on the ADA's definition of "disability" is routinely used, and the underlying prohibition already exists.

A threat against any person based on hate is a threat to all of us. The Office of the Attorney General is committed to ensuring all Marylanders live without fear of being targeted because of their race, gender, national origin, religion, or sexual orientation.

For the foregoing reasons, the Office of the Attorney General supports the spirit of House Bill 1041.

<u>Testimony of Meredith R. Weisel</u> ADL Washington D.C. Regional Director

ADL (the Anti-Defamation League) is pleased to submit this testimony in <u>support</u> of *HB1041*, *Criminal Law – Hate Crimes – Religion and Disability*, which would add the word "<u>religion</u>" to the existing Maryland hate crime statute, which currently only states "religious beliefs."

## **ADL** (the Anti-Defamation League)

Since 1913, the mission of ADL (the Anti-Defamation League) has been to "stop the defamation of the Jewish people and to secure justice and fair treatment to all." For decades, one of the most important ways in which ADL has fought against bigotry and antisemitism has been by investigating extremist threats across the ideological spectrum and by working with law enforcement, educators, the tech industry, and elected leaders to promote best practices to effectively address and counter these threats. Further, ADL conducts an annual *Audit of Anti-Semitic Incidents*, which is widely used by law enforcement, elected officials, and the community at-large to not only understand how to respond to antisemitic incidents, but how to create change.

Related to this work, ADL has long been recognized as a leading resource on effective responses to violent bigotry, including hate crimes. In 1981, ADL crafted the first model hate crime law in the country, and today, 46 states, as well as the District of Columbia, have hate crime laws, many of which are based on or substantially similar to our model, which was unanimously upheld by the U.S. Supreme Court. We were also privileged to lead a broad coalition of civil rights, religious, educational, professional, law enforcement, and civic organizations for more than a decade in support of the 2009 Matthew Shepard and James Byrd Jr. Hate Crimes Prevention Act (HCPA).

Behind every hate crime statistic, there is a person, a family, a community – dealing with the unimaginable. Hate crimes cause a distinct type of harm that can have a lasting, immeasurable impact. This is because hate crimes target people due to their protected, immutable characteristics – race, religion, national origin, sexual orientation, sex, gender, gender identity, disability – things about a person that are central to identity and cannot be changed.

Clarifying that someone's "religion" and not just their "religious beliefs" is a protected class in the hate crime law is a way to solidify that targeting someone based on their religion will be held accountable under the hate crime statute.

We urge the Committee to release HB1041 with a favorable report.

# House Bill 1041 Criminal Law - Hate Crimes - Religion and Disability Judicial Proceedings Committee March 27, 2024 SUPPORT

**Background:** House Bill 1041 (HB1041) expands Maryland's Hate Crimes Statute by: 1) defining disability and 2) adding religion as a motivation for a hate crime.

Written Comments: The Baltimore Jewish Council and Maryland's Jewish community are concerned about the recent rise in hate/bias incidents in Maryland and the damaging effect that is having on our communities. These incidents are impacting not just Jewish communities, but those of many of our other faith partners. According to the 2022 State of Maryland Hate/Bias Report authored by the Maryland State Police, Maryland experienced 311 reports, an increase from 2021, further anti-religious incidents in Maryland increased by over 84%, the vast majority of which were targeted at the Jewish community. This report does not factor in the extreme increase of almost 400% nationwide of antisemitic incidents since the Hamas terrorist attacks on October 7<sup>th</sup>.

While Maryland's hate crimes statute identifies religious beliefs as a motive for hate crimes, it does not include the term most often used in other states, religion. Someone could be a target of hate crime not because of their religious beliefs, but because of their religion, (or the religion the perpetrator thinks the victim is). For instance, you could be a Catholic atheist or someone with Jewish ancestry but not practicing the religious beliefs of Judaism. Another common hate crime is against the Sikh community who are often targeted because people believe they are Muslim due to their turbans. It is time Maryland joined the vast majority of states and include religion as a motive for hate crimes.

With this in mind, the Baltimore Jewish Council urges a favorable report of HB1041.
