## HB 319 Juvenile Justice Restoration Act of 2024 Favorable with Amendments

Thursday, February 8, 2024

**HB 319 - The Juvenile Justice Restoration Act** seeks to restore balance in the changes made over the last several years and ensure appropriate consequences for young offenders. Specifically, this bill includes:

- Interrogation allows parental consent as a substitute for the **required** consultation with an attorney. (please note see amendment #1 for bill drafting error)
- Juveniles at least ten years old who use firearms in the commission of a crime will come under the jurisdiction of the juvenile court system.
- Provide that upon the child's third arrest for a crime that does not fall within the category of "crimes of violence" or a crime committed with a firearm, the child will come under the jurisdiction of the juvenile court system (this would include car thefts). A more restrictive version of this bill to restore the language holding all juveniles accountable for their crimes is preferred, as I introduced with Delegate Lauren Arikan last year.

**AMENDMENT #2** – It has become abundantly clear that there is a **juvenile sex offender loophole**. The recent news report of a horrific rape of a three-year-old girl by a 15-year-old has revealed that immediate action is required. A 15-year-old boy was required to attend school inperson and was, and potentially still is, attending Patterson High in Baltimore City. Our public-school systems have indicated they are not able to keep a juvenile sex offender from in-person attendance. There is no juvenile sex offender registry, and juvenile records are not easily accessible.

## WHY DO WE NEED THIS BILL?

After the 2022 juvenile crime reform bill, HB 459, Juvenile Justice Reform, was passed, there has been a growing wave of juvenile crime that impacts ALL Marylanders. Juvenile crime has become a massive problem across our state. Specific categories of dangerous crimes are climbing sharply. Juvenile carjackings in Maryland have jumped by 85%, and handgun violations

statewide were up 220% between 2021 and 2023. We are glad to see the leadership in Annapolis introducing similar bills on juvenile crime.

**ACCOUNTABILITY!** It is time to restore balance in our public policy and protect our residents, visitors, and communities. Juveniles who commit crimes need to know that antisocial and illegal behavior will have consequences. Law enforcement and State Attorneys also want these laws tightened up.
