Primary and Secondary Education - Comprehensive Health Education Framework Established - HB0558

Good afternoon,

My name is Ayo H. Kimathi. In 2023, I testified against many bills proposed in Maryland that were seeking to sexualize children. They represented some of the most harmful legislation I've ever been exposed to. Two of the letters I sent to the legislature to oppose these perverse bills are included at the bottom of this document for reference.

I am writing this testimony to share my concerns about teaching LGBTQ philosophy to children from an LGBTQ perspective. As an Afrikan descendant of the Transatlantic slave trade who was born and raised in America and whose family has been in the US since the 1700's, I don't want to be re-enslaved. LGBTQ is an affront to Afrikan culture today as it was during our enslavement. We have never agreed to convert to this culture and it represents a modern enslavement being forced upon our people. Yesterday it was done on the plantations of America and today it's being done through the school system. Either way, our children are being sexualized against the customs and morals of our culture against our will, and I oppose any curriculum designed to teach this reprobate behavior to Black children. I don't believe it should be taught to any children; however, it is especially problematic to teach it to Black people because it goes 100% against our culture.

CHE is a fancy alteration of the international pedophilic education efforts of CSE (Comprehensive Sexual Education). It's perverse and anti-Afrikan culture. Black people live in America; but we are still Afrikan.

HB0558 is a step in the wrong direction and a danger to all children in Maryland. I vehemently oppose this bill.

This email is to contextualize a couple of bills that are all designed as part of a larger effort to sexualize the children of Maryland. It's part of a national agenda that is being rolled out throughout school districts in this country. And it's part of an even larger international agenda of United Nations Educational, Scientific and Cultural Organization (UNESCO) called Comprehensive Sexuality Education (CSE).

CSE is designed to introduce children to perverse sexuality in the effort to prepare them for easy targeting by pedophiles. Under the guise of informing children about sex, CSE has promoted everything from prostitution to anal and oral sex to grade school children internationally. - HB119 (SB199) Comprehensive Health Education (alteration of the CSE above from "S" for "Sex" to "H" for "Health" to hide the intent of the bill)
- SB460 (HB283) Trans Bill

HB119 is designed to work as the "grooming" tool to sexually molest the minds of youth through the school system. I've included attachments of a very small sample of the types of books we found in the PG County library system that are also being taught in the classrooms, being used to sexually groom our children into sexual confusion.

After the children have been adequately groomed, SB460 provides the physical means to facilitate the conversion of the sexually confused children into sexual/gender destruction. They can castrate themselves chemically and/or physically through medical manipulation, without their parents' knowledge and/or consent.

This is pedophilia and psychopathology rolled into one set of destructive legislative bills. We ask you to stand against these bills as they are directly targeted at our children.

HB890 Commission on History, Culture, and Civics in Education

Good evening,

My name is Ayo H. Kimathi. I am a Prince Georges County, MD resident.

This email is to express my outrage and disappointment with this bill and request that you vote against it.

The core issue I have with the bill is that it clearly links the suffering of Afrikan people in America to the LGBTQ behavior. From my point of view as a descendent of Black people who were kidnapped from Afrika and brought here in bondage, I am appalled at the constant efforts to subtly re-enslave our people.

I am (1) of the (2) world authorities of the imposition of homophilia (LGBTQ) on Black people worldwide. I have authored a book on the topic and produced many videos as well. After over (25) years of research, international travel, and lecturing I've witnessed this imposition on the Afrikan world community first hand.

We were introduced to the LGBTQ on the slave plantations of America. As a result, re-introducing LGBTQ to Black people in America and worldwide is another effort to enslave our people. Just recently, we've witnessed the US threaten Uganda for defending its culture against LGBTQ invasion.

This bill lists the specific members of the LGBTQ who will be a part of this commission. However, nowhere does it even insinuate that a "heterosexual" Black man or woman will be guaranteed to participate. So this bill leaves it wide open for there to be 100% LGBTQ participation and 0% Black heterosexual participation. LGBTQ is not the "New Black." There are still many of us who are resisting this re-enslavement.

Since this bill seeks to conflate the slavery of LGBTQ onto Black people and our culture, I believe it should be voted down altogether. We do not want to embrace our enslavement as a part of our culture. We included a link to the 13th Amendment as support for our position.
