HB0086 – Institutions of Higher Education and Elementary and Secondary Schools – Title VI Coordinators

Position: FAVORABLE

Chair Barnes, Vice Chair Chang, and Esteemed Members of the Appropriations Committee:

My name is Lauren Pruitt, and I am the Legal Director at FreeState Justice, a nonprofit organization dedicated to serving LGBTQ+ Marylanders from diverse backgrounds. I am writing in support of **HB0086**, which seeks to require higher education institutions and local school systems to designate a Title VI Coordinator to ensure compliance with Title VI of the Federal Civil Rights Act of 1964, and to allow persons alleging discrimination under certain provisions to file a complaint with the Title VI Coordinator of a local school system.

HB0086 addresses a critical area of compliance with the Civil Rights Act of 1964 that affects students across Maryland. Title VI Coordinators serve as a necessary accountability check on educational institutions, which remain hostile environments for LGBTQ+ students. It is imperative that these coordinators advocate for change and foster inclusivity, creating a climate where every student feels valued and respected.

Specifically, HB0086 would:

- **Promote Access to Education:** Title VI Coordinators may address current and potential barriers at educational institutions that disproportionately affect LGBTQ+ students of color.
- **Promote Upward Mobility:** By removing barriers to education, students can focus on their education, leading to better job opportunities and higher incomes.
- Advance Social Justice: Title VI Coordinators may investigate and dismantle institutional discrimination and systemic bias.
