Additionally, the bill will positively impact public education by promoting inclusivity and cultural awareness among all students. It will empower American Indian Marylanders to see themselves represented in their communities, fostering a sense of pride and

belonging. Seeing oneself represented in the community is crucial for holistic health, as it supports mental, emotional, and social well-being.

I also urge that preference be given to Maryland Tribes first when awarding grants, followed by non-profits that support American Indians and their descendants. This prioritization ensures that the resources are directed towards those who are most closely connected to and knowledgeable about the needs of the American Indian population in Maryland.

As an enrolled citizen of the Piscataway Conoy and as an educator, I have witnessed firsthand the importance of preserving our cultural heritage. The stories, traditions, and history of Indian tribes are invaluable assets that enrich our society and contribute to our collective identity. Supporting HB794 is not just about preserving the past; it is about empowering future generations to understand and appreciate their heritage.

I urge the Committee to pass HB794 and take a decisive step towards honoring and preserving the cultural legacy of Indian tribes in Maryland. Thank you for considering my testimony.
