AMENDMENT NO. 1

On page 1, in line 6, strike "to" and substitute "<u>to perform an impact assessment</u> of the project and"; in line 8, after "Department" insert a comma; in the same line, strike "the" and substitute "<u>a certain</u>"; in the same line, after "Program" insert a comma; in line 12, strike "and vehicle miles traveled"; and in line 13, strike "perform certain capacity expansion impact assessments" and substitute "<u>establish certain processes and post certain information on the Department's website</u>".

AMENDMENT NO. 2

On page 2, in line 19, after "PROGRAM'S" insert "<u>OPERATIONAL</u>"; and strike beginning with "THE" in line 21 down through "CHOICES" in line 28 and substitute "<u>AN</u> <u>INCREASE IN THE DEMAND FOR MOTOR VEHICLE TRAVEL THAT IS</u> <u>DEMONSTRATED BY AN INCREASE IN VEHICLE MILES TRAVELED DUE TO AN</u> <u>INCREASE IN ROADWAY SUPPLY, SUCH AS NEW OR EXPANDED ROADS,</u> <u>ADDITIONAL CAPACITY, OR ADDITIONAL LANE MILES</u>".

On page 3, in line 4, after "LANES" insert "<u>, GRADE SEPARATIONS INCLUDING</u> <u>INTERCHANGES</u>,"; in line 5, strike "FOR ALL PHASES"; in the same line, strike "\$5,000,000" and substitute "<u>\$100,000,000</u>"; after line 7, insert:

"(J) "SYSTEM PRESERVATION ACTIVITY" MEANS AN ACTIVITY FOCUSED ON MAINTAINING AND REHABILITATING EXISTING TRANSPORTATION INFRASTRUCTURE TO ENSURE THE INFRASTRUCTURE REMAINS SAFE, RELIABLE, AND FUNCTIONAL.";

On page 5, strike beginning with "IF" in line 3 down through "(3)" in line 7; in line 14, strike "THE"; in the same line, strike "BUDGET" and substitute "APPROPRIATIONS"; in line 15, strike "IS CONSISTENT WITH, AND MAKES" and substitute "AND"; in line 16, after "TARGETS" insert "ARE, OVER THE CONSOLIDATED TRANSPORTATION PROGRAM PERIOD,"; in lines 17 and 18, strike "THE STATE'S CARBON POLLUTION **REDUCTION PLAN OVER** THE **CONSOLIDATED TRANSPORTATION PROGRAM PERIOD**" and substitute **"THE PROJECTED** GREENHOUSE GAS EMISSION REDUCTIONS MODELED FOR ROADS IN MARYLAND'S CLIMATE POLLUTION REDUCTION PLAN: MODELING APPENDIX"; in line 19, strike "MAY" and substitute "SHALL"; strike beginning with "STATE'S" in line 21 down through "GOALS" in line 22 and substitute "DEPARTMENT'S 2023 CLIMATE POLLUTION REDUCTION PLAN AND THE TARGETS ESTABLISHED IN SUBSECTION (D) OF THIS SECTION"; in line 27, after "COMMUNITIES;" insert:

On page 7, in line 9, strike "ALTERNATIVE ENERGY GENERATION" and substitute "SOLAR ENERGY GENERATION ON PROPERTY CONTROLLED BY THE <u>DEPARTMENT</u>"; in line 11, strike "(C)" and substitute "(D)"; in line 17, strike "FOR"; in the same line, after "PRESERVATION" insert "<u>ACTIVITIES</u>"; and after line 21, insert:

"(2) ESTABLISH A PROCESS FOR CONSIDERING PROGRESS MADE TOWARD MEETING THE TARGETS SPECIFIED IN § 2-904(D) OF THIS SUBTITLE;

(3) ESTABLISH A PROCESS FOR DEVELOPING A MULTIMODAL TRANSPORTATION PROGRAM UNDER § 2–903 OF THIS SUBTITLE, INCLUDING A METHOD FOR CONSIDERING THE DIRECT AND INDUCED DEMAND IMPACTS OF A MAJOR HIGHWAY CAPACITY EXPANSION PROJECT; AND

(4) <u>PUBLISH ON THE DEPARTMENT'S WEBSITE:</u>

(I) <u>THE PROCESSES ESTABLISHED UNDER ITEMS (2) AND (3)</u> OF THIS SUBSECTION; AND

(II) ANY MULTIMODAL TRANSPORTATION PROGRAM DEVELOPED UNDER § 2–903 OF THIS SUBTITLE.".

On pages 7 and 8, strike in their entirety the lines beginning with line 22 on page 7 through line 28 on page 8, inclusive.

On page 8, in line 29, strike "(D)" and substitute "<u>(B)</u>"; and in the same line, strike "2025" and substitute "<u>2026</u>".
