## **Progressive Maryland strongly supports the Fair Share for Maryland Act (SB 859).**

Progressive Maryland is a member based organization led by and focused on working class, Black, and brown communities. Our grassroots advocacy focuses include racial justice and economic justice with the aim of building a more just and equitable Maryland. We have over 125,000 members and supporters across the state, with significant bases in Baltimore City, Prince George's, Montgomery, Frederick, Harford counties, and the Eastern Shore. Progressive Maryland supports S859 because it will provide resources that Maryland communities need while also ensuring that wealthy corporations and individuals are contributing their fair share to the public services we all benefit from.

Our members in Prince George's County consistently come to me pointing out crumbling school buildings, a lack of after school programs, and unsupported teachers. Other Progressive Maryland staff and members report similar problems of underinvestment in public schools and other public infrastructure, undermining the standard of living for working families all over our state. Our members want to utilize every opportunity to make our schools better, and holding corporations accountable to pay their fair share for our schools is paramount to having the thriving education we aspire for in Prince George's County and Maryland.

The Fair Share for Maryland Act will:

- Raise at least \$1.6 billion per year in new revenue when fully phased in
- Lower taxes for more than 1.3 million Marylanders by expanding the Child Tax Credit and Earned Income Tax Credit
- Close corporate tax loopholes to ensure wealthy multinational corporations can't avoid paying state taxes
- Balance our upside-down tax system and ensure millionaires pay their fair share by adding upper income tax brackets and adding a surtax on investment income

We can't grow our economy if we are cutting back on things like public schools, child care, and transit service. Businesses – and the Maryland workers they employ – value these services and it is only fair that the largest corporations pay their share, just like our Maryland small businesses already do.
