The Maryland Coalition of Families: Maryland Coalition of Families (MCF) is a statewide nonprofit organization that provides family peer support services at no cost to families who have a loved one with a mental health, substance use, or problem gambling disorder. Using their personal experience as parents, caregivers and other loved ones, our staff provide emotional support, resource connection and systems navigation as well as support groups and educational trainings and workshops.

Last year, we served nearly 5,000 Families, and 2% of the families served were caregivers of a loved one with problem gambling, and the numbers continue to increase.

- Here at MCF, we have seen a troubling rise in gambling behaviors among schoolaged children and young adults. The stigma surrounding gambling, particularly for
  college-aged students, can make it difficult for young people to seek help. There has
  been a rising number of college students and online sports wagering. So many
  people see problem gambling as a financial problem, not a behavioral health one,
  which contributes to uncertainty about where they should turn to for help.
- Educating and providing resources such as The Maryland Center of Excellence on Problem Gambling helps people get help sooner.
   Ensuring this resource is on the home page of these mobile applications and websites will reduce stigma and provide information for



support as soon as the homepage appears, which could help someone who may be struggling.

Dear Chair Guzzone:

The Maryland Center of Excellence on Problem Gambling (the Center) supports Senate Bill 86 – Online Sports Wagering - Problem Gambling Resources - Required Contact Information.

Maryland law currently does not have such a strong player protection for online and mobile sports bettors as is described in this bill. The Maryland State Lottery and Gaming Control Commission has promulgated responsible gambling regulations for sports betting licensees. Relevant regulations are codified in COMAR 36.10.10.03 and reads in part, "A sports wagering licensee shall ensure that the gambling assistance message is conspicuous and readable." Each website seems to require the player to scroll down for pages before finding any responsible gambling messaging and do not link to the Center. This bill improves existing Maryland law by its prescriptive messaging and directing helpseekers to the Center's website. The Center is the only organization in Maryland that is charged with providing a free and confidential 24-hour helpline for those struggling with problems due to gambling. When a person is directed to the Center's website they can call or text for immediate assistance. No other organization in Maryland can help in that way.

This bill will improve upon the pre-existing responsible gambling requirements of the state. For this reason, the Center urges a favorable report on this bill. # Senate Bill 86 Online Sports Wagering - Problem Gambling Resources - Required Contact Information Support

NCADD-Maryland supports Senate Bill 86. This bill will improve upon the existing responsible gambling requirements of the state and ensure that mobile sports wagering licensees prominently post information about how to get help for problem gambling.

In Maryland, it is estimated that 3.4% of adults are problem or pathological gamblers. Data shows that more and more younger people are involved in gambling activities and experiencing problems. Gambling hotlines serve as an entry point for people who think they need help. Through hotlines, callers can learn about additional resources they need to address their problems. These resources may include additional brief interventions over the phone, a connection to a peer counselor, and when the problem is severe, formal treatment.

Problem gambling hotlines are the entry point for information and help. Senate Bill 86 is a sensible measure to promote this access. We urge a favorable report.

If passed.Bill number SB 86 would require all mobile sports wagering providers to include the phone number and link to.The Maryland Center of Excellence on Problem Gambling on the home page of their website and mobile applications. The Maryland Lottery and Gaming Control Agency supports Senate Bill 86 - Sports Wagering – Problem Gambling Resources – Required Contact Information.

### **Bill Summary**:

Senate Bill 86 proposes sports wagering licensees in Maryland prominently display language that would direct an individual seeking resources for problem gambling to a phone number or online resource that could be accessed by clicking a link on the licensee's mobile application or online sports wagering website.

#### **Background:**

The Maryland Lottery and Gaming Control Agency licenses 11 sports wagering operators who provide sports wagering in the State. Once a user has met the requirements to create an account, any time the user signs into the account a landing page is displayed. Currently every licensee's landing page provides information for users to access links or a phone number to provide resources for responsible gaming in Maryland.

### **Rationale:**

Senate Bill 86 would codify this current best practice. The Agency does suggest the following amendments to Senate Bill 86.

#### Amendment No. 1

On page 2, line 7, after "THE" strike "HOMEPAGE", insert "LANDING PAGE."

### Amendment No. 2

On page 2, line 10, after "GAMBLER", insert "OR SOME COMPARABLE LANGUAGE APPROVED BY THE COMMISSION"

MLGCA respectfully requests a favorable report on Senate Bill 86.
