I am writing to you today as a parent in full support of Senate Bill 0843: School Construction – Local Cost-Share – Alterations. Passage of this bill before you is an absolute imperative for Kent County Public Schools, its students and staff, and my community.

My wife and I have two sons, the older is a third-grader at Henry Highland Garnet Elementary School in Chestertown and is possibly on his way to being an astrophysicist and his younger brother will be a first-grader at Garnet next year and hopes to specialize in veterinary medicine for injured endangered sea turtles, in his words: "a turtle doctor."

Something a lot of people don't realize about Kent County — we have only five public schools. Three elementary schools, a middle school and a high school.

So we have only one middle school serving all families in Kent County. And that building is old and failing. But we don't have the same option as families in Maryland's metropolitan areas who can opt for a different middle school nearby or enter a lottery for a coveted high-performing school in the same city or county.

If my wife and I choose to send our children to a different middle school when the time comes, it will be either at great expense to us for private school tuition or by leaving the community that is our home and finding jobs elsewhere.

Either choice is also detrimental to our school system. We would be another family contributing to declining enrollment, and the state and county funding to Kent County Public Schools would decrease as a result.

More so, I don't want to move. My family doesn't want to move. And we shouldn't have to.

The state funding formula was created with the best intentions — like all public policy. An issue needed to be addressed. State leaders took charge and created a plan that sought to fix the problem.

But like nearly every one-size-fits-all policy, there are outliers that are actually hurt instead of helped.

The school construction formula shows Kent County to be wealthy. We have a lot of waterfront land, so that tracks. Meanwhile, another formula shows that we have so much poverty among our school population that every child receives free breakfast and lunch and access to various wraparound services such as Community Schools, Judy Centers and Title I resources.

Two things can be true at the same time. In this case, the wrong formula is being applied to our middle school project.

There's no hiding the significant cost for a middle school — especially with only a 50/50 split in state funding — in Kent County's annual budget totaling around \$60 million. Nor is there any way of distributing the cost share equitably among the less than 20,000 people who live in Kent County. Please think about that for a moment — 20,000 people. You can fit more than three times our entire county population in M&T Bank Stadium.

And we haven't asked the state for a new school in 50 years — while we have tightened and tightened and tightened budgets and closed schools and consolidated roles and added responsibilities all in an effort to keep our schools going.

Please help my community and support SB0843. My children and every other child in Kent County deserve to attend a middle school that would offer them the kind of education Maryland strives to provide for its next generation of leaders in every field.

David Lever, AIA D.Arch, Educational Facilities Planning LLC March 4, 2025

I wish to offer testimony in support of Senate Bill 843, School Construction – Local Cost-Share – Alterations. Since 2017, I have assisted the Board of Education of Kent County with a range of facility planning matters. Based on a Facilities Master Plan approved by the Board in early 2018, the school system has carried out much-needed facility improvements, including security vestibules at every school, roof and mechanical system replacements, and targeted renovations at two elementary schools. The Board and Superintendent have demonstrated that they are responsible stewards of State and local funds, accomplishing these projects within budget and at a high level of quality.

While four out of five of the instructional buildings in Kent County are now better positioned to support contemporary learning approaches, the Kent County Middle School facility remains virtually untouched. The original 1950 building was last renovated in 1976. In October 2023 the Board of Education approved replacement of this facility on the existing site in Chestertown. The Board of County Commissioners supports the project, and the Interagency Commission on School Construction has granted Planning Approval as well as design funds through the Built to Learn Act and the Capital Improvement Program. The school system has worked closely with the Maryland Stadium Authority on procurement of architectural/engineering services and construction management services. Design is now well underway, with an anticipated bid date at the end of this calendar year. Working closely with Superintendent McComas and her staff, the project design team has sought every possible means to reduce the size and cost of the facility. This research continues, and it may eventually require removing program elements that are important in a middle school instructional program.

This critical project concerns equity of access to education. Since Kent County Middle School is the only middle school in the county, the deficiencies of the building affect the education of every public school student during their formative early adolescent years, when their attachments to educational achievement and to their communities are being shaped. The current facility presents many barriers to effective education, including:

- **Deficiency of instructional and support spaces:** A complete absence of full, purpose-designed science laboratories, numerous classrooms without acoustic isolation, a lack of spaces for instruction for students with special needs, the absence of teacher planning spaces, and an art room without natural daylighting. At a time when emphasis is placed on STEM and STEAM instruction and on instruction for students with special needs, these deficiencies translate to significant impediments for the students of Kent County.
- Accessibility: The building does not meet Americans with Disabilities Act (ADA) requirements. It has no accessible toilet for either students or staff, has no elevator to the second floor, and the front entrance is not ADA accessible. It has a single accessible route from parking to the ground floor. These deficiencies present serious barriers to students, staff members and visitors with disabilities.
- **Circulation:** During class changes students must pass through the Library Media Center, music students pass through the Gymnasium, and maintaining separation of the age groups during lunch periods requires a convoluted and time-consuming sequence of movements.
- **Building performance:** The building is not energy efficient and maintenance of the aged building systems is a drain on the school system budget, diverting much-needed funds from the classroom. School days have been lost due to failing building systems.

I served as the Executive Director of the Maryland Public School Construction Program from 2003 to 2016. As a lead author of the original regulations under which the State school construction program has operated since 2007, I understand how serious an issue is involved in any adjustment of long-standing

practices for allocating funds. However, the mission of the school construction program has always been to ensure that no school in Maryland is significantly deficient when compared to those in other jurisdictions. Kent County Public Schools is the only school system in the state that has not received a new school from the increase in funding that resulted from the Public School Facilities Act of 2004 and subsequent legislation. As a result, the school system has among the oldest average square footage of school space in the state, a situation that has a negative impact on students throughout the county.

To ensure that students in Kent County have the same educational opportunities as their peers in other Maryland school systems, Kent County Public Schools seeks an exception to the standard State construction funding percentage. The exception will allow the replacement of Kent County Middle School to proceed to construction. Our specific interest is in Kent County, which currently receives the minimum state share of school construction funding (50%), while other similar counties are at levels such as 85 – 100%. This bill serves to address this issue and revises the funding %.

A new school project in Kent County is long overdue. The current Kent County Middle School was built in 1950 and last renovated in 1976. This makes the original building 73 years old and the renovations 47 years old. With an aging facility, concerns such as safety/security, ADA compliance, energy efficiency, access to natural daylight for the students, efficient learning designs, etc, are at the forefront of needs. It is past time for a new middle school in Kent County.

I wish to testify in support of Senate Bill 0843, School Construction – Local Cost-Share – Alterations. In July 2019, I was hired as an Accountant for Kent County Public Schools with the intention to financially oversee the school system's School Construction, Maintenance, Operations, and Transportation budgets.

Within the School Construction Program, Kent County Public Schools has completed projects of various scales that have improved the learning conditions for students at four of the five schools within the county's portfolio. Each of these projects have been completed within the allowed budget, with many being under the allowed budget, showing strong financial oversight of the state and county's valuable funding. The only building that has not received an improvement to the learning conditions within the building is Kent County Middle School, which serves every child within Kent County Public Schools. Due to the results of the Feasibility Study conducted by Kent County Public Schools, it was determined that any renovation projects would be an inefficient use of limited funding for the building. The Maintenance & Operations team in addition to the Custodial staff at Kent County Middle School have demonstrated a tremendous ability to keep the school operational for the students despite the overwhelming daily challenges they face due to the age of the building systems.

Through the Capital Improvement Program, Kent County Public Schools has diligently worked toward achieving each possible Add-On allowable by the state. These Add-ons include Concentration of Poverty and Maintenance Effectiveness. A third Add-On for achieving a Net-Zero Energy building is also expected to be achieved through the A/E Design that is currently underway.

In the past 19 months, Kent County Public Schools has spent \$129,626.48 just in repairs to the building. These repairs have ranged from sewage infrastructure, roofing, HVAC, and repairs to the BAS. As a point of reference, the entire building repair budget annually to service each school location is \$21,000.00 and the entire school system's budget for all locations is \$115,000.00 annually. Kent

County Middle School also has a failing BAS control system, which is going to result in another potential \$33,843.00 expense soon. As you can see, the day-today operation of the school is causing extreme budgetary impacts. This means that Kent County Public Schools must utilize other sources of revenue, such as the IAC's Aging Schools Program to supplement the funding for these repairs. Kent County Public Schools receives an annual amount of \$38,292 through this program. Ideally, the projects that utilize Aging Schools Funding would be projects to enhance the learning environment, not to repair an aging building where the intention is to replace it in the near future.

For these reasons mentioned above, I urge the members of the Senate Budget and Taxation Committee to give a favorable report on Senate Bill 0843 – School Construction – Local Cost-Share – Alterations. Thank you for your time and consideration.

This bill ensures the process launched in 2018 to plan to renovate and modernize our school buildings culminates with the capstone project in the Kent County Public Schools Six-Year Facilities Strategic Plan: the construction of a new Kent County Middle School.

In past years, the state has granted counties in similar situations a much higher percentage of costs. Kent County has 86% of students qualifying for CEP. Caroline County, with 85% CEP, was granted 94% from the state for eligible costs. Wicomico, with 77% CEP, was granted 98% from the state. Kent County Middle School was built in 1946. That was 79 years ago, the year World War II ended, the same year the world's first general-service computer was introduced to the world.

We cannot expect our children to thrive when they are trying to learn in a building that is almost 80 years old and is crumbling around them. There are leaks in the roof, rooms without windows, and no spaces designed to accommodate and support the pedagogical advancements of the past 80 years. It looks and feels like a bunker. How can our students learn to prepare for the future when their school is a relic of the past?

Our kids and teachers need a new building—one that reflects the fact that we are living in the 21st century. Our community needs this school. But we do not have the funds to pay for it because our county is small and our budgets are as well. It is an injustice of our forward-thinking state to leave Kent County students behind and to continue to forfeit their futures because our county is unable to fund a new school building. Kids deserve a healthy, safe and welcoming school building that inspires learning, no matter where they're from.

Please advocate for our often overlooked and undervalued students by voting favorably on SB0843 to give them the best environment for success.

This bill would make it possible for our community to build the new middle school that we desperately need. Currently, the state would split the costs for a new school 50-50 with the county. With construction costs budgeted between \$60 and \$70 million, that is a burden our Kent County community of less than 20,000 residents cannot afford.

The state set the 50/50 split because a formula shows Kent County to be very wealthy, but all five of our schools have high rates of poverty. Every student in each of our schools gets free breakfast and lunch because of our poverty rates.

We have one middle school — Kent County Middle School — serving all the children of our county. It opened in 1950 and the maintenance costs we are paying every year is money that would be much better spent on a new building. The building had to be shut down and classes canceled for three days this school year for plumbing issues. When it rains, water leaks in. One room is freezing cold and the next room over is boiling hot. Kent County Middle School's classrooms do not meet the needs of today's students. They are not suitable by today's educational standards.

Our kids deserve better, especially during their middle school years. A new Kent County Middle School will revive our school system and our local economy.

We urge you to support the passage of Senate Bill 0843.

SB0843 School Construction - Local Cost-Share - Alterations

Dear Chairman Guzzone and Members of the Senate Budget and Taxation Committee:

I am writing today to express my strong support of bill SB0843 - sponsored by Delegates Jacobs, Ghrist, and Arentz, and Senator Hershey. This bill requests that an adjustment is made for the local cost-share for school construction projections under certain circumstances.

The school is truly ancient, and is falling apart. It is unfortunate just how often the children have to be sent home because of a sewage break, but there is no alternative. If I could pull my daughter out of this particular school in favor of another I certainly would. I have one more younger daughter in this system, I really hope we can do better for her, when it's time for her to attention middle school.

Kent County Middle School serves all of Kent County with a high population of students who qualify for free or reduced price meals. The current state cost share for public school construction for Kent County is designated as 50%, leaving our small county of 22,000 to cover about \$45 million to build a new school. This is about 3/4 of Kent County's entire yearly budget. Unfortunately, we know this project literally cannot happen without an increase in support from the state.

In past years, the state has granted counties in similar situations a much higher percentage of costs. Kent County has 86% of students qualifying for CEP. Caroline County, with 85% CEP, was granted 94% from the state for eligible costs. Wicomico, with 77% CEP, was granted 98% from the state. Kent County Middle School was built in 1946. That was 79 years ago, the year World War II ended, the same year the world's first general-service computer was introduced to the world.

We cannot expect our children to thrive when they are trying to learn in a building that is almost 80 years old and is crumbling around them. There are leaks in the roof, rooms without windows, and no spaces designed to accommodate and support the pedagogical advancements of the past 80 years. It looks and feels like a bunker. How can our students learn to prepare for the future when their school is a relic of the past?

Our kids and teachers need a new building—one that reflects the fact that we are living in the 21st century. Our community needs this school. But we do not have the funds to pay for it because our county is small and our budgets are as well. It is an injustice of our forward-thinking state to leave Kent County students behind and to continue to forfeit their futures because our county is unable to fund a new school building. Kids deserve a healthy, safe and welcoming school building that inspires learning, no matter where they're from.

Please advocate for our often overlooked and undervalued students by voting favorably on SB0843 to give them the best environment for success.

Agency Statement of Position

The Interagency Commission does not support SB0843 for three reasons:

- It would override the IAC's statutory authority to determine how it allocates State capital funds to school districts' projects pursuant to formulas duly adopted in regulation and applicable to all project requests – an authority central to its ability to carry out its core mission and statutory responsibilities;
- It would suspend one of the IAC's central equity mechanisms the State-Local Cost Share system and arbitrarily shift approximately \$8 million from other counties' high-priority projects to one singled-out project that currently is behind a number of other projects in terms of readiness; and
- Legislation that overrides the IAC's State-local cost-share system for a single case may induce other counties to pursue similar legislatively directed increases in State support for projects in a manner that reduces the effectiveness of one of the IAC's central equity mechanisms.

Scope of the Bill

This bill would adjust the State cost share to approximately 84% for projects meeting a set of specific criteria. At this time, the only school in the State that meets the criteria is Kent County Middle School (KCMS) in Kent County, which has a full replacement project pending at the IAC. Should Talbot County choose in the near future to allow all of their schools to participate in the Community Eligibility Program, which gives free and reduced-priced lunches as an option at all schools, then projects at most of the Talbot County schools (including the pending Chapel District Elementary School renovation-addition project) may also become eligible for this increase to the State cost share.

Fiscal Impact to the State

Assuming an estimated total eligible construction cost of \$43,032,000 and an estimated total project cost of \$66,700,000, the bill would adjust State and Local Cost Shares on the KCMS project as follows:

The IAC interprets SB0843 as mandating a calculated State share for the KCMS project that cannot include any of the add-ons. Based on Kent County's base State Cost Share of 50%, plus an additional 15% as a result of qualifying for the 5% Concentration of Poverty Add-On, the 5% Maintenance Add-On, and – pending confirmation and therefore not yet shown on the IAC's 90% CIP recommendations – the 5% Net-Zero Add-On, SB0843 would direct the IAC to award an estimated \$8,175,000 more to the KCMS project than it otherwise would under its rules.

Fiscal Impact to Other Counties


Because State-funded school construction projects are funded over several years, with partial funding awards being granted each year on pace with actual construction spending, the total additional expense of \$8,175,000 would likely be broken up over the course of 2-3 years, resulting in a yearly reduction of \$2,725,800 to \$4,087,500 in the funding available to the remaining LEAs' projects as a result of this bill.

Even if the IAC were to vary its rules and award more than the standard amount to the KCMS project, the IAC would first need additional appropriations with which to do so. Should the IAC receive additional appropriations, however, the KCMS project would not be first in line to receive such because

- The project has not yet begun construction;
- There are five IAC-approved projects in other counties for which construction is already underway and that require delivery of portions of their Maximum State Awards that currently are unfunded and would take precedence over the KCMS project; and
- There are three other projects currently requesting first-year construction funding alongside KCMS that, due to their greater extent of design and/or construction progress at this point in time, would likely take precedence over the KCMS project.
