#### TESTIMONY IN SUPPORT OF SB 528 SALES AND USE TAX – TAX-FREE DAY – VETERANS' DAY

Chair Guzzone, Vice-Chair Rosapepe and Members of the Committee,

Thank you for the opportunity to testify before you on SB 528, Sales and Use Tax – Tax-Free Day – Veterans' Day. The purpose of this bill is to establish a sales tax-free day on Veterans' Day for veterans who have served in the uniformed services of the United States as a Reserve component, Armed Forces, U.S. Public Health Service, or the National Guard of any state.

Within its border, Maryland has 20 military installations that make up a key part of the state's economy. According to the Maryland Department of Veterans & Military Families, Maryland is home to nearly 360,000 veterans and 100,000 active-duty service members, reservists, national guard and dependents. A tax-free day on November 11<sup>th</sup> would not only provide a tangible benefit in the form of financial relief but also serve as a public acknowledgment of their service. The concept of a tax-free day is not new to Maryland. ## Senate Bill 528 -- Sales and Use Tax - Tax-Free Day - Veterans' Day Senate Budget and Taxation Committee March 5, 2025 Support

The Montgomery County Chamber of Commerce (MCCC), the voice of business in Metro Maryland, supports Senate Bill 528 -- Sales and Use Tax - Tax-Free Day - Veterans' Day.

Senate Bill 528 establishes November 11 as a tax-free in Maryland for military veterans.

**Background:** SB528 would establish an annual tax-free day on Veterans' Day for veterans.

Comments: The Maryland Retailers Alliance (MRA) supports the establishment of an annual sales tax holiday on Veterans' Day for veterans who have served in the armed forces of the United States.
