RE: SB 1006 Assigned to Senate Budget and Taxation Committee

I am writing in support of the Bill SB1006, which is intended to provide Artist's Rights Protection as well as their reputation. The goal of this bill is to protect the public's interest in ensuring that the investment and legacy of a work of art is not lost or compromised.

I have created public art locally and nationally for over 35 years and feel strongly that it is important to our culture. It enriches our lives and does a myriad of good including the enhancement of the vibrancy in our cities and neighborhoods and supports economic growth. Public art contributes to the health and well-being of individuals and communities. Two reasons for this are the landmarks and identity public art has created for communities. Also, keep in mind that public art has been commissioned across Maryland through multiple Federal, State, and local public art programs for placemaking and creating legacies.

SB1006 is being introduced because some public art in Maryland has been altered without artists' permission in violation of their rights. When artists are coerced to waive their federal VARA (Visual Artist Rights Act of 1990) and copyright protections in contracts for commissioned works, the integrity of the art is no longer protected which hurts the artist and the public.

This legislation will establish that the State of Maryland respects artists' rights and the public interest in the preservation of public art. It is limited in scope, since it is only enforceable with entities in which State funds are involved. However, the legislation will apply to contracts with artists by entities that receive state funding. Additionally, the legislation also recognizes that there may be unforeseeable conditions where this legislation may not be applicable and so provides for review by the Attorney General with guidance as needed from those with knowledge and expertise in public art through MSAC.

Thank you are your attention. As an artist who has spent her professional life since 1979 in Maryland, please pass this legislation.

TESTIMONY IN SUPPORT OF SB 1006 Commissioned Public Art - Artist Rights

My name is Linda DePalma. I am an artist living for over 40 years in Bolton Hill 21217 and vote in all elections. Please support **SB1006.** I am 100% in favor and support of this bill.

As an artist who has been fortunate enough to receive a number of public art commissions in the regional area, this is a poignant issue for me.

Public artworks, commissioned by the State, often involve artists collaborating with local governments, architects and engineers. This is a challenging process, however, due to this collaboration, a sense of place with historical and meaningful implications develops. Artworks are beloved by the communities where they are sited. A public artwork becomes an important identifier, a landmark, for State constituents and their communities. What is the intrinsic value of this artwork? A connection to art can enhance emotional, physical and mental health. Viewing art can trigger those "feel good hormones." It can actually create joy!

Public art acts as an economic engine, attracting visitors, who in turn patronize other businesses in the region. It creates jobs for fabricators and installers, and provides funds to purchase materials. It acknowledges the importance of promoting art in a community so that the quality of life can be uplifted. Works can become a symbol or a document of the culture. Since public art is free and available to ANYONE, it becomes a catalyst for social interaction. It is accessible to all. People come together and connect to each other. It is a legacy document of the culture and can address social issues sparking conversation.=Artists should not be asked to waive their copyright or other protection rights. Since this is not a lucrative calling for most artists, their integrity and intellectual ownership is of upmost importance. Insuring protection of the artist's original intent or any action to compromise the work is in the best public interests.

I have had a personal experience with this issue. I was a finalist for a federally funded sculptural relief and was asked to waive my Integrity rights. I did not agree to that and although all the comments about the design were all positive, I did not receive the commission.

Personally, I *love* the idea of community being pleasantly surprised when they come upon a sculpture – a sense of embracing both pride and ownership of sculpture in the public realm emerges. The viewer is uplifted and feels like they got a special gift. Among my works is an expansive gate at the Maryland Public Health Laboratory in East Baltimore, an entry gate to the nature-walk at Ladew Topiary Gardens in Monkton, MD and three sculptural works (a gate, canopy and bench) at Brookside Gardens in Wheaton, MD. In addition, I received an Art-in-Transit commission through the Purple Line, Maryland Transit Systems, to be completed in 2025 for the Riggs Road station in Washington DC.

SB1006: Public Artists

Senate Budget & Taxation Committee Wednesday, March 12, 2025 3:00 PM

Arts uplifts and enriches our communities. It reflects our diversity and communicates our values. In addition to funding, Maryland can do better to support our working artists. <u>SB1006/HB961</u> is a modest bill that would provide a much-needed measure of protection.

Too often, working artists are required to waive their rights under the federal Visual Artists Rights Act (VARA) of 1990 as a condition for receiving a grant for publicly commissioned art. These protect an artist's integrity, attribution, and intellectual property. Requiring a waiver deters some artists from having their work displayed. Additionally, publicly commissioned works have been damaged or have even <u>disappeared entirely</u>, underscoring the need for stronger protections.

<u>SB1006</u> seeks to protect visual artists by ensuring that their VARA rights cannot be made a condition of accepting a State-funded grant. This bill not only protects artists, but safeguards taxpayer dollars.

As amended and passed by the House of Delegates (124-9), waivers would be allowed in limited cases, primarily relating to

- Registration with the Maryland State Arts Council;
- Attribution: ensuring that an artist's work cannot be falsely attributed to another individual; and
- Preservation: addressing situations in which the artwork is structurally integrated into a building and cannot be feasibly maintained.

SB1006 is not intended to stop negotiations. Rather, it ensures that artists who do not wish to waive their rights are not forced to do so in order to receive funding.

This bill would maintain artistic integrity and ensure that our State gives grants to talented artists-- not barred by contract negotiations.

I urge a favorable report on SB1006 as amended.
