On behalf of the Dorchester County Council, I respectfully offer its support of House Bill 566, entitled “Dorchester County – Alcoholic Beverages Licenses – Fees” for the purpose of altering licensing fees for certain alcoholic beverages licenses in Dorchester County; authorizing the Board of License Commissioners for Dorchester County to charge an application or transfer fee under certain circumstances; and generally relating to alcoholic beverages license, application, and transfer fees in Dorchester County.
