## Support – House Bill 1419- Electric Distribution System Support Services - Cost Recovery and Energy Storage

Potomac Electric Power Company (Pepco) and Delmarva Power & Light Company (Delmarva Power) support House Bill 1419- Electric Distribution System Support Services - Cost Recovery and Energy Storage. House Bill 1419 requires the Public Service Commission (PSC) to approve the use of regulatory asset accounting for recovering costs associated with electric distribution system support services, which could include incentive/rebate programs for distributed energy resources (DER).

Pepco and Delmarva Power are actively investing in battery storage solutions to enhance grid resilience and support Maryland's clean energy goals. Through pilot programs, we are deploying storage projects designed to optimize energy distribution, reduce peak demand stress, and provide backup power for critical infrastructure. These efforts not only contribute to the state's storage goal, but also ensure that our customers benefit from a more reliable and efficient energy system.

The ability to store and deploy electricity when demand is highest will reduce strain on the grid, mitigate power outages, and support Maryland's overall energy security. House Bill 1419 advances Maryland's ambitious energy goals by facilitating the deployment of energy storage solutions while ensuring cost-effective implementation. This legislation represents a critical step in achieving the state's target of deploying 3,000 MW of energy storage. This approach provides a predictable and sustainable framework for financing storage initiatives while maintaining affordability for customers.
