Testimony SB 13: Commission to Study African American Civil War Sailors in Maryland

Chairman Feldman, Vice Chairwoman Kagan, and esteemed members of the Senate Education, Energy, and Environment Committee, Senate Bill 13, would establish the Commission to Study African American Civil War Sailors in Maryland. This bill represents an important step in recognizing the often-overlooked contributions of African American <u>sailors</u> who served in the Union Navy during the Civil War.

The contributions of African American sailors in the Union Navy have largely been left in the shadows. This bill acknowledges the need for a comprehensive study to understand the experiences, contributions, and histories of these sailors, particularly those who served from Maryland. These sailors were crucial in the Union Navy's success, and it is critical to ensure their story is told, recognized, and memorialized.

The creation of the Commission to Study African American Civil War Sailors in Maryland will allow for thorough research into the records, muster rolls, and honors awarded to these sailors. It will also make recommendations on how to appropriately memorialize their sacrifices and contributions, which include potential funding, design, construction, and location of a memorial. By requiring the Commission to submit a report to the Governor and General Assembly by December 1, 2025, we will ensure that this important work is completed in a timely manner.

Additionally, I would like to clarify why this bill is necessary and why we cannot simply amend last year's bill, which created a commission to study African American Civil War Soldiers. Researching Army records is fundamentally different from researching Navy records, particularly when it comes to African American soldiers and sailors. The Army organized its African American soldiers into regiments of 1,000 men, making them easier to track and document in comparison to Navy personnel. In contrast, the Navy initially separated African American sailors to only four sailors per ship, largely out of prejudice. This intentional segregation of African American sailors creates challenges for researching their service and contributions. The complexity and time-consuming nature of this research highlight why a separate commission focused on African American Civil War sailors is so crucial.

We must not overlook the contributions of these sailors, who played a pivotal role in the Union Navy's success. Their stories are an integral part of Maryland's history and our nation's broader history. By supporting this bill, we ensure that their service is not forgotten, and that future generations will have the opportunity to learn about their bravery and sacrifice.

Therefore, I respectfully urge a FAVORABLE report for Senate Bill 13, so that we can honor and memorialize the legacy of African American Civil War Sailors in Maryland in an appropriate and meaningful way.

Dear Chair Feldman and distinguished members of the Education, Energy, and the Environment Committee:

On behalf of the members of the Maryland Military Coalition (MMC), I write to recommend a **FAVORABLE report** by the Committee on **SB0013 – Commission to Study African American Civil War Sailors in Maryland**, sponsored by Senator C. Anthony Muse. This bill will establish a Commission that will study the history of African American Sailors who fought for the Union Navy and make recommendations for an appropriate memorial.

Of the nearly 18,000 men of African descent who served in the U.S. Navy during the Civil War, and identified by name, more than 2,300 were from Maryland. The size of the Maryland contingent benefited from an agreement to transfer nearly 800 of them from incomplete units of the U.S. Colored Troops into the navy.¹ However, the extent of their participation, their individual stories, and their naval unit history are not well known. The Commission proposed in this legislation will address this gap by studying the history of African American Civil War Sailors and publishing its findings to enhance public awareness of the contributions they made.

Most importantly, the Commission will make recommendations for an appropriate memorial to these sailors. The memorial, when completed, will serve to not only commemorate their service to the Union but also how they served important roles on some of the navy's most important ships.

The Maryland Military Coalition **strongly supports SB0013** and asks for a **FAVORABLE** report from the Education, Energy, and the Environment Committee.

The Episcopal Diocese of Maryland, at its 237th Convention in 2021, passed a resolution calling upon the Maryland General Assembly, convening in January of 2022, to pass what was then The Public Schools: African American History Development of Content Standards and Implementation Act, relating to the development and implementation of an African American history curriculum in public schools. We are dismayed that bill and subsequent versions to revise the history and culture that we teach never moved beyond this committee.

Given the hostility that has engulfed local school boards in the past few years, we understand that fear and misinformation have made any rational conversation about expanding our history to include all who played a part in living it though not writing it, and the circumstances faced by each player.

We support the inclusive intent of this bill, and all related bills that hopefully will still be filed, but ultimately, we support this because it is about truth, a truth without which there can be no true reconciliation in our nation - a shared history of which we may not be proud, but which defines us, one we can embrace, and finally move on together with a shared understanding of who we are as a people - a truth without which we can never be set free from the insidious grip of our past.

This is a small part of the larger truth which begs to be heard in the form of the sacred stories of so many who were participants in our history and whose legacies have been denied. Including, we might add, Frederick Douglass, who in spite of his



relentless pressure on Lincoln before, during and after and the influence that he exerted on his policies concerning slavery, does not appear in the Spielberg film, *Lincoln*.

History without truth is a fairytale at best, and propaganda at its worst. And as is the case with all sin, too many have suffered at the hands of those who have owned our past to the benefit of too few and the oppression of far too many. We have nothing to fear from knowing our true history. But in the reconciliation that it offers, we have everything to gain.
