Russ Ware, DVMF Cemetery and Memorial Program Director TESTIMONY IN SUPPORT OF Senate Bill 237 Burial Equity Act Education, Energy, and the Environment Committee February 6, 2025

Good afternoon, Chair Feldman, Vice Chair Kagan, and distinguished members of the committee.

I am Russ Ware, the Director of Cemetery & Memorial Programs for the Maryland Department of Veterans & Military Families, and I am here today to speak in favor of SB237 as amended, which will allow National Guardsmen and members of the military reserves to be buried in our state veteran cemeteries, along with their eligible family members. It also removes the state residency requirement for veteran interments, which is necessary for our State to receive VA cemetery grants, as well as for the eligible dependents of out-of-state veterans.

I served 25 years of active duty in the United States Air Force, and during that time, I witnessed firsthand the incredible sacrifices made by National Guardsmen and Reservists. Their dedication to our country is no less significant than that of active-duty personnel, and it's time that we recognize their sacrifices by providing them with the honor of being buried in a state veteran cemetery.

While the federal government provides burial rights for veterans, it does not currently extend this same privilege to Guardsmen and Reservists. This bill will share that privilege and will also remove the existing requirement for veterans to be current or previous Maryland state residents, a change that is necessary to meet the U.S. Department of Veterans Affairs' eligibility criteria for cemetery grants. This change ensures that all veterans who have served, regardless of where they call home, and their eligible dependents, have access to burial benefits and places a greater focus on honoring their service rather than their residency.

Passing this bill will not only generate revenue for the state cemetery program by regaining the ability to apply for federal cemetery expansion grants but will also help sustain the system and ensure its continued operation for future generations. Also, the program will receive federal funding to cover the costs of out-of-state veterans' burials; however, there will be a financial impact on state funds for the burials of out-of-state dependents, the cost of supporting the growth and expansion of the cemetery program by extending benefits to dependents of out-of-state veterans.

By supporting this bill, Maryland demonstrates that we honor the service of all veterans, whether they served on active duty, the Reserves, or the National Guard. I respectfully ask for a favorable report on SB237 as amended, as it ensures that all who served this nation are given the respect and dignity they have earned.

Dear Chair Feldman, Vice Chair Kagan and Distinguished Members of the Senate Education, Energy and the Environment Committee:

For the record, my name is Lynn Nash. I am a 30 year retiree with service in both the Army and the U.S. Public Health Service and the Communications Director for the Coalition.

I'm pleased to say that I am starting out in front of your committee this session with a bill that has no cost. Let's hope that I can keep it up.

House Bill HB 138, the Burial Equity Act, is a valuable measure. The bill seeks to clarify existing eligibility for burial in State cemeteries for members of the National Guard and Military Reserves. However, the current bill language is exclusive and needs amendment.

The Department of Veterans and Military Families (DVMF) follows the eligibility requirements of the VA National Cemetery. This legislation clarifies that members who served full-time in the Commissioned Corps of the U.S. Public Health Service or the Commissioned Corps of the National Oceanic and Atmospheric Administrations are veterans, as stated in Maryland Code, General Provisions § 1-117 and Title 38 U.S. Code § 101.

Futher, the bill includes service members who have completed their contractual obligations as a member of the National Guard or the "**Military Reserves**" (emphasis added) under honorable terms. As written, the bill is exclusive. The use of the term "military reserves" includes only members of the Army, Navy, Marines, Air Force and Space Force. It excludes members of the Coast Guard (Department of Homeland Security) and the Ready Reserve of the U.S. Public Health Service (Department of Health and Human Services) who are federal reservist. To exclude these reservists who volunteer and place their lives on the line daily, does a huge disservice to them and their family members.

The Coalition seeks an amendment to correct this disservice. Instead of using the term "military reserves" we ask that it\\the bill be modified to "federal reserve" which includes the reserves of the Army, Navy, Marines, Air Force, Space Force, as well as the Coast Guard and the Ready Reserve of the Commissioned Corps of the U.S. Public Health Service". This language keeps in the spirit of the Governor's "leave no man behind" and conforms to the DVMF-preferred use of the term "Uniformed Services".

Dear Chair Feldman, Vice Chair Kagan and Distinguished Members of the Senate Education, Energy and the Environment Committee:

SB 237, "State Government – Veterans – Burial at State Veterans' Cemeteries (Burial Equity Act)", is a valuable measure. This no-cost legislation, sponsored by the Department of Veterans and Military Familes and Governor Moore, seeks to clarify existing eligibility for burial in State cemeteries for members of the National Guard and Military Reserves. However, the current bill language is <u>exclusive</u> and <u>needs amendment</u>.

The Department of Veterans and Military Families (DVMF) follows the eligibility requirements of the VA National Cemetery. This legislation clarifies that members who served full-time in the Commissioned Corps of the U.S. Public Health Service or the Commissioned Corps of the National Oceanic and Atmospheric Administrations are **veterans**, as stated in Maryland – General Provisions § 1-117 and Title 38 U.S. Code § 101. Futher, the bill includes service members who have completed their contractual obligations as a member of the National Guard or the "**Military Reserves**" (emphasis added) under honorable terms. The use of the term "military reserves" includes only members of the Army, Navy, Marines, Air Force, Space Force and Coast Guard **and excludes** members of the **Ready Reserve of the U.S. Public Health Service** (Department of Health and Human Services) who are **Reserve Component** members under28 U.S.C. § 101(24). To exclude these reservists who volunteer and place their lives on the line daily, does a huge <u>diservice</u> to them and their family members.

The Coalition seeks an **amendment to correct this diservice**, and offers the following language which has already been coordinated the Department and Governor Moore, and has received markup by the House Health and Government Operations Committee.

Where the bill reads:

• (line 5) "the National Guard and military reserves" replace with "a reserve component"

Page 2 SB 237-Burial Equity Act -**FAVORABLE with Amendment**

- (line 7) "National Guard and military reserves services" ... replace with "reserve component". This language keeps in the spirit of the Governor's "leave no man behind" and conforms to the DVMF-preferred use of the term "Uniformed Services".
- Page 2 after (3) Eligible spouse add (4) definition of reserve component:

(4) "RESERVE COMPONENT" MEANS:

- (I) THE ARMY NATIONAL GUARD OF THE UNITED STATES;
- (II) THE ARMY RESERVE;
- (III) THE NAVY RESERVE;
- (IV) THE MARINE CORPS RESERVE;
- (V) THE AIR NATIONAL GUARD OF THE UNITED STATES;
- (VI) THE AIR FORCE RESERVE;
- (VII) THE COAST GUARD RESERVE;
- (VIII) THE RESERVE CORPS OF THE U.S. PUBLIC HEALTH SERVICE;

<u>OR</u>

(IX) ANY OTHER RESERVE SERVICE INCLUDED IN 28 U.S.C. §

<u>101(24).</u>

- Page 2 (lines 17-18) "Member of the National Guard or the military reserves" replace with "reserve component"
- Page 2 lines 25-26) "Member of the National Guard or the military reserves" replace with "reserve component"
- Page 2 (line 27) after armed forces add uniformed services.
- Page 3 (5) "Member of the National Guard or the military reserves" replace with "reserve component"

As previously stated, this bill has no fiscal consequence. Veterans and their spouses and dependents are currently not charged for burial. This legislation continues the practice of collecting a burial fee for National Guard and Reservists equal to the annual plot allowance established by the National Cemetery Administration. That fee currently is \$998.00.

We support the intent of SB 237 and ask for a **FAVORABLE report with AMENDMENT** to truly create the Burial Equity Act, by including **ALL reserve components**.
