The Maryland Coalition Against Sexual Assault (MCASA) is a non-profit membership organization that includes the State's seventeen rape crisis centers, law enforcement, mental health and health care providers, attorneys, educators, survivors of sexual violence and other concerned individuals. MCASA includes the Sexual Assault Legal Institute which provides direct legal services for survivors across the State of Maryland. We urge the Education, Energy, and the Environment Committee to report favorably on Senate Bill 491.

#### Senate Bill 491 – Military Discharge and Sexual Trauma

This bill would define "honorable discharge" with respect to any State program of benefits, rights, or privileges applicable to a veteran to include certain discharges based on an experience of sexual trauma.

Research estimates there were 75,569 cases of sexual assault in the military in 2021 and 73,695 cases in 2023. On average, over the course of the war in Afghanistan, 24 percent of active-duty women and 1.9 percent of active-duty men experienced sexual assault. https://watson.brown.edu/costsofwar/papers/2024/sexualassault

Senate Bill 491 helps ensure that members who leave services as a result of experiencing sexual trauma are treated with respect and continue to receive the benefits they have earned.

Good Afternoon, Chairman Feldman, Vice-Chair Kagan and members of the Education, Energy and the Environment Committee. I am pleased to provide this written statement and testify today on behalf of the State Legislative Committee of the Maryland National and Active and Retired Federal Employees Association (NARFE), representing approximately 317,000 federal annuitants and employees in Maryland. For the continuing benefit of the more than 3,100 Veterans who are Maryland NARFE members – and for all Maryland Veterans - we support and ask you for a favorable report on SB 491 – General Provisions – Veterans Benefits –

Honorable Discharge. We thank Senator Dawn Gile and the other Co-Sponsors for introducing this Bill.

SB 491 will change existing Maryland Veterans law to expand the definition of "honorable discharge" to include discharges other than honorable which were based on incidents relating to a diagnosis of post-traumatic stress disorder (PTSD) or traumatic brain injury (TBI), which the Veteran received from an individual licensed to provide health services at a U.S. Department of Veterans Affairs facility, or based on an experience of military sexual trauma (MST)<sup>1</sup> which the Veteran disclosed to an individual licensed to provide health care services at a certain Veterans Affairs facility.

Military sexual trauma, or MST, is the term used by VA to refer to experiences of sexual assault or repeated, threatening sexual harassment that a Veteran experienced during his or her military service. The definition used by the VA comes from Federal law (Title 38 U.S. Code 1720D) and is "psychological trauma, which in the judgment of a VA mental health professional, resulted from a physical assault of a sexual nature, battery of a sexual nature, or sexual harassment which occurred while the Veteran was serving on active duty or active duty for training." Sexual harassment is further defined as "repeated, unsolicited verbal or physical contact of a sexual nature which is threatening in character." More concretely, MST includes any sexual activity where a Service member is involved against his or her will -- he or she may have been pressured into sexual activities (for example, with threats of negative consequences for refusing to be sexually cooperative or with implied better treatment in exchange for sex), may have been unable to consent to sexual activities (for example, when intoxicated), or may have been physically forced into sexual activities. Other experiences that fall into the category of MST include unwanted sexual touching or grabbing; threatening, offensive remarks about a person's body or sexual activities; and threatening and unwelcome sexual advances. The identity or characteristics of the perpetrator, whether the Service member was on or off duty at the time, and whether he or she was on or off base at the time do not matter. If these experiences occurred while an individual was on active duty or active duty for training, they are considered by VA to be MST. (From VA Fact Sheet on MST, April 2014

Under this new definition of "honorable discharge," Veterans who previously could not qualify for certain Veterans benefits in Maryland because their discharge was other than honorable for the reasons directly above will now be eligible for such benefits.

SB 491 will follow the example of the Restoration of Honor Act, Maryland legislation passed and signed into law by Governor Larry Hogan in May, 2022. This law changed the then definition of "honorable discharge" to include discharges other than honorable (1) solely due to the sexual orientation or gender identity of the individual being discharged or (2) based on a statement or consensual act of the individual being discharged related to the individual's sexual orientation or gender identity, if the statement or consensual act was prohibited by the military or naval service at the time of discharge.<sup>2</sup>

## Why SB 491 is needed

Military discharges are categorized into several types, including Honorable, General (under honorable conditions), Other Than Honorable (OTH), Bad Conduct, and Dishonorable. The type of discharge a service member receives significantly affects their post-military life, particularly regarding access to veterans' benefits and employment opportunities.

Many Veterans have received discharges other than honorable because of their servicerelated experiences of PTSD, TBI and MST. In data from 2014, the Department of Defense

(DoD) released records indicating that 13% of post-9/11 veterans, around 318,000, received a less-than-honorable discharge between fiscal years (FY) 2000 – 2013. From 2009 to 2015, the Army has separated at least 22,000 combat veterans who had been diagnosed with mental health disabilities like PTSD or TBI for alleged misconduct, despite reforms intended to halt the administrative separations of veterans suffering from service-related conditions. These unjustly discharged veterans were ineligible for veterans' benefits, and the impacts of the "less-than-honorable" discharges made them socially isolated from the military and veterans community, and more likely to be homeless, suffer from substance abuse, go without treatment for physical and mental injuries, become incarcerated, and die by suicide.<sup>3</sup>

In that time (from 2000-2015), there was an increasing recognition of the impact of PTSD and TBI on service members' conduct, including the acknowledgement that some behaviors leading to less than honorable discharges were linked to service-related mental health issues. The Pentagon issued policy guidance in in this area, such as the 2014 memorandum from Secretary Chuck Hagel directing discharge review boards to give "liberal consideration" to petitions where PTSD or other mental health conditions played a role in the misconduct leading to the discharge. In 2017, a memorandum from Undersecretary Kurta expanded on the Hagel Memorandum by instructing discharge review boards to consider any underlying mental health condition as a mitigating factor in military misconduct.<sup>4</sup>

Regarding MST, Veterans also may receive less than honorable discharges due to misconduct which they believe resulted from their experience of sexual assault and/or sexual harassment trauma. In the 2017 DOD memorandum, it was noted that "evidence of misconduct, including any misconduct underlying a Veteran's discharge may be evidence of …behavior consistent with experiencing sexual assault or sexual harassment. A determination made by the VA that a Veteran's mental health condition … including sexual assault or sexual harassment is connected to military service, while not binding on the DOD is persuasive evidence that the experience occurred during military service."<sup>5</sup>

On the Federal level, the VA has taken significant steps to look at the underlying problems of STSD, TBI and MST on discharge characterizations. The 2018 Honor Our Commitment Act mandated the VA to provide mental health care to veterans with service-connected trauma or military sexual trauma, regardless of their discharge status. And in 2020, the Discharge Appeal Review Board was created to provide a final opportunity for veterans to appeal their discharge characterization at the Department of Defense level.<sup>6</sup>

We hope that SB 491 will offer significant help to MD veterans like the help offered by the Federal efforts described above. Additionally, if this legislation is enacted, Maryland will

have legislation similar to the New York State Restoration of Honor Act (2019). This law

authorizes the New York State Department of Veterans' Services (DVS) to restore state Veterans

benefits to Veterans who have a less than honorable discharge due to PTSD, TBI, MST, or

Sexual Orientation, Gender Identity or Gender Expression. While the law does not change a

Veteran's official federally issued character of discharge, if the Veteran receives a favorable

determination and their service is considered honorable for the purpose of receiving New York

State Veterans Benefits, DVS will provide the Veteran an award letter with a list of New York

State Veterans benefits for which the Veteran is now eligible.<sup>7</sup>

We believe that SB 491 is a significant step to honor and help those who

served and sacrificed for our Nation but have been denied benefits they earned and

deserved because of unfairly characterized discharges.

We respectfully ask that you give a favorable report to SB 491.

## **Testimony in Support of SB0491 - General Provisions - Veterans Benefits - Honorable Discharge**

Mr. Chair, Madame Vice Chair, and members of the Senate Education, Energy, and the Environment Committee:

SB0491 would broaden the eligibility criteria for veterans seeking to upgrade their discharge status from "less than honorable" to "honorable" for the purpose of accessing state benefits, ensuring alignment with existing federal policy.<sup>1</sup>

#### **Background**

When service members are separated from service, the Department of Defense (DoD) authorizes six characterizations of service for military service members to receive on discharge: (1) Honorable; (2) Under Honorable Conditions (General); (3) Under Other than Honorable (OTH) Conditions; (4) Bad Conduct; (5) Dishonorable, and (6) Uncharacterized.<sup>2</sup> Federal and state benefits are withheld from veterans who are not discharged as "honorable" or "general" (otherwise known as "less-than-honorable").

For decades, service members received less-than-honorable discharges due to reasons that are no longer considered valid grounds for such classifications. These include:

- Mental health conditions, including posttraumatic stress disorder (PTSD)
- Traumatic brain injury (TBI)
- Sexual assault or harassment during military service ("military sexual trauma" or MST)
- Sexual orientation (including under the *Don't Ask, Don't Tell* policy)

After federal policy changes, such as the repeal of *Don't Ask, Don't Tell*, the U.S. Department of Veterans Affairs (VA) established a process for veterans to apply for a discharge upgrade if their less-than-honorable classification was based on conduct that is no longer considered grounds for such a status. This process enables veterans to seek upgrades for the reasons outlined above, ensuring they receive the recognition and benefits they deserve.

### Existing Law

Maryland already provides a process for veterans to request reconsideration of their eligibility for state benefits if their discharge was based on a statement or consensual act related to their sexual orientation or gender identity—conduct that was prohibited by the military or naval service at the time of their discharge.

#### Solution

SB0491 would expand the grounds for reconsideration to include:

- A diagnosis of post-traumatic stress disorder (PTSD) or traumatic brain injury (TBI) made by a licensed healthcare provider at a U.S. Department of Veterans Affairs (VA) facility.
- A disclosed experience of sexual trauma reported to a licensed healthcare provider at a designated VA facility.

This expansion aligns Maryland's discharge upgrade process with federal VA policy, ensuring greater consistency and fairness for affected veterans.

Additionally, I am offering a sponsor amendment to correct a minor drafting error and clarify the specific circumstances in which the expanded process may be applied.

For these reasons, I respectfully request a favorable report on SB0491.

Dear Chair Feldman, Vice Chair Kagan and Distinguished Members of the Senate Education, Energy and the Environment Committee:

On behalf of the members of the Maryland Military Coalition (MMC), I write to recommend a **FAVAORABLE REPORT** with **AMENDMENTS** by the Committee on **General Provisions** — **Veterans Benefits** — **Honorable Discharge.** This bill is designed to allow a veteran who has a "covered mental health condition" or has been a victim of a sexual trauma, to apply for state veteran benefits while awaiting a federal discharge upgrade. This bill seeks to assist in making a veteran "whole" after trauma.

#### However, the bill needs amendments:

- 1. The citation currently in the bill is incorrect. The citation should be 38 U.S.C. §1166 (not 1720 which deals with nursing home transfers).
- 2. The following should be amended to more clearly adhere to the citation.
  - (3) BASED ON AN INCIDENT OR INCIDENTS RELATING TO:
    - (I) Diagnosis of post traumatic stress disorder or traumatic brain injury a "covered mental health condition" disclosed to an individual licensed to provide health care services at a hospital of the Armed Forces or at a U.S. Department of Veterans Affairs facility, that the Secretary determines to be related to military sexual trauma. "Covered mental health condition" means post- traumatic stress disorder, anxiety, depression, or other mental health diagnosis described in the current version of the Diagnostic and Statistical Manual of Mental Health Disorders (published by the American Psychiatric Association).
    - (II) An experience of sexual trauma, as described in 38 U.S.C. §1720-§1166 disclosed to an individual licensed to provide health care services at a hospital of the Armed Forces or at a U.S. Department of Veterans Affairs facility. The term "military sexual trauma" means, with respect to a



veteran, a physical assault of a sexual nature, battery of a sexual nature, or sexual harassment during active military, naval, air, or space service.

#### According to the **Cost of War Project**:

- In 2013, the Department of Defense reversed a ban on women in combat.
- From 2016 onward, all military jobs were opened to women.
- Recently released Department of Defense (DoD) data shows that 29,000 military personnel were sexually assaulted in 2023. In addition, during the same period, close to 25% of active-duty women were sexually harassed (a decrease from 28.6% in 2021).
- Independent data shows ever higher rates than DoD estimates.
  - o 75,569 cases in 2021
  - o 73,695 cases in 2023
  - On average, during the period of 2001-2021 twenty four percent (24%) of active-duty women and 1.9 percent (1.9%) of active-duty men experienced sexual assault.
  - Racial minority and LGBTQ+ service members face the greatest risk of sexual assault.
- While these numbers are horrible, they follow a decade of interventions intended to address the sexual assault crisis:
  - 10 DoD Inspector General reports
  - o 60 Government Accountability Office recommendations
  - Over 200 government panel and task force recommendations
  - 150 Congressional provisions, including passage of the "I am Vanessa Guillen Act" (Military Justice Improvement and Increasing Prevention Act) in 2023, which removes commanders authority over sexual assault cases and hands it to independent prosecutors. SPC Guillen was murdered at Fort Hood, Texas after suffering multiple incidents of sexual harassment.
  - More than 50 Secretary of Defense initiatives

Sexual trauma is a wound that doesn't show and is difficult to "heal". Often victims are unwilling to seek assistance because they fear retalliation. Many times, victims become isolated, leading to more problems in their conduct while in service. Many are removed from service under less than honorable conditions.

The Coalition seeks an **amendment to clarify the citation and definitions offered.** There is no fiscal note at this time, however, costs should be minimal, as this bill simply affords a service member earlier access to healing services.

We support the intent of **SB 491** and ask for a **FAVORABLE report with AMENDMENTs** to allow veterans to seek access to benefits they have earned. These amendments have been coordinated with the Department of Veterans and Military Families as well as the bill sponsors.

The Maryland Military Coalition is a registered non-profit, non-partisan advocacy organization comprised of prominent Maryland-based veteran and military groups, representing over 150,000 service-connected individuals, including those currently serving, veterans, retirees and their families, caregivers, and survivors.
