Senate Bill 690 - Higher Education - Scholarships for Correctional Officers

Dear Chair Feldman and Members of the Committee,

I am writing to introduce Senate Bill 690. This bill would expand eligibility for the Maryland Police Officers and Probation Agents Scholarship Program to include correctional officers.

In 2021, as part of the Maryland Police Accountability Act, the General Assembly created the Maryland Police Officers Scholarship Program. This program was created because of research which showed how higher education for police officers is beneficial to more than just the officer receiving the degree. A review of the research indicates that police officers who have graduated from college are less likely to be the subject of citizen complaints. In 2023, the General Assembly passed legislation to add probation agents to this scholarship program, and last year, we passed legislation allowing police officers and probation agents to use this scholarship at community colleges in addition to four-year institutions. I strongly believe in this scholarship program and have been working over the past several months with the Maryland Higher Education Commission on how to increase the utilization of this program through greater outreach to our State's police officers.

During the interim, I was approached by correctional officers in my district who shared with me that, as currently drafted, correctional officers are not included in the list of individuals who are eligible for the Police Officers and Probation Agents Scholarship Program. Therefore, I have introduced this bill to ensure that correctional officers are included in the program. At this time when recruitment and retention of public safety officers in all fields, including correctional officers, is so critical, this bill will aid in those efforts while also providing the State with the benefits that come with more correctional officers receiving a college education.

I respectfully request a favorable report on Senate Bill 690. Thank you for your consideration.

The Maryland Association of Counties (MACo) **SUPPORTS SB 690.** This bill expands eligibility for the Maryland Police Officers and Probation Agents Scholarship Program to include correctional officers.

SB 690 extends higher education resources, currently limited to law enforcement, to include detention center officers. There is a great deal of crossover between the corrections and law enforcement workforces, which is why considering their needs together will make them both stronger independent agencies. The adjustments represent an opportunity for local governments to build and sustain a qualified and enthusiastic workforce of employees while incentivizing their professional development and career longevity.

Broadening eligibility for funding from scholarship programs to include local correctional officers sends an important message about how much governments and communities value these roles. As the rehabilitative arm of the justice system, corrections officers look out for and care for some of Maryland's most vulnerable populations. Prioritizing professional development and continued education has the potential to increase the pool of candidates looking to join this vital work force. Additionally, the skills and knowledge acquired through post-secondary education can have a substantial influence on the quality of work performed and services provided in detention centers. There is no question this can have a significant impact on successful reentry and recidivism rates for returning citizens.

MACo commends the expansion of eligibility to corrections officers for these opportunities that promote continual growth and improvement. This is paramount to ensuring employees see a fulfilling future for themselves in these critical public safety roles. Accordingly, MACo urges a **FAVORABLE** report for **SB 690**.
