Dear Chair Feldman and Members of the Committee:

On behalf of the EV Charging Task Force, a Maryland-based coalition of electric vehicle (EV) drivers, I wish to submit the attached "Maryland Fast Charger Survey" for your consideration in connection with House Bill 1427.

HB 1427 directs the Maryland Zero Emission Electric Vehicle Infrastructure Council (ZEEVIC) to evaluate and provide recommendations on improving the reliability of the state's EV charging stations. With respect to this goal, our group conducted a comprehensive statewide survey of the operability of DC fast charging infrastructure from December 23, 2024, to January 4, 2025.

Thirteen volunteer EV drivers visited 304 fast charger locations and evaluated over 1,000 individual charging ports. The enclosed "Maryland Fast Charger Survey" table details our findings, including the number of ports observed as non-functional ("down") at the time of our visits.

The table uses a color-coding system to highlight concerns:

- Red highlights locations where all charging ports were inoperable;
- Yellow indicates sites where some, but not all, ports were non-functional.

For added accessibility, an interactive version of the table is available online at <u>Interactive Survey Data</u>, and an accompanying map of the surveyed locations can be viewed at <u>Maryland Fast Charger Map</u>.

Our survey highlights the strengths and challenges of Maryland's fast charging network, offering a practical, user-driven perspective to support the rationale for the reliability study proposed in HB 1427.

We respectfully submit this data for your review as you shape policies to improve the reliability and oversight of EV charging infrastructure statewide.

We are deeply grateful to Delegate April Miller, a fellow EV driver and HB 1427's sponsor, for her leadership in advancing this effort.

Thank you for your consideration and for the Committee's ongoing commitment to strengthening Maryland's electric vehicle infrastructure.

RE: Letter of Information – House Bill 1427 – Maryland Zero Emission Electric Vehicle Infrastructure Council – Revisions

Dear Chair Feldman and Committee Members:

The Maryland Department of Transportation (MDOT) takes no position on House Bill 1427 but respectfully offers the following information for the Committee's consideration.

HB 1427 requires ZEEVIC to prepare a study and recommendations addressing safety design elements associated with EV Charging in parking lots. The study and recommendations are required to be submitted to the Governor and General Assembly by June 30, 2026. The bill also adds the Secretary of the Maryland State Police to the Council's membership.

Safe design of parking lot infrastructure and operations affects more than just those who choose to own and operate zero emission electric vehicles (EV). Further, safety design elements listed in HB 1427 are not necessarily under the purview of the State. Lighting is approved through local government site planning and development review processes. Monitoring by security cameras is a site-specific determination made by a site owner. Smart phone applications are a nimble market response to market demand. Methods for disconnecting an EV from a charging station are subject to Society of Automative Engineers industry standards.

The Maryland Department of Transportation respectfully requests that the Committee take this information into account during its deliberation of House Bill 1427.
