Dear Chair Beidle and distinguished members of the Finance Committee:

On behalf of the members of the Maryland Military Coalition (MMC), I recommend a **FAVORABLE report** by the Committee on **SB0652** – **Local Government** – **Local Personnel** – **Leave With Pay**, sponsored by Senator J. B. Jennings. This legislation authorizes counties and municipalities to increase the number of days of disaster leave and the number of days of annual military leave for their employees to be equal to those for State employees authorized under the Time to Serve Act of 2024.

SB0652 will benefit employees and the county and municipality level, ensuring that service members use paid time off to be with their families as opposed to performing disaster or military service. Absent this legislation, there exists a disparity in National Guard and federal reserve units that provides State employees, who are members, with greater opportunities to perform military duty. This disparity gives those State employees an advantage in promotion and schooling opportunities that their fellow service members, who are employees at the county and municipality level, do not equally enjoy. SB0652 will eliminate that advantage and create a "level playing field" for State and county and municipality employees who are members of these units.

The Maryland Military Coalition strongly supports SB0652 and asks for a FAVORABLE report. <u>All members</u> of the Reserve Components (National Guard and Federal Reserve) need to be treated equally.

The Maryland Military Coalition is a registered non-profit, non-partisan advocacy organization comprised of 22 prominent Maryland-based veteran and military groups. It represents over 150,000 service-connected individuals, including those currently serving, veterans, retirees and their families, caregivers, and survivors.
