On behalf of the Charles County Board of County Commissioners, I write to express our strong support for passage of House Bill 835/Senate Bill 731, which authorizes the license holder at the Charles County baseball stadium to sell beer, wine, and liquor for on-premises consumption throughout the stadium.

Currently, the baseball license allows for sales of beer, wine, and liquor at particular points of sale, and consumption of beer and wine throughout the stadium. HB 835/SB 731 would allow for sale and consumption of beer, wine, and liquor throughout the stadium, excluding the parking lot area.
